Senate Amendments to House Bill No. 1406

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is authorized and approved for expenditure out of any
7	special source funds which are received by or otherwise become
8	available to the Pearl River Valley Water Supply District, for the
9	purpose of defraying the expenses of the district for the fiscal
10	year beginning July 1, 2021, and ending June 30, 2022
11	\$ 20,237,250.00.
12	SECTION 2. Of the funds appropriated under the provisions of
13	Section 1, the following positions are authorized:

19	With the funds herein appropriated, it shall be the agency's
20	responsibility to make certain that funds required to be

- Any transfers or escalations shall be made in accordance with

- No general funds authorized to be expended herein shall be
- 62 used to replace federal funds and/or other special funds which are
- 63 being used for salaries authorized under the provisions of this
- 64 act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in
- 66 violation of Internal Revenue Service's Publication 15-A relating
- 67 to the reporting of income paid to contract employees, as
- 68 interpreted by the Office of the State Auditor.
- 69 **SECTION 3.** It is the intention of the Legislature that the
- 70 Pearl River Valley Water Supply District shall maintain complete
- 71 accounting and personnel records related to the expenditure of all
- 72 funds appropriated under this act and that such records shall be
- 73 in the same format and level of detail as maintained for Fiscal

- 74 Year 2021. It is further the intention of the Legislature that
- 75 the agency's budget request for Fiscal Year 2023 shall be
- 76 submitted to the Joint Legislative Budget Committee in a format
- 77 and level of detail comparable to the format and level of detail
- 78 provided during the Fiscal Year 2022 budget request process.
- 79 **SECTION 4.** It is the intention of the Legislature that
- 80 whenever two (2) or more bids are received by this agency for the
- 81 purchase of commodities or equipment, and whenever all things
- 82 stated in such received bids are equal with respect to price,
- 83 quality and service, the Mississippi Industries for the Blind
- 84 shall be given preference. A similar preference shall be given to
- 85 the Mississippi Industries for the Blind whenever purchases are
- 86 made without competitive bids.
- 87 **SECTION 5.** The funds herein approved for expenditure, except
- 88 and less an amount approved by the State Fiscal Officer which
- 89 shall be sufficient to cover disbursements for current operations,
- 90 shall be deposited at interest with any official depository of the
- 91 state at a rate of interest numerically not less than one percent
- 92 (1%) below the bank discount rate on United States Treasury bills
- 93 of comparable maturity as determined by the State Treasurer.
- 94 **SECTION 6.** None of the funds appropriated for expenditure
- 95 under this act may be expended by Pearl River Valley Water Supply
- 96 District until the district agrees to comply with the following
- 97 condition: the District shall waive traffic control fees for any
- 98 vehicle displaying a "REZ" tag.

99 SECTION 7. None of the funds appropriated for expenditure 100 under this act may be expended by Pearl River Valley Water Supply 101 District until the district agrees to comply with the following 102 conditions: (1) If any local governmental or nonprofit entity wins the bid for the ESPN Bass Masters Classic or the FLW Major 103 104 Open, these events shall be exempt from the district's lottery 105 system for host events at the reservoir and given priority of any 106 and all date options available. (2) If any local governmental or 107 nonprofit entity wins the bid for such events, the district shall 108 waive the daily launch fees or any other special event fees for 109 the ESPN Bass Masters Classic or the FLW Major Open. (3) 110 Catch A Dream Foundation Bass Classic shall be held on the first 111 Sunday in May unless any local governmental or nonprofit entity 112 wins the bid for the ESPN Bass Masters Classic or the FLW Major Open on that date. The Catch A Dream Foundation Bass Classic 113 114 shall be exempt from the district's lottery system for host events 115 at the reservoir and given priority for the first Sunday in May. 116 The district shall waive the daily launch fees or any other 117 special event fees for the Classic.

SECTION 8. Of the funds appropriated herein, Two Hundred
Thousand Dollars (\$200,000.00) is provided for salary increase for
the purpose of funding overtime, callback or standby pay.

SECTION 9. Of the funds appropriated herein, Two Hundred
Thousand Dollars (\$200,000.00) is provided out of the Ross Barnett
Reservoir Dredging Fund for dredging and other related activities

- 124 to remove sediments and debris from the bottom of the Ross Barnett
- 125 Reservoir.
- 126 **SECTION 10.** It is the intention of the Legislature that the
- 127 funds herein appropriated shall be expended in compliance with
- 128 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 129 shall incur obligations or indebtedness in excess of their
- 130 appropriation and that the responsible officers, either personally
- 131 or upon their official bonds, shall be held responsible for
- 132 actions contrary to this provision.
- 133 **SECTION 11.** The money herein approved for expenditure shall
- 134 be disbursed upon bank checks signed by the proper person, officer
- or officers, in the manner provided by law or in accordance with
- 136 the provisions of a valid trust indenture.
- 137 **SECTION 12.** The money herein appropriated shall be paid by
- 138 the State Treasurer out of any money in the State Treasury to the
- 139 credit of the proper fund or funds as set forth in this act, upon
- 140 warrants issued by the State Fiscal Officer; and the State Fiscal
- 141 Officer shall issue his warrants upon requisitions signed by the
- 142 proper person, officer or officers, in the manner provided by law.
- 143 **SECTION 13.** This act shall take effect and be in force from
- 144 and after July 1, 2021.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE PEARL RIVER VALLEY WATER SUPPLY DISTRICT FOR THE FISCAL YEAR 2022.
