## HOUSE BILL NO. 47

1 AN ACT TO AMEND SECTION 37-41-1, MISSISSIPPI CODE OF 1972, TO 2 REQUIRE SCHOOL BUS DRIVERS TO BE TRAINED AND CERTIFIED IN FIRST 3 AID AND CARDIOPULMONARY RESUSCITATION (CPR); AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 37-41-1, Mississippi Code of 1972, is 6 7 amended as follows: 37-41-1. (1) The State Board of Education is authorized, 8 9 empowered and directed to promulgate rules and regulations 10 relating to the transportation of students enrolled in the public school districts, including rules and regulations for: 11 12 (a) Setting standards for public school district bus 13 routes; 14 (b) Setting standards for public school district buses; (c) Setting standards for public school district bus 15 16 drivers; 17 (d) Formulating procedure for selecting public school district bus drivers; 18

- 22 (f) Providing operation procedure for public school
- 23 district buses to insure safety of pupils;
- 24 (q) Formulating specifications for use in purchasing
- 25 public school district buses; getting bids on public school
- 26 district buses; equipment and supplies; and fixing prices based
- 27 upon said bids which school districts may not exceed in purchasing
- 28 said equipment;
- 29 (h) Formulating specifications for use by school
- 30 districts in purchasing used school buses; and
- 31 (i) Providing a system of records and reports for the
- 32 purpose of carrying out the provisions of Sections 37-41-1 through
- 33 37-41-51, and providing the superintendent of schools with a
- 34 sufficient supply of report forms.
- 35 All rules and regulations adopted and promulgated by the
- 36 State Board of Education relating to school district bus drivers
- 37 shall also be applicable to drivers of privately owned buses
- 38 transporting public school district children.
- 39 All rules and regulations adopted and promulgated by the
- 40 State Board of Education pursuant to the authority conferred by
- 41 this section shall be spread at large upon the minutes of the
- 42 State Board of Education and copies thereof shall be furnished to

- Except for subsection (2) of this section, the provisions of
- 46 this chapter are applicable to school districts and the
- 47 transportation of students enrolled in public school districts.
- 48 Charter schools authorized by the Mississippi Charter School
- 49 Authorizer Board are exempt from the provisions of this chapter.
- 50 (2) The driver of every school transportation vehicle used
- 51 to transport pupils must be trained and certified in first aid and
- 52 cardiopulmonary resuscitation (CPR). The State Board of Education
- 53 and Mississippi Charter School Authorizer Board shall enforce this
- 54 subsection.
- 55 **SECTION 2.** This act shall take effect and be in force from
- 56 and after July 1, 2022.
