HOUSE BILL NO. 441

1 AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE 2 LICENSE TAGS TO SUPPORTERS OF THE MISSISSIPPI ACADEMY OF NURSE 3 PRACTITIONERS; TO PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF 4 SUCH LICENSE TAGS; TO PROVIDE FOR THE DISTRIBUTION OF THE ADDITIONAL 5 FEE COLLECTED FROM THE ISSUANCE OF SUCH LICENSE TAGS; AND FOR 6 RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 8 SECTION 1. (1) Any owner of a motor vehicle who is a 9 resident of this state, upon payment of the road and bridge privilege taxes, ad valorem taxes and registration fees as 10 11 prescribed by law for private carriers of passengers, pickup 12 trucks and other noncommercial motor vehicles, and upon payment of 13 an additional fee in the amount provided in subsection (3) of this 14 section, shall be issued a distinctive license tag for any motor 15 vehicle registered in his name identifying such person as a supporter of the Mississippi Academy of Nurse Practitioners. 16 The distinctive license tags so issued shall be of such color and 17 18 design as the Department of Revenue, with the advice of the 19 Mississippi Academy of Nurse Practitioners, may prescribe and

22 Application for the distinctive license tags authorized (2)by this section shall be made to the county tax collector on forms 23 24 prescribed by the Department of Revenue. The application and the 25 additional fee imposed under subsection (3) of this section, less 26 Two Dollars (\$2.00) thereof to be retained by the tax collector, 27 shall be remitted to the Department of Revenue on a monthly basis 28 as prescribed by the department. The portion of the additional 29 fee retained by the tax collector shall be deposited into the 30 county general fund.

31 (3)Beginning with any registration year commencing on or 32 after July 1, 2022, any person applying for a distinctive license tag under this section shall pay an additional fee in the amount 33 of Thirty Dollars (\$30.00) for each distinctive license tag 34 35 applied for under this section, which shall be in addition to all 36 other taxes and fees. The additional fee paid shall be for a period of time to run concurrently with the vehicle's established 37 38 license tag year. The additional fee is due and payable at the 39 time the original application is made for a distinctive license 40 tag under this section and thereafter annually at the time of renewal registration as long as the owner retains the distinctive 41 license tag. If the owner does not wish to retain the distinctive 42 43 license tag, he must surrender it to the local county tax collector. 44

At the end of each month, the Department of Revenue shall certify to the State 47 Treasurer the total fees collected under this section from the 48 49 issuance of the distinctive license tags issued under this 50 section. The State Treasurer shall distribute such collections as 51 follows:

52 (a) Twenty-four Dollars (\$24.00) of each additional fee 53 collected on distinctive license tags issued pursuant to this 54 section shall be distributed to the Mississippi Academy of Nurse 55 Practitioners.

56 (b) One Dollar (\$1.00) of each additional fee collected 57 on distinctive license tags issued pursuant to this section shall 58 be deposited into the Mississippi Burn Care Fund created pursuant 59 to Section 7-9-70.

(c) Two Dollars (\$2.00) of each additional fee
collected on distinctive license tags issued pursuant to this
section shall be deposited to the credit of the State Highway Fund
to be expended solely for the repair, maintenance, construction or
reconstruction of highways.

(d) One Dollar (\$1.00) of each additional fee collected
on distinctive license tags issued pursuant to this section shall
be deposited to the credit of the special fund created in Section
27-19-44.2.

The tax collector shall issue up to two (2) license 74 decals for each distinctive license tag issued under this section, 75 which will expire the same month and year as the regular license 76 tag.

77 In the case of loss or theft of a distinctive license (6)78 tag issued under this section, the owner may make application and 79 affidavit for a replacement distinctive license tag as provided by 80 Section 27-19-37. The fee for a replacement distinctive license 81 tag shall be Ten Dollars (\$10.00). The tax collector receiving 82 such application and affidavit shall be entitled to retain and deposit into the county general fund five percent (5%) of the fee 83 84 for such replacement license tag and the remainder shall be 85 distributed in the same manner as funds from the sale of regular distinctive license tags issued under this section. 86

87 SECTION 2. This act shall take effect and be in force from 88 and after July 1, 2022.
