HOUSE BILL NO. 446

1 AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE  
2 LICENSE TAGS TO SUPPORTERS OF MISSISSIPPI MAIN STREET ASSOCIATION;  
3 TO PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF SUCH LICENSE  
4 TAGS; TO PROVIDE FOR THE DISTRIBUTION OF THE ADDITIONAL FEE  
5 COLLECTED FROM THE ISSUANCE OF SUCH LICENSE TAGS; AND FOR RELATED  
6 PURPOSES.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

8 **SECTION 1.** (1) Any owner of a motor vehicle who is a  
9 resident of this state, upon payment of the road and bridge  
10 privilege taxes, ad valorem taxes and registration fees as  
11 prescribed by law for private carriers of passengers, pickup  
12 trucks and other noncommercial motor vehicles, and upon payment of  
13 an additional fee in the amount provided in subsection (3) of this  
14 section, shall be issued a distinctive license tag for any motor  
15 vehicle registered in his name identifying such person as a  
16 supporter of Mississippi Main Street Association. The distinctive  
17 license tags so issued shall be of such color and design as the  
18 Department of Revenue, with the advice of Mississippi Main Street  
19 Association, may prescribe and shall consist of such letters or



20 numbers, or both, as may be necessary to distinguish each license  
21 tag.

22 (2) Application for the distinctive license tags authorized  
23 by this section shall be made to the county tax collector on forms  
24 prescribed by the Department of Revenue. The application and the  
25 additional fee imposed under subsection (3) of this section, less  
26 Two Dollars (\$2.00) thereof to be retained by the tax collector,  
27 shall be remitted to the Department of Revenue on a monthly basis  
28 as prescribed by the department. The portion of the additional  
29 fee retained by the tax collector shall be deposited into the  
30 county general fund.

31 (3) Beginning with any registration year commencing on or  
32 after July 1, 2022, any person applying for a distinctive license  
33 tag under this section shall pay an additional fee in the amount  
34 of Thirty Dollars (\$30.00) for each distinctive license tag  
35 applied for under this section, which shall be in addition to all  
36 other taxes and fees. The additional fee paid shall be for a  
37 period of time to run concurrently with the vehicle's established  
38 license tag year. The additional fee is due and payable at the  
39 time the original application is made for a distinctive license  
40 tag under this section and thereafter annually at the time of  
41 renewal registration as long as the owner retains the distinctive  
42 license tag. If the owner does not wish to retain the distinctive  
43 license tag, he must surrender it to the local county tax  
44 collector.



45           (4) The Department of Revenue shall deposit all fees into  
46 the State Treasury on the day collected. At the end of each  
47 month, the Department of Revenue shall certify to the State  
48 Treasurer the total fees collected under this section from the  
49 issuance of the distinctive license tags issued under this  
50 section. The State Treasurer shall distribute such collections as  
51 follows:

52           (a) Twenty-four Dollars (\$24.00) of each additional fee  
53 collected on distinctive license tags issued pursuant to this  
54 section shall be distributed to Mississippi Main Street  
55 Association to be used for the promotion of tourism throughout  
56 Mississippi.

57           (b) One Dollar (\$1.00) of each additional fee collected  
58 on distinctive license tags issued pursuant to this section shall  
59 be deposited into the Mississippi Burn Care Fund created pursuant  
60 to Section 7-9-70.

61           (c) Two Dollars (\$2.00) of each additional fee  
62 collected on distinctive license tags issued pursuant to this  
63 section shall be deposited to the credit of the State Highway Fund  
64 to be expended solely for the repair, maintenance, construction or  
65 reconstruction of highways.

66           (d) One Dollar (\$1.00) of each additional fee collected  
67 on distinctive license tags issued pursuant to this section shall  
68 be deposited to the credit of the special fund created in Section  
69 27-19-44.2.



70 (5) A regular license tag must be properly displayed as  
71 required by law until replaced by a distinctive license tag under  
72 this section. The regular license tag must be surrendered to the  
73 tax collector upon issuance of the distinctive license tag under  
74 this section. The tax collector shall issue up to two (2) license  
75 decals for each distinctive license tag issued under this section,  
76 which will expire the same month and year as the regular license  
77 tag.

78 (6) In the case of loss or theft of a distinctive license  
79 tag issued under this section, the owner may make application and  
80 affidavit for a replacement distinctive license tag as provided by  
81 Section 27-19-37. The fee for a replacement distinctive license  
82 tag shall be Ten Dollars (\$10.00). The tax collector receiving  
83 such application and affidavit shall be entitled to retain and  
84 deposit into the county general fund five percent (5%) of the fee  
85 for such replacement license tag and the remainder shall be  
86 distributed in the same manner as funds from the sale of regular  
87 distinctive license tags issued under this section.

88 **SECTION 2.** This act shall take effect and be in force from  
89 and after July 1, 2022.
