HOUSE BILL NO. 465

AN ACT TO AMEND SECTION 27-19-56.314, MISSISSIPPI CODE OF 1 2 1972, TO REAUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE 3 LICENSE TAGS TO SUPPORTERS OF THE MIND CENTER AT THE UNIVERSITY OF 4 MISSISSIPPI MEDICAL CENTER; AND FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 SECTION 1. Section 27-19-56.314, Mississippi Code of 1972, 6 7 is amended as follows: 27-19-56.314. (1) Beginning with any registration year 8 commencing on or after July 1, \* \* \* 2022, any owner of a motor 9 10 vehicle who is a resident of this state, upon payment of the road and bridge privilege taxes, ad valorem taxes and registration fees 11 12 as prescribed by law for private carriers of passengers, pickup 13 trucks and other noncommercial motor vehicles, and upon payment of 14 an additional fee in the amount provided in subsection (3) of this section, shall be issued a distinctive license tag for any motor 15 vehicle registered in his name identifying such person as a 16 17 supporter of the MIND Center at the University of Mississippi Medical Center. 20 advice of the MIND Center at the University of Mississippi Medical 21 Center, may prescribe and shall consist of such letters or 22 numbers, or both, as may be necessary to distinguish each license 23 tag.

24 Application for the distinctive license tags authorized (2)25 by this section shall be made to the county tax collector on forms 26 prescribed by the Department of Revenue. The application and the 27 additional fee imposed under subsection (3) of this section, less 28 Two Dollars (\$2.00) thereof to be retained by the tax collector, 29 shall be remitted to the Department of Revenue on a monthly basis 30 as prescribed by the department. The portion of the additional 31 fee retained by the tax collector shall be deposited into the 32 county general fund.

Any person applying for a distinctive license tag under 33 (3) 34 this section shall pay an additional fee in the amount of Thirty 35 Dollars (\$30.00) for each distinctive license tag applied for 36 under this section, which shall be in addition to all other taxes and fees. The additional fee paid shall be for a period of time 37 38 to run concurrently with the vehicle's established license tag 39 year. The additional fee is due and payable at the time the 40 original application is made for a distinctive license tag under this section and thereafter annually at the time of renewal 41 42 registration as long as the owner retains the distinctive license 43 taq. If the owner does not wish to retain the distinctive license 44 taq, he must surrender it to the local county tax collector.

45 (4) The Department of Revenue shall deposit all fees into 46 the State Treasury on the day collected. At the end of each month, the Department of Revenue shall certify to the State 47 Treasurer the total fees collected under this section from the 48 49 issuance of the distinctive license tags issued under this 50 section. The State Treasurer shall distribute such collections as follows: 51

52 (a) Twenty-four Dollars (\$24.00) of each additional fee 53 collected on distinctive license tags issued pursuant to this 54 section shall be distributed to a special fund hereby created in 55 the State Treasury to the credit of the MIND Center at the 56 University of Mississippi Medical Center. The fund shall be 57 available for expenditure at the discretion of the University of 58 Mississippi Medical Center for the benefit of the MIND Center.

(b) One Dollar (\$1.00) of each additional fee collected
on distinctive license tags issued pursuant to this section shall
be deposited into the Mississippi Burn Care Fund created pursuant
to Section 7-9-70.

(c) Two Dollars (\$2.00) of each additional fee

section shall be deposited to the credit of the State Highway Fund
to be expended solely for the repair, maintenance, construction or
reconstruction of highways.

72 (5) A regular license tag must be properly displayed as 73 required by law until replaced by a distinctive license tag under 74 this section. The regular license tag must be surrendered to the 75 tax collector upon issuance of the distinctive license tag under 76 this section. The tax collector shall issue up to two (2) license 77 decals for each distinctive license tag issued under this section, 78 which will expire the same month and year as the regular license 79 tag.

In the case of loss or theft of a distinctive license 80 (6) tag issued under this section, the owner may make application and 81 82 affidavit for a replacement distinctive license tag as provided by 83 Section 27-19-37. The fee for a replacement distinctive license tag shall be Ten Dollars (\$10.00). The tax collector receiving 84 85 such application and affidavit shall be entitled to retain and 86 deposit into the county general fund five percent (5%) of the fee 87 for such replacement license tag and the remainder shall be 88 distributed in the same manner as funds from the sale of regular 89 distinctive license tags issued under this section.

90 (7) In order for a distinctive license tag to be issued 91 under this section, the provisions of Section 27-19-44(3) must be 92 satisfied for the distinctive license tag before July 1, \* \* \* 93 <u>2025</u>.
