HOUSE BILL NO. 526

1 AN ACT TO AMEND SECTION 37-181-3, MISSISSIPPI CODE OF 1972, WHICH IS THE DEFINITIONS SECTION OF THE "EQUAL OPPORTUNITY FOR 2 3 STUDENTS WITH SPECIAL NEEDS ACT," TO REVISE THE DEFINITIONS FOR "ELIGIBLE STUDENT" AND "ELIGIBLE SCHOOL" TO REFLECT THE INCLUSION 4 5 OF STUDENTS DIAGNOSED WITH DYSLEXIA WHO DO NOT RECEIVE THE 6 ASSISTANCE OF A MISSISSIPPI DYSLEXIA THERAPY SCHOLARSHIP FOR 7 STUDENTS WITH DYSLEXIA PROGRAM; AND FOR RELATED PURPOSES. 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Section 37-181-3, Mississippi Code of 1972, is 10 amended as follows: 11 37-181-3. The terms used in this chapter shall have the meanings ascribed herein, unless the context clearly indicates 12 13 otherwise: 14 (a) "ESA program" means the Education Scholarship Account (ESA) program created in this chapter. 15 16 (b) "Eligible student" means any student who has had an 17 active Individualized Education Program (IEP) within the past 18 three (3) years and has maintained eligibility or who has been 19 properly screened and has received a diagnosis of dyslexia and is

(c) "Participating student" means any student who meets
the qualifications of an eligible student as defined in paragraph
(b) of this section and is participating in an ESA program at an
eligible school.

26 (d) "Parent" means a resident of this state who is a
27 parent, legal guardian, custodian or other person with the
28 authority to act on behalf of the eligible student.

29 (e) "Department" means the State Department of30 Education.

31 (f) "Home school district" means the public school 32 district in which the student resides.

33 "Eligible school" means a state-accredited special (q) 34 purpose school, a state-accredited nonpublic school, or a 35 nonpublic school located in the state that has enrolled a 36 participating student and is providing services for the participating student's disability or special education needs, or 37 38 is providing services addressing a participating student's IEP. 39 For purposes of eligible students with a dyslexia diagnosis, an 40 eligible school includes those defined in Section 37-173-1(g). An eligible school does not include a home instruction program under 41 Section 37-13-91, Mississippi Code of 1972. 42

43 (h) "Tutor" means a person who is certified or licensed44 by a state, regional, or national certification, licensing, or

48 (i) "Postsecondary institution" means a community
49 college, college, or university accredited by a state, regional or
50 national accrediting organization.

51 (j) "Educational service provider" means an eligible 52 school, tutor, or other person or organization that provides 53 education-related services and products to participating students.

54 (k) "Awarded ESA school year" means the duration of the 55 school year in which ESA program funds are deposited in a 56 student's ESA.

(1) Nothing in this section shall negate federal law
requiring public school districts to identify and provide services
to students with disabilities who live within the public school
district, including those enrolled in nonpublic schools or home
instruction programs.

62 An eligible school shall provide notice to a (m) 63 participating student's home school district when the eligible 64 student enrolls in the eligible school with an ESA. Furthermore, 65 a public school district providing special education services to a 66 participating student enrolled in an eligible school shall be reimbursed by the eligible school, or parent or quardian who 67 68 submitted the ESA application, fair market value for any special education services rendered to the eligible student in an amount 69

72 SECTION 2. This act shall take effect and be in force from 73 and after July 1, 2022.
