- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** (1) This act shall be known and may be cited as
- 10 the "Mississippi Healthy Food and Families Program."
- 11 (2) For purposes of this act, the following terms shall have
- 12 the following meanings unless the context clearly indicates
- 13 otherwise:
- 14 (a) "Eligible fruits and vegetables" means any fresh or
- 15 frozen, whole or cut fruits and vegetables that do not contain
- 16 added sugar, fat, oil or salt.
- 17 (b) "Eligible retailers" means a small business whose
- 18 principal office is located in Mississippi and that has a

- 19 demonstrated commitment to procuring Mississippi-grown foods,
- 20 including fruits and vegetables.

- 23 organizations, who will distribute incentive dollars to

- 27 and vegetables, support farmers and invest in Mississippi's local

- 29 (4) The designated nonprofit organizations shall have a
- 30 demonstrated track record of:
- 31 (a) Building a statewide network;
- 32 (b) Implementing such funds for distribution and
- 33 reporting processes;
- 34 (c) Providing training and technical assistance to
- 35 farmers markets, produce stands, and direct producer-to-consumer
- 36 venues;
- 37 (d) Conducting community outreach and data collection;

- 39 (e) Providing full accounting and administration of
- 40 funds distributed to farmers markets and retailers.
- 41 (5) At least ninety percent (90%) of the money deposited
- 42 into the Mississippi Healthy Food and Families Program shall be
- 43 distributed to participating Mississippi farmers markets, produce
- 44 stands and retailers for healthy food incentives. A maximum of
- 45 ten percent (10%) of the money deposited into the Mississippi

- 46 Healthy Food and Families Program may be used for administrative
- 47 costs.
- 48 (6) Guidelines and eligibility for the Mississippi Healthy
- 49 Food and Families Program will be established by the Department of
- 50 Agriculture, consistent with the U.S. Agriculture Improvement Act
- 51 of 2018.
