HOUSE BILL NO. 561

- AN ACT TO AMEND SECTION 25-3-43, MISSISSIPPI CODE OF 1972, TO REMOVE THE GEOGRAPHICAL LIMITATION ON THE EXPENSE ALLOWANCE
- 3 RECEIVED BY EACH SUPREME COURT JUSTICE AND EACH JUDGE OF THE COURT
- 4 OF APPEALS; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 25-3-43, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 25-3-43. (1) When any chancery judge, county judge or
- 9 circuit judge shall be required to travel in the performance of
- 10 his official duties, such judge shall receive as expenses of such
- 11 travel the mileage allowance and a reimbursement for other actual
- 12 and necessary expenses incurred in such travel as provided for
- 13 public officers and employees in Section 25-3-41, Mississippi Code
- 14 of 1972. This shall be the entire travel allowances or travel
- 15 expenses received by such judges.
- 16 (2) Chancery judges and circuit judges shall direct requests
- 17 for reimbursement for the travel expenses authorized pursuant to
- 18 this section to the Supreme Court and the Supreme Court shall

- 19 submit such requests to the Department of Finance and
- 20 Administration.
- 21 (3) The Supreme Court shall have the power to adopt rules
- 22 and regulations regarding the administration of travel expenses
- 23 authorized pursuant to this section.
- 24 (4) In any county in which is located a State Penitentiary,
- 25 the board of supervisors, in order to compensate the justice court
- 26 judges who are required to travel to the State Penitentiary, is
- 27 authorized to reimburse justice court judges' mileage in the
- amount authorized by Section 25-3-41, but not to exceed One
- 29 Hundred Dollars (\$100.00) per month, such monies to be paid from
- 30 the general county fund of such county.
- 31 (5) In addition to the regular salary provided by Section
- 32 25-3-35 and the mileage reimbursement provided by Section 25-3-41,
- 33 each Supreme Court Justice and each judge of the Court of Appeals
- 34 shall receive an expense allowance as specified in this
- 35 subsection. The expense allowance shall be equal to the maximum
- 36 daily expense rate allowable to employees of the federal
- 37 government for travel in the high rate geographical area of
- 38 Jackson, Mississippi, as may be established by federal
- 39 regulations, per day, for each day while actually attending to
- 40 judicial duties in * * * Mississippi, not to exceed twenty (20)
- 41 days per month.
- 42 **SECTION 2.** This act shall take effect and be in force from
- 43 and after July 1, 2022.
