HOUSE BILL NO. 591

1 AN ACT TO AMEND SECTIONS 37-179-1 AND 37-179-3, MISSISSIPPI 2 CODE OF 1972, TO AUTHORIZE THE STATE BOARD OF EDUCATION TO APPROVE 3 THE CREATION OF DISTRICTS OF INNOVATION; TO DEFINE CERTAIN TERMS RELATED TO "DISTRICTS OF INNOVATION"; TO LIMIT THE INITIAL 4 5 APPROVAL AND SUBSEQUENT RENEWALS OF DISTRICTS OF INNOVATION TO 6 FIVE-YEAR PERIODS; TO DIRECT THE BOARD TO PROMULGATE 7 ADMINISTRATIVE RULES AND REGULATIONS TO PRESCRIBE THE CONDITIONS AND PROCEDURES TO BE USED BY LOCAL SCHOOL BOARDS TO BE APPROVED AS 8 9 A DISTRICT OF INNOVATION; TO SPECIFY THE CRITERIA TO BE ADDRESSED 10 BY THE ADMINISTRATIVE REGULATIONS; TO PRESCRIBE THE REQUIREMENTS FOR A DISTRICT TO BE A DISTRICT OF INNOVATION APPLICANT; TO 11 12 PRESCRIBE THE STATUTORY REQUIREMENTS WITH WHICH SCHOOLS OF 13 INNOVATION WITHIN DISTRICTS OF INNOVATION MUST COMPLY; TO IDENTIFY AREAS IN WHICH DISTRICTS OF INNOVATION MAY REQUEST APPROVAL OF 14 15 PRACTICES THAT ARE DIFFERENT THAN CURRENT STATUTORY REQUIREMENTS; 16 AND FOR RELATED PURPOSES.

17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

18 SECTION 1. Section 37-179-1, Mississippi Code of 1972, is

23 (a) "District of innovation" means a district that has 24 developed a plan of innovation in compliance with this section and

25 has been approved by the State Board of Education to be exempted

(b) "Innovation" means a new or creative alternative to existing instructional and administrative practices intended to improve student learning and student performance of all students, including community schools;

(c) "School of innovation" means a school that voluntarily participates in a district of innovation plan to improve instruction, including waivers and exemptions from local school board policies, selected provisions of rules and regulations promulgated by the State Board of Education, and selected sections of the Mississippi Code of 1972, as permitted under this section and Section * * * <u>37-179-3</u>;

40 (d) "Board" means the State Board of Education;
41 (e) "Department" means the State Department of
42 Education.

43 (f) "Community school" means a traditional district 44 public school that partners with community-based organizations to 45 coordinate academic, social, physical health and mental health 46 services, to reduce barriers to learning and improve education 47 outcomes. Community schools include all five (5) of the 48 following:

99 (i) Is a full-time staff member serving one (1) 100 eligible school; Is responsible for the identification, 101 (ii) implementation and coordination of integrated student supports, 102 103 expanded and enriched learning time and opportunities, family and 104 community engagement and collaborative leadership and practices; 105 (iii) Serves as a member of the school-based 106 leadership team; 107 (iv) Serves as the lead for the needs and assets 108 assessment and community school plan; and (v) Coordinates the needs and assets assessment 109 110 and stakeholder-driven approach to problem-solving and continuous 111 improvement. 112 The State Board of Education is authorized to approve (2)113 districts of innovation for the purposes of improving students' 114 educational performance. Districts of innovation shall be provided flexibility from selected board regulations, Title 37, 115 Mississippi Code of 1972, and local school board policies for 116 117 school administrators, teachers and staff to meet the diverse 118 needs of students. A low-performing school or school district 119 managing the transition of multiple schools to the community 120 school model shall be provided a three-year transition before becoming eligible for state takeover. The initial approval of a 121

122 district of innovation shall be for a five-year period. Each 123 renewal of a district of innovation shall not exceed five (5)

126 (3) The board shall promulgate administrative rules and 127 regulations to prescribe the conditions and procedures to be used 128 by a local school board to be approved as a district of innovation 129 and shall publish the same on or before December 31, 2015.

130 (4) Administrative rules and regulations promulgated by the131 board under subsection (3) of this section shall specify:

(a) The regulatory areas which may be exempted or
modified if approved by the board, except as provided in Section
37-179-3(2), and in addition to those areas identified in Section
37-179-3(3);

214 (2) The district and all schools participating in a 215 district's innovation plan shall:

(a) Ensure the same health, safety, civil rights, and disability rights requirements as are applied to all public schools;

(b) Ensure students meet compulsory attendance requirements under Sections 37-13-91 and 37-13-92;

7-7-211(e);

(f) Require state and criminal background checks for staff and volunteers as required of all public school employees and volunteers within the public schools and specified in Section 37-9-17;

(g) Comply with open records and open meeting
requirements under Sections 25-41-1 et seq. and 25-61-1 et seq.;
(h) Comply with purchasing requirements and limitations

(i) Provide overall instructional time that is equivalent to or greater than that required under Sections 37-1-11 and 37-13-67, but which may include on-site instruction, distance learning, online courses, and work-based learning on nontraditional school days or hours; and

(3) (a) Only schools that choose to be designated as schools of innovation shall be included in a district's application;

(c) Notwithstanding the provisions of paragraph (a) of this subsection, a local school board may require a school that has been identified as a persistently low-achieving school under provisions of Section 37-17-6 to participate in the district's plan of innovation.

262 Use capital outlay funds for operational costs; (a) 263 Hire persons for classified positions in (b) 264 nontraditional school and district assignments who have bachelors 265 and advanced degrees from postsecondary education institutions 266 accredited by a regional accrediting association (Southern 267 Association of Colleges and Schools) or by an organization 268 affiliated with the National Commission on Accrediting;
