HOUSE BILL NO. 603

1 AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE 2 LICENSE TAGS TO SUPPORTERS OF STARKVILLE ACADEMY ATHLETICS; TO 3 PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF SUCH LICENSE TAGS; 4 TO PROVIDE FOR THE DISTRIBUTION OF THE ADDITIONAL FEE COLLECTED 5 FROM THE ISSUANCE OF SUCH LICENSE TAGS; AND FOR RELATED PURPOSES. 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. (1) Any owner of a motor vehicle who is a 8 resident of this state, upon payment of the road and bridge 9 privilege taxes, ad valorem taxes and registration fees as 10 prescribed by law for private carriers of passengers, pickup trucks and other noncommercial motor vehicles, and upon payment of 11 12 an additional fee in the amount provided in subsection (3) of this section, shall be issued a distinctive license tag for any motor 13 14 vehicle registered in his or her name identifying such person as a 15 supporter of Starkville Academy athletics. The distinctive license tags so issued shall be of such color and design as the 16 17 Department of Revenue, with the advice of the principal of Starkville Academy, may prescribe and shall consist of such 18

21 Application for the distinctive license tags authorized (2)22 by this section shall be made to the county tax collector on forms 23 prescribed by the Department of Revenue. The application and the 24 additional fee imposed under subsection (3) of this section, less Two Dollars (\$2.00) thereof to be retained by the tax collector, 25 26 shall be remitted to the Department of Revenue on a monthly basis 27 as prescribed by the department. The portion of the additional 28 fee retained by the tax collector shall be deposited into the 29 county general fund.

30 (3)Beginning with any registration year commencing on or 31 after July 1, 2022, any person applying for a distinctive license 32 tag under this section shall pay an additional fee in the amount of Fifty Dollars (\$50.00) for each distinctive license tag applied 33 34 for under this section, which shall be in addition to all other 35 taxes and fees. The additional fee paid shall be for a period of time to run concurrently with the vehicle's established license 36 37 tag year. The additional fee is due and payable at the time the 38 original application is made for a distinctive license tag under 39 this section and thereafter annually at the time of renewal 40 registration as long as the owner retains the distinctive license If the owner does not wish to retain the distinctive license 41 taq. 42 tag, he or she must surrender it to the local county tax collector. 43

At the end of each month, the Department of Revenue shall certify to the State 46 Treasurer the total fees collected under this section from the 47 48 issuance of the distinctive license tags issued under this 49 section. The State Treasurer shall distribute such collections as 50 follows:

(a) Forty-four Dollars (\$44.00) of each additional fee
collected on distinctive license tags issued pursuant to this
section shall be distributed to Starkville Academy.

54 (b) One Dollar (\$1.00) of each additional fee collected 55 on distinctive license tags issued pursuant to this section shall 56 be deposited into the Mississippi Burn Care Fund created pursuant 57 to Section 7-9-70.

(c) Two Dollars (\$2.00) of each additional fee
collected on distinctive license tags issued pursuant to this
section shall be deposited to the credit of the State Highway Fund
to be expended solely for the repair, maintenance, construction or
reconstruction of highways.

(d) One Dollar (\$1.00) of each additional fee collected
on distinctive license tags issued pursuant to this section shall
be deposited to the credit of the special fund created in Section
27-19-44.2.

67 (5) A regular license tag must be properly displayed as68 required by law until replaced by a distinctive license tag under

69 this section. The regular license tag must be surrendered to the 70 tax collector upon issuance of the distinctive license tag under 71 this section. The tax collector shall issue up to two (2) license 72 decals for each distinctive license tag issued under this section, 73 which will expire the same month and year as the regular license 74 tag.

75 In the case of loss or theft of a distinctive license (6) 76 tag issued under this section, the owner may make application and 77 affidavit for a replacement distinctive license tag as provided by 78 Section 27-19-37. The fee for a replacement distinctive license 79 tag shall be Ten Dollars (\$10.00). The tax collector receiving 80 such application and affidavit shall be entitled to retain and 81 deposit into the county general fund five percent (5%) of the fee 82 for such replacement license tag and the remainder shall be distributed in the same manner as funds from the sale of regular 83 84 distinctive license tags issued under this section.

85 **SECTION 2.** This act shall take effect and be in force from 86 and after July 1, 2022.
