## HOUSE BILL NO. 682

AN ACT TO CREATE NEW SECTION 73-21-131, MISSISSIPPI CODE OF

1972, TO AUTHORIZE PHARMACISTS TO TEST OR SCREEN FOR AND TREAT 3 CERTAIN MINOR, NONCHRONIC HEALTH CONDITIONS AFTER COMPLETING AN APPROVED EDUCATION COURSE AND MEETING OTHER REQUIREMENTS; TO 5 PROVIDE THAT PHARMACISTS WHO TEST FOR AND TREAT INFLUENZA OR 6 STREPTOCOCCUS MUST HAVE AN ESTABLISHED WRITTEN PROTOCOL WITH A 7 SUPERVISING PRACTITIONER APPROVED BY THE STATE BOARD OF PHARMACY; TO REQUIRE PHARMACISTS PROVIDING SERVICES UNDER THIS SECTION TO 8 9 COMPLETE A CONTINUING EDUCATION COURSE APPROVED BY THE BOARD 10 ADDRESSING ISSUES RELATED TO MINOR, NONCHRONIC HEALTH CONDITIONS 11 FOR EACH ANNUAL LICENSURE RENEWAL; AND FOR RELATED PURPOSES. 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 13 SECTION 1. The following shall be codified as Section 73-21-131, Mississippi Code of 1972: 14 15 73-21-131. (1) The State Board of Pharmacy, in consultation with the State Board of Medical Licensure and the Mississippi 16 Board of Nursing, shall adopt rules identifying the minor, 17 18 nonchronic health conditions for which a pharmacist may test or screen for and treat. For purposes of this section, a "minor, 19 nonchronic health condition" is typically a short-term condition 20 21

that is generally managed with minimal treatment or self-care,

including, but not limited to, the following:

- 24 (b) Streptococcus;
- 25 (c) Lice;
- 26 (d) Skin conditions, such as ringworm, athlete's foot
- 27 and others; and
- 28 (e) Minor, uncomplicated infections.
- 29 (2) A pharmacist who tests or screens for and treats minor,
- 30 nonchronic health conditions under this section must:
- 31 (a) Hold an active and unencumbered license to practice
- 32 pharmacy in this state;
- 33 (b) Complete an initial appropriate education course
- 34 approved by the State Board of Pharmacy;
- 35 (c) Maintain at least Two Hundred Fifty Thousand
- 36 Dollars (\$250,000.00) of liability coverage or be covered by an
- 37 employer's liability insurance in an equivalent amount;
- 38 (d) Report a diagnosis or suspected existence of a
- 39 disease of public health significance to the State Department of
- 40 Health in accordance with rules adopted under Section 41-23-1;
- 41 (e) Upon request of a patient, furnish patient records
- 42 to a practitioner designated by the patient; and
- 43 (f) Maintain records of all patients receiving services
- 44 under this section for a period of five (5) years.
- 45 (3) The State Board of Pharmacy shall adopt, by rule, within
- 46 ninety (90) days after the effective date of this act, a formulary
- 47 of medicinal drugs that a pharmacist may prescribe for the minor,

- 48 nonchronic health conditions approved under subsection (1) of this
- 49 section. The formulary must include medicinal drugs approved by
- 50 the United States Food and Drug Administration that are indicated
- 51 for treatment of the minor, nonchronic health condition, including
- 52 any over-the-counter medication. The formulary may not include
- 53 any controlled substance as defined in Section 41-29-105 or 21 USC
- 54 Section 802.
- 55 (4) A pharmacist who tests or screens for and treats minor,
- 56 nonchronic health conditions under this section may use any tests
- 57 that may guide diagnosis or clinical decision making that the
- 58 Centers for Medicare and Medicaid Services has determined
- 59 qualifies for a waiver under the federal Clinical Laboratory
- 60 Improvement Amendments of 1988, or the federal rules adopted under
- 61 that law, or any established screening procedures that can safely
- 62 be performed by a pharmacist.
- 63 (5) A pharmacist who tests for and treats influenza or
- 64 streptococcus under this section may only provide those services
- 65 within the framework of the established written protocol with a
- 66 supervising practitioner approved by the State Board of Pharmacy
- 67 according to the collaborative practice arrangements allowed by
- 68 the board.
- 69 (6) A pharmacist providing services under this section must
- 70 complete a continuing education course approved by the State Board
- 71 of Pharmacy addressing issues related to minor, nonchronic health
- 72 conditions for each annual licensure renewal in addition to the

- 73 continuing education requirements under Section 73-21-91. Each
- 74 pharmacist must submit confirmation of having completed the course
- 75 when applying for licensure renewal. A pharmacist who fails to
- 76 comply with this subsection may not provide testing, screening or
- 77 treatment services.
- 78 **SECTION 2.** This act shall take effect and be in force from
- 79 and after July 1, 2022.
