HOUSE BILL NO. 796

AN ACT TO AMEND SECTION 27-19-48, MISSISSIPPI CODE OF 1972,
TO PROVIDE THAT, AS AN ALTERNATIVE TO A PERSONALIZED LICENSE TAG
BEING OF THE SAME COLOR AS REGULAR LICENSE TAGS, AN OWNER OF A
MOTOR VEHICLE OR NONCOMMERCIAL TRAILER MAY CHOOSE A PERSONALIZED
TAG WITH A BLACK BACKGROUND AND A WHITE PINSTRIPE BORDER, WITH
"MISSISSIPPI" PRINTED AT THE TOP AND THE NAME OF THE COUNTY
PRINTED AT THE BOTTOM; AND FOR RELATED PURPOSES.

- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 27-19-48, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 27-19-48. (1) (a) Owners of motor vehicles and
- 12 noncommercial trailers who are residents of this state, upon
- 13 complying with the laws relating to registration and licensing of
- 14 motor vehicles and trailers, and upon payment of the road and
- 15 bridge privilege taxes, ad valorem taxes and registration fees as
- 16 prescribed by law for private carriers of passengers, pickup
- 17 trucks, other noncommercial motor vehicles and trailers, and upon
- 18 payment of an additional fee in the amount provided in subsection
- 19 (4)(a) of this section, shall be issued a personalized license tag
- 20 of the same color as regular license tags to consist of the name

- 21 of the county and not more than seven (7) letters of the alphabet 22 or seven (7) numbers in lieu of the license tag numbering system prescribed by law. The purchaser of the personalized license tag 23 may choose the combination of such letters or numbers, but no two 24 25 (2) motor vehicles or trailers shall have the same combination of 26 letters or numbers. In the event that the same combination of 27 letters has been chosen by two (2) or more purchasers, the 28 Department of Revenue shall assign a different number to each such 29 purchaser which shall appear on the license tag following the combination of letters; however, this combination shall not exceed 30 seven (7) letters and/or numbers. The combination of letters 31 32 and/or numbers written across the license tag shall be 33 sufficiently large to be easily read but shall not be less than three (3) inches in height. No combination of letters or numbers 34 35 which comprise words or expressions that are considered obscene, 36 slandering, insulting or vulgar in ordinary usage shall be 37 permitted, with the Commissioner of Revenue having the responsibility of making this determination. If, however, such 38 39 license plate is issued in error or otherwise and is determined by 40 the commissioner to be obscene, slanderous, insulting, vulgar or 41 offensive, the commissioner shall notify the owner that the 42 license plate must be surrendered and that another personalized 43 license plate may be selected by him and issued at no cost. 44 (b) As an alternative to the personalized license tag

being of the same color as regular license tags, an owner of a

- 46 motor vehicle or noncommercial trailer may choose a personalized
- 47 tag with a black background and a white pinstripe border.
- 48 "Mississippi" shall be printed at the top, and the name of the
- 49 county shall be printed at the bottom.
- 50 (c) Should the vehicle or trailer owner not desire
- 51 another personalized license plate, the fee for such plate shall
- 52 be refunded. In the event the owner fails to surrender the
- 53 license plate after receiving proper notification, the
- 54 commissioner shall issue an order directing that the license plate
- 55 be seized by agents of the Department of Revenue or any other duly
- 56 authorized law enforcement personnel.
- 57 (2) For the purposes of this section the terms "motor
- 58 vehicle" and "vehicle" include motorcycles.
- 59 (3) Application for the personalized license tags shall be
- 60 made to the county tax collector on forms prescribed by the
- 61 Department of Revenue. The application form shall contain space
- 62 for the applicant to make five (5) different choices for the
- 63 combination of the letters and numbers in the order in which the
- 64 combination is desired by the applicant. The application and the
- 65 additional fee, less five percent (5%) thereof to be retained by
- 66 the tax collector, shall be remitted to the Department of Revenue
- 67 within seven (7) days of the date the application is made. The
- 68 portion of the additional fee retained by the tax collector shall
- 69 be deposited into the county general fund.

70	(4) (a) Beginning with any registration year commencing on
71	or after November 1, 1986, any person applying for a personalized
72	license tag shall pay an additional fee which shall be in addition
73	to all other taxes and fees. The additional fee paid shall be for
74	a period of time to run concurrently with the vehicle's or
75	trailer's established license tag year. The additional fee of
76	Thirty Dollars (\$30.00) is due and payable at the time the
77	original application is made for a personalized tag and thereafter
78	annually at the time of renewal registration as long as the owner
79	retains the personalized tag. If the owner does not wish to
80	retain the personalized tag, he must surrender it to the local
81	county tax collector. The additional fee due at the time of
82	renewal registration shall be collected by the county tax
83	collector and remitted to the Department of Revenue on a monthly
84	basis as prescribed by the department.

85 The Department of Revenue shall deposit all taxes 86 and fees into the State Treasury on the day collected. At the end 87 of each month, the Department of Revenue shall certify the total 88 fees collected under this section to the State Treasurer who shall distribute to the credit of the State General Fund Sixteen Dollars 89 90 and Twenty-five Cents (\$16.25) of each additional fee and the remainder of each such additional fee shall be deposited to the 91 92 credit of the State Highway Fund to be expended solely for the 93 repair, maintenance, construction or reconstruction of highways.

- 94 (5) A regular license tag must be properly displayed as
 95 required by law until replaced by a personalized license tag; and
 96 the regular license tag must be surrendered to the tax collector
 97 upon issuance of the personalized license tag. The tax collector
 98 shall issue up to two (2) license decals for the personalized
 99 license tag, which will expire the same month and year as the
 100 original license tag.
- 101 (6) The applicant shall receive a refund of the fee paid for 102 a personalized license tag if the personalized license tag is not 103 issued to him because the combination of letters and numbers 104 requested to be placed thereon is not available for any reason.
 - (7) In the case of loss or theft of a personalized license tag, the owner may make application and affidavit for a replacement license tag as provided by Section 27-19-37. The fee for a replacement personalized license tag shall be Ten Dollars (\$10.00). The tax collector receiving such application and affidavit shall be entitled to retain and deposit into the county general fund five percent (5%) of the fee for such replacement license tag and the remainder shall be distributed in the same manner as funds from the sale of regular license tags.
- 114 (8) The owner of a personalized license tag may make
 115 application for a duplicate of such tag. The fee for such
 116 duplicate personalized license tag shall be Ten Dollars (\$10.00).
 117 The tax collector receiving the application shall be entitled to
 118 retain and deposit into the county general fund five percent (5%)

119	of the fee for such duplicate personalized license tag and the
120	remainder shall be distributed in the same manner as funds from
121	the sale of regular license tags. A duplicate personalized
122	license tag may not be fastened to the rear of a vehicle or
123	trailer and may not be utilized as a replacement for any
124	personalized license tag issued pursuant to this section. Month
125	decals and year decals shall not be issued for duplicate
126	personalized license tags and month decals and year decals shall
127	not be attached to duplicate personalized license tags.
128	SECTION 2. This act shall take effect and be in force from
129	and after July 1, 2022.
