HOUSE BILL NO. 829

AN ACT TO AMEND SECTIONS 19-9-11, 19-9-13 AND 21-33-307, MISSISSIPPI CODE OF 1972, TO MANDATE THE HOLDING OF AN ELECTION ON THE QUESTION OF ISSUING COUNTY OR MUNICIPAL BONDS; AND FOR RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 SECTION 1. Section 19-9-11, Mississippi Code of 1972, is 7 amended as follows:

19-9-11. Before issuing any bonds for any of the purposes 8 enumerated in Sections $19-9-1 \star \star \star$ and 19-9-3, the board of 9 10 supervisors shall adopt a resolution declaring its intention so to do, stating the amount of bonds proposed to be issued and the 11 12 purpose for which the bonds are to be issued, and the date upon which the board proposes to direct the issuance of such bonds. 13 14 Such resolution shall be published once a week for at least three (3) consecutive weeks in at least one (1) newspaper published in 15 16 such county. * * * If no newspaper be published in such county, 17 then such notice shall be given by publishing the resolution for the required time in some newspaper having a general circulation 18 in such county and, in addition, by posting a copy of such 19 H. 20 resolution for at least twenty-one (21) days * * * at three (3)
21 public places in such county. * * * An election on the question
22 of the issuance of such bonds shall be called and held as is

24 SECTION 2. Section 19-9-13, Mississippi Code of 1972, is 25 amended as follows:

26 19-9-13. * * * Notice of the election * * * provided for in 27 Section 19-9-11 * * * shall be signed by the clerk of the board of 28 supervisors and shall be published once a week for at least three 29 (3) consecutive weeks, in at least one (1) newspaper published in 30 such county. The first publication of such notice shall be made not less than twenty-one (21) days prior to the date fixed for 31 32 such election, and the last publication shall be made not more than seven (7) days prior to such date. If no newspaper is 33 34 published in such county, then such notice shall be given by 35 publishing the same for the required time in some newspaper having 36 a general circulation in such county and, in addition, by posting a copy of such notice for at least twenty-one (21) days next 37 38 preceding such election at three (3) public places in such county. 39 SECTION 3. Section 21-33-307, Mississippi Code of 1972, is 40 amended as follows:

41 21-33-307. Before issuing any bonds for any of the purposes 42 enumerated in Section 21-33-301, the governing authority of the 43 issuing municipality shall adopt a resolution declaring its 44 intention so to do, stating the amount of bonds proposed to be

Such resolution shall be published once a 47 week for at least three (3) consecutive weeks in at least one (1) 48 49 newspaper published in such municipality. * * * If no newspaper 50 be published in such municipality, then such notice shall be given by publishing the resolution for the required time in some 51 52 newspaper having a general circulation in such municipality and, 53 in addition, by posting a copy of such resolution for at least twenty-one (21) days * * * at three (3) public places in such 54 55 municipality. The publication of the resolution may be made as provided in Section 21-17-19. * * * An election on the question 56 57 of the bonds shall be called and held as is provided in Section 58 21-33-309. Notice of such election shall be signed by the clerk 59 of the municipality and shall be published once a week for at 60 least three (3) consecutive weeks in at least one (1) newspaper 61 published in such municipality. The first publication of such notice shall be made not less than twenty-one (21) days prior to 62 63 the date fixed for such election, and the last publication shall 64 be made not more than seven (7) days prior to such date. If no 65 newspaper is published in such municipality, then such notice 66 shall be given by publishing the same for the required time in 67 some newspaper having a general circulation in such municipality and published in the same or an adjoining county and, in addition, 68 by posting a copy of such notice for at least twenty-one (21) days 69

72 Under no circumstances shall any municipality exceed the bond 73 limit as set by statute for municipalities.

74 SECTION 4. This act shall take effect and be in force from 75 and after July 1, 2022.
