HOUSE BILL NO. 860

AN ACT TO CREATE NEW SECTION 41-37-27, MISSISSIPPI CODE OF

2 1972, TO BE KNOWN AS "JENNA'S LAW," TO REQUIRE THAT ALL AUTOPSIES CONDUCTED IN THIS STATE INCLUDE AN INQUIRY TO DETERMINE WHETHER 3 THE DEATH WAS A DIRECT RESULT OF A SEIZURE OR EPILEPSY; TO PROVIDE 5 THAT IF THE FINDINGS IN AN AUTOPSY ARE CONSISTENT WITH KNOWN OR 6 SUSPECTED SUDDEN UNEXPECTED DEATH IN EPILEPSY (SUDEP), THEN THE 7 MEDICAL EXAMINER, EXAMINING PHYSICIAN OR CORONER SHALL CAUSE TO BE 8 INDICATED ON THE DEATH CERTIFICATE THAT SUDEP IS THE CAUSE OR 9 SUSPECTED CAUSE OF DEATH AND FORWARD A COPY OF THE DEATH CERTIFICATE TO THE NORTH AMERICAN SUDEP REGISTRY WITHIN THIRTY 10 11 DAYS; AND FOR RELATED PURPOSES. 12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 13 SECTION 1. The following shall be codified as Section 41-37-27, Mississippi Code of 1972: 14 15 41-37-27. (1) This section shall be known as "Jenna's Law." (2) For the purposes of this section, the term "sudden 16 17 unexpected death in epilepsy" means a death in a patient 18 previously diagnosed with epilepsy which is not due to trauma, 19 drowning, status epilepticus or other known causes, but for which there is often evidence of an associated seizure. A finding of 20 sudden unexpected death in epilepsy (SUDEP) is definite when 21

- 23 cause of death, such as stroke, myocardial infarction or drug
- 24 intoxication, although there may be evidence of a seizure.
- 25 (3) All autopsies conducted in this state must include an
- 26 inquiry to determine whether the death was a direct result of a
- 27 seizure or epilepsy. If the findings in an autopsy of a medical
- 28 examiner, examining physician or coroner are consistent with known
- 29 or suspected sudden unexpected death in epilepsy, then the medical
- 30 examiner, examining physician or coroner must:
- 31 (a) Cause to be indicated on the death certificate that
- 32 SUDEP is the cause or suspected cause of death; and
- 33 (b) Forward a copy of the death certificate to the
- 34 North American SUDEP Registry at the Langone Medical Center at New
- 35 York University within thirty (30) days.
