HOUSE BILL NO. 1035 (As Sent to Governor)

AN ACT TO REQUIRE THE COMMISSION ON WILDLIFE, FISHERIES AND 2 PARKS TO ESTABLISH AND REGULATE SPECIAL HUNTS DURING VELVET 3 HUNTING SEASON; TO PROVIDE THAT VELVET HUNTING SEASON SHALL BEGIN ON SEPTEMBER 10 AND END SEPTEMBER 20; TO REQUIRE THE COMMISSION TO 5 ESTABLISH A SPECIAL HUNTING PERMIT FOR VELVET HUNTING SEASON; TO 6 AMEND SECTION 49-7-31, MISSISSIPPI CODE OF 1972, WHICH RELATES TO 7 OPEN SEASON ON DEER, TO REQUIRE THE COMMISSION TO ESTABLISH AND REGULATE SPECIAL HUNTS DURING VELVET HUNTING SEASON; AND FOR 8 9 RELATED PURPOSES.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 SECTION 1. (1) The Mississippi Commission on Wildlife,
- 12 Fisheries and Parks shall establish and regulate special hunts
- 13 during velvet hunting season, outside of the regular open season
- 14 on deer. Velvet hunting season shall begin on September 10, and
- 15 end no later than September 20, and shall be for no less than
- 16 three (3) consecutive days in length, and for no more than five
- 17 (5) consecutive days in length, and only hunting with bow and
- 18 arrow or crossbows shall be allowed during such season. The
- 19 special season shall be open on private lands and any Wildlife
- 20 Management Areas as deemed appropriate by the department. Only
- 21 bucks that meet the antler criteria for the respective deer

- 22 management unit may be harvested. There shall be mandatory
- 23 reporting of the harvested animal.
- 24 (2) The commission shall establish a special hunting permit
- 25 for velvet hunting season. Such special hunting permit for velvet
- 26 hunting season shall be authorized for a time period beginning on
- 27 September 10, and ending no later than September 20, and shall be
- 28 valid for no less than three (3) consecutive days in length, and
- 29 for no more than five (5) consecutive days in length. The
- 30 commission shall, set the cost of permits.
- 31 **SECTION 2.** Section 49-7-31, Mississippi Code of 1972, is
- 32 amended as follows:
- 49-7-31. (1) The open season on deer shall be as follows:
- 34 (a) With bow and arrow: October 1 through the Friday
- 35 prior to Thanksgiving.
- 36 (b) With guns and with dogs: from the Saturday prior
- 37 to Thanksgiving through December 1.
- 38 (c) With primitive weapons and without dogs: December
- 39 2 through December 15.
- 40 (d) With guns and without dogs: December 16 through
- 41 December 23. However, the commission may allow hunting statewide
- 42 or in specific areas with any legal weapon which it may designate
- 43 without dogs after the end of the last season for hunting deer
- 44 with guns and with dogs, but the season with legal designated
- 45 weapons and without dogs shall not extend beyond January 31.

47 with primitive weapons and bow and arrow without dogs from February 1 through February 15 for the area south of U.S. Highway 48 84 and east of Mississippi Highway 35 only for legal bucks. 49 50 antlered deer taken in this area during any open season under this 51 section must be a legal buck as defined in this paragraph. purposes of this paragraph, the term "legal buck" means a deer 52 53 with antlers of four (4) points or more with a minimum inside 54 spread of ten (10) inches or a minimum main beam length of 55 thirteen (13) inches. The commission may regulate the taking of deer with antlers of four (4) points or less under this paragraph 56 57 for the proper management of antlered deer. The commission may 58 delay the opening date and change the length of bow and arrow 59 season in paragraph (a) in this area.

The commission shall establish an extended season

- (f) With guns and with dogs: December 24 through a
 date fixed by the commission that will provide a total of
 thirty-nine (39) days of hunting deer with guns and with dogs when
 added to the number of days provided for hunting deer with guns
 and with dogs in paragraph (b).
- (g) When the open season on deer ends on a Friday, the commission shall have the authority to extend the season until thirty (30) minutes after sunset on the following Sunday.
- 68 (2) The commission may set and regulate the deer seasons on 69 wildlife management areas which it administers.

- 71 antlerless deer in the districts or zones upon the recommendation
- 72 of the executive director based upon good and substantial
- 73 quantitative data and research evaluations that demonstrate that
- 74 the harvesting is necessary to properly manage the herd.
- 75 (b) The commission, only upon the recommendation of the
- 76 executive director, may allow the harvesting of antlerless deer
- 77 during the deer season with guns and with dogs by a majority vote
- 78 of the commission.
- 79 (c) Nothing in this subsection prohibits the harvesting
- 80 of either-sex deer by landowners or leaseholders on private lands
- 81 under the deer management assistance program prescribed or
- 82 approved by the executive director.
- 83 (4) The commission may provide a special permit for the
- 84 harvesting of deer when they are depredating and destroying crops.
- 85 The department shall supervise the harvesting and provide for the
- 86 salvaging of the meat of the animals. The commission may
- 87 authorize the department to assist any farmer in this state, who
- 88 sustains crop damage by wildlife, in eradication of the problem
- 89 wildlife.
- 90 (5) (a) During any open season on deer with primitive
- 91 weapons after November 30, a person may use any legal weapon of
- 92 choice on private lands only, if the person is:
- 93 (i) The title owner of the land;
- 94 (ii) The lessee of the hunting rights on the land;

95	(iii) A member of a hunting club leasing the
96	hunting rights on the land; or
97	(iv) A guest of a person specified in subparagraph
98	(i), (ii) or (iii).
99	(b) If the person is required to have a hunting
100	license, the person must have a primitive weapon license,
101	Sportsman's License or a Lifetime Sportsman's License.
102	(6) The commission shall establish and regulate special
103	hunts during velvet hunting season, outside of the regular open
104	season on deer, as provided in Section 1 of this act.
105	SECTION 3. This act shall take effect and be in force from
106	and after July 1, 2022.
