61 It is the intent of the Legislature that any state funds made 62 available for salaries of licensed personnel in excess of the 63 funds paid for such salaries for the 1986-1987 school year shall 64 be paid to licensed personnel pursuant to a personnel appraisal 65 and compensation system implemented by the State Board of Education.
