HOUSE BILL NO. 1320  
(As Passed the House)

1 AN ACT TO AMEND SECTION 49-15-79, MISSISSIPPI CODE OF 1972,  
2 TO PROVIDE THAT IT IS UNLAWFUL FOR ANY PERSON, FIRM OR CORPORATION  
3 TO USE OR ATTEMPT TO USE A PURSE SEINE FOR THE TAKING OF FISH OR  
4 TO HAVE SUCH SEINE IN THE WATER WITHIN ONE MILE OF THE SHORELINE  
5 OF JACKSON COUNTY, MISSISSIPPI AND WITHIN ONE MILE OF THE  
6 SHORELINE OF CAT ISLAND; TO REPEAL SECTION 49-15-35, MISSISSIPPI  
7 CODE OF 1972, WHICH PROVIDES THAT THE COMMISSION MAY ADOPT  
8 ORDINANCES PROHIBITING THE TAKING AND CATCHING OF MENHADEN WITHIN  
9 CERTAIN LIMITS; TO BRING FORWARD SECTION 49-15-78, MISSISSIPPI  
10 CODE OF 1972, WHICH PROVIDES FOR THE USE OF A GILL NET, TRAMMEL  
11 NET, ENTANGLEMENT NET, OR LIKE CONTRIVANCES, FOR THE PURPOSE OF  
12 POSSIBLE AMENDMENT; AND FOR RELATED PURPOSES.

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

14 **SECTION 1.** Section 49-15-79, Mississippi Code of 1972, is  
15 amended as follows:

16 49-15-79. (1) It is unlawful for any person, firm or  
17 corporation to use or attempt to use a purse seine for the taking  
18 of fish or to have such seine in the water within one (1) mile of  
19 the shoreline of the County of Hancock or Harrison in the State of  
20 Mississippi. It is unlawful for any person, firm or corporation  
21 to use or attempt to use a purse seine for the taking of fish or  
22 to have such seine in the water within one (1) mile of the  
23 shoreline of Cat Island and the shoreline of the County of Jackson



24 in the State of Mississippi. The Boards of Supervisors of  
25 Hancock, Harrison and Jackson Counties shall have the authority to  
26 submit proposed regulations to the commission to regulate within  
27 their respective counties the use of \* \* \* trammel nets. The  
28 commission may consider all such proposals submitted by the boards  
29 of supervisors in formulating regulations to be promulgated under  
30 this section.

31 (2) A person, firm or corporation convicted of a violation  
32 of this section or regulations promulgated under this section  
33 shall be punished by the penalties provided in Section  
34 49-15-100(2) \* \* \*.

35 **SECTION 2.** Section 49-15-35, Mississippi Code of 1972, which  
36 provides that the commission may adopt ordinances prohibiting the  
37 taking and catching of menhaden within certain limits of the coast  
38 line of the county so requesting, but the commission shall not fix  
39 such limits except upon request of the board of supervisors, and  
40 such limit shall not exceed two (2) miles from the shore line, or  
41 two (2) miles from the corporate limit boundaries of any  
42 municipality bordering on the Mississippi Sound, is repealed.

43 **SECTION 3.** Section 49-15-78, Mississippi Code of 1972, is  
44 brought forward as follows:

45 49-15-78. (1) (a) It is unlawful for a person to use a  
46 gill net, trammel net, entanglement net, or like contrivances for  
47 the taking of finfish in marine waters within one-half (1/2) mile  
48 of the shoreline.



49           (b) For the purposes of this section, the phrase "like  
50 contrivances" means any net that is similar in form, function,  
51 purpose or use to a gill net, trammel net or entanglement net.

52           (c) It is unlawful for a person to use a haul seine net  
53 for the taking of fish in marine waters within one-half (1/2) mile  
54 of the shoreline of Cat Island.

55           (d) The provisions of this section shall not apply to  
56 hand seines, cast nets or brill nets.

57           (2) A violation of this section is punishable by the  
58 penalties provided in Section 49-15-100.

59           **SECTION 4.** This act shall take effect and be in force from  
60 and after July 1, 2022.
