HOUSE CONCURRENT RESOLUTION NO. 71

1	A CONCURRENT RESOLUTION RECOGNIZING AND ACKNOWLEDGING
2	INTERNATIONAL WOMEN'S MONTH AND DESIGNATING THE MONTH OF MARCH
3	2022 AS THE PERIOD OF OBSERVATION AND CELEBRATION THROUGHOUT THE
4	STATE OF MISSISSIPPI.

- 5 WHEREAS, the State of Mississippi joins the global community
- 6 in acknowledging the importance of women and the significantly
- 7 profound contributions and advancement womankind has made to
- 8 society, by standing in solidarity to observe International
- 9 Women's Day on March 8, 2022, and International Women's Month
- 10 throughout the month of March; and
- 11 WHEREAS, it has been stated by United Nations Educational,
- 12 Scientific and Cultural Organization (UNESCO) that "International
- 13 Women's Day is an occasion to celebrate the progress made towards
- 14 achieving gender equality and women's empowerment but also to
- 15 critically reflect on those accomplishments and strive for a
- 16 greater momentum towards gender equality worldwide. It is a day to
- 17 recognize the extraordinary acts of women and to stand together,
- 18 as a united force, to advance gender equality around the world";

20	WHEREAS, birthed out of a movement of the Socialist Party of
21	America, which dedicated a day in February to honor the 1908
22	women's garment workers strike in New York in protest against
23	harsh labor conditions, the conceptualized observations of
24	International Women's Day first emerged in 1909; and
25	WHEREAS, in 1945, the Charter of the United Nations became
26	the first international agreement to affirm the principle of
27	equality between men and women, and 30 years subsequent thereto,
28	the United Nations celebrated its first official International
29	Women's Day during International Women's Year in 1975; and
30	WHEREAS, International Women's month, also known as Women's
31	History month, began as a local celebration in Santa Rosa,
32	California, through grassroots galvanization of the Education Task
33	Force of the Sonoma County Commission on the Status of Women,
34	which planned and executed a "Women's History Week" celebration in
35	1978, by selecting the week of March 8th to correspond with
36	International Women's Day; and
37	WHEREAS, gaining momentum, the movement spread across the
38	country as many communities implemented acknowledging celebration,
39	and in 1980, many women's groups and historians led by the
40	National Women's History Project now known as the National Women's
41	History Alliance, successfully lobbied for recognition, which
42	resulted in President Jimmy Carter's issuance of the first
43	Presidential Proclamation declaring the week of March 8th as

National Women's History week; and

45 WHEREAS, in 1987, seven years after the first official acknowledgement by a national official, Congress passed Public Law 46 100-9, designating March as "Women's History Month"; and 47 WHEREAS, in keeping the spirit of excellence from which this 48 49 international observance has blossomed, the National Women's 50 History Alliance selects an annual theme to highlight the significance of the cause, and this year's theme, "Women Providing 51 Healing, Promoting Hope," is a tribute to all caregivers and front 52 53 line workers as the pandemic continues, as well as in general, for 54 all women who have provided healing and hope in numerous ways 55 throughout history; and 56 WHEREAS, it is the policy of this Legislature to lend its 57 unwavering support to the remarkable women who have and continue to make great strides toward advancing the mission of gender 58 59 equality and women's empowerment around the world: 60 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF 61 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That we do hereby recognize and acknowledge International 62 63 Women's Month and designate the month of March 2022 as the period 64 of observation and celebration throughout the State of 65 Mississippi.
