## HOUSE CONCURRENT RESOLUTION NO. 76

1 A CONCURRENT RESOLUTION COMMENDING THE MISSISSIPPI HIGH 2 SCHOOL ACTIVITIES ASSOCIATION FOR ITS OUTSTANDING ACCOMPLISHMENTS 3 AND COMMEMORATING ITS CENTENNIAL ANNIVERSARY.

4 WHEREAS, the Mississippi High School Activities Association (MHSAA) was formed in 1922 to serve member schools by providing 5 leadership and coordination of interscholastic activities 6 enhancing the educational experiences of secondary students and 7 8 reducing the risks of their participation; and 9 WHEREAS, the MHSAA promotes participation and sportsmanship to develop good citizens through interscholastic activities which 10 11 provide equitable opportunities, positive recognition and learning experiences to students while maximizing the achievement of 12 13 educational goals; and 14 WHEREAS, the MHSAA is a member of the National Federation of State High School Associations (NFHS), which consists of 50 15 16 individual state high school athletics and/or activities 17 associations united to secure the benefits of cooperation and increased efficiency through the coordination of ideas of all who 18

19 are engaged in high school athletics and activities programs 20 throughout the nation; and

21 WHEREAS, the MHSAA works with school leaders statewide for 22 the administration of education-based high school athletics and 23 activities through the writing of playing rules that emphasize 24 health, safety and educational programs that increase 25 participation opportunities and promote sportsmanship; and

26 WHEREAS, through the efforts of the MHSAA and its member 27 schools, Mississippi is recognized nationally for its athletics 28 and activities programs and the young people who ascend to 29 represent Mississippi in both college and professional sports; and

30 WHEREAS, it is the policy of this Legislature to recognize 31 the steadfast diligence of such reputable organizations such as 32 the MHSAA, which strives to encourage student participation and 33 promote excellence through superior performance in extracurricular 34 activities through academics, athletics and the arts:

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That we do hereby congratulate the Mississippi High School Activities Association on the centennial anniversary of its founding and extend best wishes for continued success in its future.
