HOUSE CONCURRENT RESOLUTION NO. 79

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING MRS.

2 MILLICENT "MANDY" GUNTER OF BAYOU VIEW ELEMENTARY SCHOOL IN

3 GULFPORT, MISSISSIPPI, FOR RECEIVING MISSISSIPPI'S 2020

4 PRESIDENTIAL AWARD FOR EXCELLENCE IN MATHEMATICS AND SCIENCE

5 TEACHING.

6 WHEREAS, Mrs. Millicent "Mandy" Gunter is one of two

7 Mississippi teachers who earned national recognition as recipients

8 of the 2020 Presidential Awards for Excellence in Mathematics and

9 Science Teaching (PAEMST); and

10 WHEREAS, established in 1983, PAEMST is the highest award

11 kindergarten through 12th grade mathematics and science (including

12 computer science) teachers can receive from the United States

13 government, and each year, the award criteria alternates years

14 between kindergarten through sixth grade and seventh through 12th

15 grade teachers, and this year, kindergarten through sixth grade

16 teachers received the awards; and

17 WHEREAS, over the years, PAEMST award recipients represent

18 schools and organizations from all 50 states, Washington D.C.,

- 19 Puerto Rico, Department of Defense Education Activity (DODEA)
- 20 schools, and the U.S. territories; and
- 21 WHEREAS, PAEMST nominees complete a rigorous application
- 22 process that allows them to demonstrate deep content knowledge and
- 23 their ability to adapt to a broad range of learners and teaching
- 24 environments, and a panel of distinguished mathematicians,
- 25 scientists and educators at the state and national levels assess
- 26 the applications before recommending nominees to the White House
- 27 Office of Science and Technology Policy (OSTP), then teachers are
- 28 selected based on their distinction in the classroom and
- 29 dedication to improving STEM education; and
- 30 WHEREAS, Mrs. Gunter has been an educator for more than 30
- 31 years, and has spent the last 18 years teaching in the Gulfport
- 32 School District, and she is currently teaching all subjects in
- 33 third grade at Bayou View Elementary School, and prior to joining
- 34 Bayou View, taught at Westminster Academy for ten years and
- 35 Diamondhead Academy for the first two years of her teaching
- 36 career; and
- 37 WHEREAS, in her classroom, Mrs. Gunter challenges students to
- 38 explore problem-based mathematics, motivates students to become
- 39 problem solvers, incorporates real-world scenarios and implements
- 40 mathematical discourse to promote deeper student thinking, and her
- 41 classroom is an active learning environment where technology is
- 42 incorporated into her daily lessons; and

- WHEREAS, in addition to teaching third grade, Mrs. Gunter
- 44 also serves as the K-5 mathematics coach, and as a lead teacher,
- 45 she facilitates professional development for teachers, continues
- 46 to build a site level collaborative mathematics team, mentors
- 47 student teachers, monitors site level mathematics programs, plans
- 48 activities to celebrate student success and orchestrates family
- 49 math night; and
- 50 WHEREAS, Mrs. Gunter has served on several district and state
- 51 committees, and she has been able to implement programs and
- 52 enhance curriculum from the knowledge gained from the numerous
- 53 national conferences she has attended, including: NCTM, Model
- 54 Schools, the Ron Clark Academy and Staff Development for
- 55 Educators; and
- 56 WHEREAS, dedicated to academic excellence, Mrs. Gunter is a
- 57 1984 graduate of Saint John High School in Gulfport, and she
- 58 earned a bachelor's degree in elementary education from the
- 59 University of Southern Mississippi in 1990, and a master's degree
- 60 in curriculum and instruction from Mississippi College in 2020,
- 61 and she also has a highly qualified status in mathematics from
- 62 Mississippi State University; and
- 63 WHEREAS, for excellence in education, Mrs. Gunter received
- 64 the Hannah Hatfield award for 2006, and she received Teacher of
- 65 the Year in 2000, 2004, 2011, and 2016; and
- 66 WHEREAS, Mrs. Gunter is married to her loving husband of 30
- 67 years, Mr. Edward Gunter, and they have a daughter, Haley Gunter,

- 68 who is also a teacher in the Gulfport School District, and in her
- 69 spare time she enjoys walking and gardening and is a member of
- 70 First Presbyterian Church in Gulfport; and
- 71 WHEREAS, Mrs. Gunter stated, "Being named a finalist for the
- 72 Presidential Award has been a truly humbling experience. I am
- 73 extremely grateful for teachers and colleagues who have mentored
- 74 and encouraged me throughout my journey of teaching. This award
- 75 recognizes my commitment to providing the best mathematics
- 76 instruction I can for my students, and it is rewarding to know
- 77 that I have had an impact on their success. This award inspires me
- 78 to continue to search for best practices in education and
- 79 implement them with intention."; and
- 80 WHEREAS, it is the policy of this Legislature to recognize
- 81 and commend outstanding Mississippi teachers, especially those
- 82 such as Mrs. Gunter, whose dedication to her students brings great
- 83 honor to Bayou View Elementary School, the Gulfport School
- 84 District and the State of Mississippi:
- 85 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
- 86 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, THE SENATE CONCURRING
- 87 THEREIN, That we do hereby commend and congratulate Mrs. Millicent
- 88 "Mandy" Gunter of Bayou View Elementary School in Gulfport,
- 89 Mississippi, for receiving Mississippi's 2020 Presidential Award
- 90 for Excellence in Mathematics and Science Teaching, and extend to
- 91 her our best wishes for continued excellence in education.
