- 4 WHEREAS, Mr. Royce Cumbest, a lifelong resident of Jackson
- 5 County, Mississippi, has devoted his life to serving and improving
- 6 the State of Mississippi through not only his professional
- 7 contributions but also his service as a member of the Jackson
- 8 County Economic Development Foundation; and
- 9 WHEREAS, the son of the late Lum R. Cumbest, Sr., and the
- 10 late Mae Holder Cumbest, Mr. Royce Cumbest was educated at East
- 11 Central High School, Millsaps College and the University of
- 12 Southern Mississippi, and he has worked in the banking and finance
- 13 industry since 1971, joining Merchants and Marine Bank in 1977 as
- 14 vice president; and
- 15 WHEREAS, in March 1985, Mr. Cumbest was elected president and
- 16 CEO of Merchants and Marine Bank, and in 1991, he became chairman
- 17 of the board of directors and still serves in that position; and

- 18 WHEREAS, Mr. Cumbest was chosen to serve on Mississippi
- 19 Power's board of directors in 2010, and he currently serves as the
- 20 chairman and director of the Jackson County Economic Development
- 21 Foundation: and
- 22 WHEREAS, after Hurricane Katrina, Mr. Cumbest co-chaired
- 23 Rebuild Jackson County, served as a board member of the
- Mississippi Hurricane Recovery Fund and of the Governor's 24
- 25 Hurricane Relief "Mississippi Rising" concert program, and in
- 26 2006, he was named one of south Mississippi's outstanding
- 27 community leaders; and
- 28 WHEREAS, throughout his professional career, and continuing
- 29 today, Mr. Cumbest has been active in community, state and
- national affairs, as he is one of the founders of the Jackson 30
- 31 County Economic Development Foundation (JCEDF), has served on its
- 32 board since 2000, and today serves as Chairman of the Foundation's
- 33 Board of Directors; and
- WHEREAS, for over four decades, Mr. Cumbest has dedicated his 34
- 35 time and talents to improving the quality of lives for countless
- 36 Mississippians and played an instrumental role in the effort to
- 37 transform the JCEDF into what is now widely regarded as a model of

- Mississippi, and in 2002, he served in a leadership role for the 39
- 40 JCEDF's first Partners in Progress capital campaign which raised
