HOUSE RESOLUTION NO. 54

1 A RESOLUTION RECOGNIZING THE OUTSTANDING LEGACY AND CIVIC
2 CONTRIBUTIONS OF LINDA ROSS ALDY, C.A.E., UPON THE OCCASION OF HER
3 RETIREMENT AFTER 16 YEARS OF EFFECTIVE SERVICE AS EXECUTIVE
4 DIRECTOR OF THE MISSISSIPPI OPTOMETRIC ASSOCIATION.

5 WHEREAS, Linda Ross Aldy began overseeing the operations of
6 the Mississippi Optometric Association (MOA) as its Executive
7 Director in 2005 and was only the third executive director in its
8 history, having served in that role for 16 years, and she
9 officially retired from the association on December 31, 2021; and

10 WHEREAS, her professional activities and associations are a
11 matter of record:

12 • She is a recent recipient of the Virgil Deering Optometric
13 Executive Director Award, which is presented annually to an
14 outstanding State Optometric Executive Director, recognizing the
15 dedicated, capable leadership and support that State Optometric
16 Associations receive from their executive directors;

17 • She served on the faculty of the State of Mississippi's
18 Personnel Board Training Division;



19 • She is a graduate of and advisor to Mississippi Economic
20 Development's Leadership Mississippi Program, the nation's second
21 oldest state leadership program;

22 • She has served on the advisory board for the Hayes Center
23 for Practice Excellence at Southern College of Optometry in
24 Memphis, Tennessee, and on the executive board of the
25 International Association of Optometric Executives, eventually
26 serving as president;

27 • She earned the Certified Association Executive designation
28 through the American Society of Association Executives;

29 • She is a former member of the Board of Directors for the
30 Mississippi Society of Association Executives and continues to be
31 actively involved in the organization;

32 • She has also served as a member of the Board of Directors
33 for the Mississippi Nurses' Foundation and is a past-president of
34 the National Alumni Association of the Mississippi University for
35 Women;

36 • She and her family own and operate three Cups coffee shop
37 franchises in the Jackson, Mississippi, metro area with two more
38 shops scheduled to open soon; and

39 WHEREAS, she has been named as one of Mississippi's "50
40 Leading Businesswomen" in recognition of her accomplishments as an
41 author, former newspaper reporter, editor and television host; and

42 WHEREAS, she is a cum laude graduate of Mississippi
43 University for Women, the Stennis Center Executive Management



44 Institute and has completed coursework through the University of
45 Pennsylvania, Wharton School of Business, Executive Development
46 Program; and

47 WHEREAS, she is a former State Agency Director, having served
48 as Executive Director of what is now the Mississippi Department of
49 Employment Security, and she has worked for two Mississippi
50 Governors; and

51 WHEREAS, during her tenure as Executive Director of the MOA,
52 Mrs. Aldy was particularly successful in hosting an annual
53 reception for the members of the Legislature, which took place at
54 the old Denney's Restaurant, in conjunction with the annual
55 meeting of the MOA, which provided members an excellent
56 opportunity to discuss important practice issues with the policy
57 makers; and

58 WHEREAS, Mrs. Aldy is the daughter of the late Mr. Richard
59 Ross, former District 4 Supervisor of Yalobusha County, and Mrs.
60 Margaret Jean Ross, matriarch of Oakland, Mississippi, supporter
61 of the development and progress of the Town of Oakland, and a
62 shining example and role model for her daughter; and

63 WHEREAS, she was instrumental in establishing the Chamber of
64 Commerce for Yalobusha County, offering great assistance to the
65 place she was born and raised, and she continues to offer such
66 great support; and

67 WHEREAS, it is the policy of the House of Representatives to
68 commend a most public-spirited citizen of Mississippi whose



69 professional accomplishments and effective leadership have brought
70 honor to the practice of optometry and to the State of
71 Mississippi:
