HOUSE RESOLUTION NO. 55

1 A RESOLUTION HONORING THE LIFE AND LEGACY OF DR. GUSTAVUS
2 ADOLPHUS "SONNY" RUSH III AND EXPRESSING DEEPEST SYMPATHY TO HIS
3 FAMILY AND FRIENDS UPON HIS PASSING.

4 WHEREAS, it is written in Ecclesiastes 3:1 that "To
5 everything there is a season, and a time for every purpose under
6 the Heaven," and as such, on August 20, 2021, the immaculate
7 author and finisher of our soul's destiny summoned the mortal
8 presence of dearly beloved, Dr. G.A. "Sonny" Rush III, to eternal
9 rest, rendering great sorrow and loss to his family, friends and
10 community; and

11 WHEREAS, born on September 29, 1952, in Meridian,
12 Mississippi, to Mr. Gustavus Adolphus Rush, Jr., and Mrs. Virginia
13 Arline Rush, Dr. Rush was a 1970 graduate of Meridian High School,
14 where he was class president, and after graduating high school, he
15 attended the University of Mississippi, where he was a member of
16 Phi Delta Theta fraternity, where he was fondly known as "The
17 Governor"; and



18 WHEREAS, Dr. Rush received his Doctorate of Medicine at
19 University of Mississippi Medical Center in Jackson, Mississippi,
20 in 1978, and then he completed his residency training in
21 orthopedic surgery and sports medicine in 1984, at Ochsner
22 Foundation Hospital in New Orleans, Louisiana, where he served as
23 Chief Orthopedic Resident; and

24 WHEREAS, after completing his residency, Dr. Rush joined Rush
25 Foundation Hospital, where he spent the entirety of his
26 outstanding 38-year career as a third generation of Rush
27 physicians, and during this time, he improved and enriched the
28 lives of countless patients and friends, performed over 20,000
29 surgeries during his career, and had many other tremendous work
30 accomplishments; and

31 WHEREAS, Dr. Rush was instrumental in founding the Rush
32 Orthopedic Program at Rush Hospital, and in 1987, he founded the
33 Rush Sports Medicine Team, a group of orthopedic surgeons,
34 physical therapists, and athletic trainers who supported over 40
35 local high schools and colleges in Mississippi and West Alabama,
36 and in 1992, he founded Rush Sports Medicine Research and
37 Development, and as he was inspired by his desire to protect young
38 athletes, he patented several cutting-edge technologies such as
39 protective helmets and concussion sensors; and

40 WHEREAS, "Dr. Sonny," as he was affectionally known by his
41 patients, treated work like a blessing, none of it like a chore,
42 and to him, being a doctor was every bit as fun and enjoyable as



43 his hobbies, and it is no coincidence that he routinely had clinic
44 on late Friday afternoons because he loved taking care of
45 patients, and his life was firmly dedicated to that; and

46 WHEREAS, as the true measure of the eternal impact that he
47 made in this world may never be known, Dr. Rush dedicated his life
48 to serving others, and as he was not only a beloved physician to
49 his patients, but also a wonderful friend, and his faithful
50 service in the medical community will continue to be an
51 inspiration that will surely provide a road map for others to
52 imitate for years to come; and

53 WHEREAS, for a sports medicine doctor, Dr. Rush achieved a
54 Hall of Fame career, yet his career achievements in medicine paled
55 in comparison to his achievements as a family man, a Christian,
56 and a friend, and despite his busy schedule, his priorities were
57 never in question as he prioritized family and faith above all
58 else, and was adored by his five children and his wife of 40
59 years, Karen; and

60 WHEREAS, "Pops," as he was lovingly known by his five
61 children and seven grandchildren, epitomized the ideal father and
62 grandfather, and as his enormous accomplishments were only matched
63 by his kindness and humility; and

64 WHEREAS, a genuine and distinguished man of outstanding
65 character, exceptional courage and strength beyond comparison, Dr.
66 Rush's devotion to his faith, his family, and to his community
67 will always be remembered, and precious memories of time spent



68 with him will hopefully continue to provide warmth, peace and
69 comfort to his loved ones until they are reunited with him in
70 Glory; and

71 WHEREAS, though he has traversed the river of life to reunite
72 with those who answered God's summons to life eternal and now
73 beckon his arrival to the celestial shores of Heaven's grandeur,
74 such as his parents, Mr. Gustavus Adolphus Rush, Jr., and Mrs.
75 Virginia Arline Rush, and his sister, Jeannine Rush Savell, the
76 legacy of Dr. Rush's indelible imprint upon our lives will
77 continue to refresh the hearts and fond memories of his loved
78 ones, including his wife, Mrs. Karen Rush, and his five children,
79 Heath Rush, Lane Rush, Alston Rush, Logan Rush and Callie Waite;
80 seven grandchildren, Lane Rush, Jr., Luke Rush, Ben Rush, Lillian
81 Rush, Henry Rush, Clara Jane Rush, and Drew Rush; siblings, Diane
82 Douglas and Harriette Carney; and a host of other relatives and
83 dear friends; and

84 WHEREAS, Dr. Rush will forever be loved, cherished and missed
85 by all who knew him, and since it is written in 2 Corinthians 5:8,
86 that to be "absent from the body is to be present with the Lord,"
87 his family and friends can find peace and comfort during this
88 difficult time, and undoubtedly know that he is shouting with joy
89 on the streets of gold with many jewels in his crown; and

91 recognize and commend the lives of extraordinary Mississippians,
92 especially those such as Dr. Rush, who truly inspired everyone he

96 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby
97 mourn the loss and commemorate the life and legacy of Dr. G.A.

99 family, friends and community upon his passing.
