HOUSE RESOLUTION NO. 67

1 A RESOLUTION COMMENDING THE CITY OF JACKSON AND RECOGNIZING  
2 AND SUPPORTING THE CELEBRATION OF ITS BICENTENNIAL.

3 WHEREAS, the City of Jackson is the Capital of Mississippi  
4 and holds within its borders a great deal of history, legacy, and  
5 culture; and

6 WHEREAS, the City of Jackson has many significant elements  
7 that draw in tourists and hold their hearts for years to come; and

8 WHEREAS, the city reaches its bicentennial of being  
9 incorporated for 200 years in the year 2022; and

10 WHEREAS, November 28, 1821, is the date that the State  
11 Legislature selected LeFleur's Bluff as the site of the seat of  
12 government of the State of Mississippi followed by the formal  
13 planning of the City of Jackson in April 1822, and most  
14 significantly, on December 23, 1822, the State Legislature  
15 established its seat by convening its first session in what we  
16 know now as the Capital City; and



17 WHEREAS, from November 29, 2021, through December 31, 2022,  
18 the City of Jackson marks a time of celebration for its historic  
19 establishment and reign as the capital; and

20 WHEREAS, the City of Jackson's Cultural Services Division and  
21 Visit Jackson have collaborated to create a bicentennial platform  
22 designed to welcome all ideas, celebrate all peoples, and lift our  
23 collective community through a host of exciting events and  
24 celebrations that incorporate themes of this remarkable  
25 celebration, and in doing so, the community and culture of  
26 the City of Jackson will be on full display; and

27 WHEREAS, the city's bicentennial celebration is diverse and  
28 inclusive as it aims to highlight Jackson's people, community,  
29 businesses, and events, and it is a celebration of where the city  
30 has come from, who the city is and where the city is headed; and

31 WHEREAS, it is the policy of the House of Representatives to  
32 commend historic milestone events of our primary city and seat of  
33 government, the City of Jackson:

34 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF  
35 REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we do hereby  
36 commend the City of Jackson and recognize and support the  
37 celebration of its bicentennial and express sincere wishes for  
38 continued success into the future.
