HOUSE RESOLUTION NO. 68

1 A RESOLUTION COMMENDING AND CONGRATULATING THE MIZE  
2 ATTENDANCE CENTER BULLDOGS VARSITY CHEER SQUAD AND COACH BROOKE  
3 KING FOR EARNING SECOND PLACE HONORS AT THE UNIVERSAL CHEERLEADERS  
4 ASSOCIATION'S NATIONAL HIGH SCHOOL CHEERLEADING COMPETITION.

5 WHEREAS, the Mize Attendance Center Bulldogs Varsity Cheer  
6 Squad's hard work and dedication over the past months has come to  
7 fruition as the squad performed exceptionally well, earning second  
8 place honors at Universal Cheerleaders Association's National High  
9 School Cheerleading Competition in Walt Disney World, Orlando,  
10 Florida, on February 11-12, 2022; and

11 WHEREAS, the team competed at the UCA Regional Competition on  
12 December 5, 2021, at the Jackson Convention Center and received  
13 first place as well as a bid to Nationals in Orlando, Florida; and

14 WHEREAS, Mize Cheerleaders, also the reigning Magnolia  
15 Regional Champions and Mississippi High School Activities  
16 Association (MHSAA) Class 1A/2A State Champions, performed their  
17 routine three times, advancing through preliminaries to top 18  
18 semi-finals, before taking the stage to compete against the final  
19 10 teams; and



20 WHEREAS, the cheerleaders competed against 34 teams from all  
21 over the nation in the Super Varsity Non-Tumbling Game Day  
22 Division in the ESPN Wide World of Sports Complex; and many of  
23 their competitors, including the previous and current national  
24 champions, are equivalent to the MHSAA Class 6A classification;
