## HOUSE RESOLUTION NO. 85

A RESOLUTION COMMENDING THE HONORABLE JUDGE DENISE OWENS FOR PROVIDING 33 YEARS OF EXEMPLARY SERVICE AS HINDS COUNTY DISTRICT 3 CHANCERY JUDGE, AND CONGRATULATING HER UPON RETIREMENT FROM THIS POSITION AFTER PROVIDING STELLAR JUDICIAL LEADERSHIP TO THE CITIZENS OF MISSISSIPPI.

6 WHEREAS, the Honorable Judge Denise Owens, the Senior

7 Chancellor for Hinds County Chancery Court, will lay down her

8 judicial gavel and retire as Chancellor for Hinds County District

9 3 at the end of her term in 2022, after passionately serving the

10 citizens of this great state for 33 years and creating a positive

11 impact in the lives of countless citizens of this state; and

12 WHEREAS, she is so well respected amongst her peer group of

13 Chancery Court judges that she has held leadership positions in

14 the Conference of Chancery Judges which is the governing body for

15 Mississippi's Chancery Judges since 1996, when she was elected

16 secretary, in 1998, when she was elected vice chair and program

17 chairperson in 1998 and 2000, and where she served as Conference

18 Chair for two years; and

19	WHEREAS, she began her legal career in 1979, when she earned
20	her Juris Doctorate from George Washington University, in
21	Washington, D.C., and worked for two years as a law clerk at the

22 Washington, D.C. Legal Services Elder Law Clinic; and

23 WHEREAS, after being admitted to The Mississippi Bar, this

24 tenacious young lawyer landed her first Mississippi job as a staff

25 attorney for Central Mississippi Legal Services in Jackson,

26 Mississippi, where she worked hard to address the legal needs of

27 those who are traditionally underserved; and

28 WHEREAS, she ventured out to private legal practice in 1983,

29 by working as an associate attorney with The Law Firm of Owens and

30 Byrd, where she continued to hone her legal skills and caught the

31 attention of the mayor of Jackson, Mississippi, who was so

32 impressed by her legal acumen, that she was appointed to work as

33 the Assistant City prosecutor from 1983 through 1986, while she

34 still worked as an associate lawyer at the law firm; and

35 WHEREAS, she parted ways with the city in 1986 upon earning

the titles of partner and managing attorney for The Law Firm of

37 Owens and Owens; and

38 WHEREAS, Judge Owens has been and continues to be a legal

39 scholar, as evidenced by her other accomplishments in the world of

40 legal academia, such as graduating from the Court Practice

41 Institute in Chicago, Illinois, and completing advanced judicial

42 studies at both the National Judicial College in Reno, Nevada, and

43 the College of Business Court Judges; and

44	WHEREAS, Judge Owens is very passionate about educating the
45	next generation of lawyers and has spent countless hours
46	throughout her career serving in various academic leadership
47	roles, such as working as a pre-law program advisor and adjunct
48	professor at Tougaloo College, sponsoring Tougaloo College's
49	Pre-Law Society, and teaching paralegal technology at Hinds
50	Community College to nurture the next generation of legal
51	scholars, in order to impart wisdom in the minds of young people;
52	and
53	WHEREAS, since her days at legal services, she has continued
54	her efforts to use her position to improve the quality of life for
55	others by financially sponsoring legal education programs for law
56	students and young attorneys, working with the National
57	Association of Women Judges to present the Color of Justice, an
58	annual program which introduces young female students to careers
59	as lawyers and judges, serving on the Board of the Council of
60	Legal Education Opportunity (CLEO) to increase diversity on the
61	bench and bar by promoting interest in careers in law, and
62	organizing a law camp to reach girls, ages 12 to 15, to encourage
63	them to pursue law as a career, and increase their self-esteem and
64	awareness, and sitting on the Task Force on Gender Fairness and
65	the Gender Fairness Advisory Study Committee which seeks to level
66	the playing field on issues of gender fairness by educating the
67	judicial bench, The Mississippi Bar and the public about the
68	importance of gender fairness: and

69	WHEREAS, Judge Owens' ability to work toward and attain
70	positive results for the underserved has garnered so much respect
71	from her colleagues that she has held numerous leadership roles in
72	philanthropic organizations, including the Access to Justice
73	Commission for the last 10 years, where she is co-chair and helps
74	to guide the organization, formulate recommendations implemented
75	by the Mississippi Supreme Court, and create strategies to make
76	the courts accessible to all people; and
77	WHEREAS, Judge Owens' fervent advocacy skills have resulted
78	in earning her prestigious appointments from the State Supreme
79	Court to the States' Pro Se Task Force, the Gender Bias Task
80	Force, the Race and Ethics Bias Task Force, the Mississippi
81	Delivery of Legal Services State Planning Board where she also
82	served as chair, and has completed her three-year term as
83	representative from the College of Business Court Judges to the
84	American Bar Association Corporate and Litigation Committee.
85	WHEREAS, Judge Owens' professional associations and
86	activities include membership in the Mississippi Bar Association,
87	the Mississippi Bar Foundation, the National Association of Women
88	Judges, the Magnolia Bar Association, Member of the American Bar
89	Association's Judicial Division, The American Trial Lawyers
90	Judicial Division, The National Bar Association's Judicial
91	Division, The Magnolia Bar Association Judicial Division, American
92	Bar Association (Corporate and Litigation Committee): and

93	WHEREAS, not surprisingly, Judge Owens' reputation of
94	impressive legal prowess coupled with high moral character have
95	gained her an impressive list of awards, such as the 2016 Susie
96	Blue Buchanan Award which is a prestigious award presented
97	annually by The Mississippi Bar's Women in the Profession
98	committee to honor an outstanding woman lawyer who has achieved
99	professional excellence and has actively paved the way to success
100	for other women lawyers, and in 2019, the Judicial Excellence
101	Award at the upcoming Mississippi State Bar meeting; and
102	WHEREAS, throughout all of her endeavors, she has enjoyed the
103	love and support of her husband of 41 years, Bob, and their four
104	children Selika, Bobby, Brittany and Jason, and upon her
105	retirement, she will bask in the adoration and affection of her
106	grandchildren; and
107	WHEREAS, it is the policy of the House of Representatives to
108	honor the extraordinary career and amazing philanthropy of elected
109	officials, such as Judge Denise Owens, who have blazed a
110	progressive trail for future generations of lawyers and other
111	professionals, affirmatively impacts the quality of life for
112	underserved citizens and lives a life built on justice in and out
113	of the courtroom:
