HOUSE RESOLUTION NO. 122

1 A RESOLUTION COMMENDING AND EXPRESSING APPRECIATION TO DR. 2 THOMAS DOBBS FOR HIS INVALUABLE SERVICE FOR THE PEOPLE OF THE 3 STATE OF MISSISSIPPI DURING HIS TIME AS STATE HEALTH OFFICER, ESPECIALLY FOR STEADFASTLY LEADING THE STATE THROUGH THE DAUNTING 5 CHALLENGES OF THE COVID-19 PUBLIC HEALTH CRISIS. 6 WHEREAS, Dr. Thomas Dobbs, Mississippi's State Health 7 Officer, recently announced that he will be resigning from that 8 position at the end of July of this year after leading the State Department of Health through one of the most difficult and

11 WHEREAS, a native of Haleyville in northwest Alabama, Dr.

challenging periods in the agency's history; and

12 Dobbs went east to Atlanta to get a Bachelor of Science degree in

13 applied physics from Emory University in May 1992, then returned

14 to Alabama where he earned a Doctor of Medicine degree from the

15 University of Alabama at Birmingham (UAB) in May 1996 and a Master

16 of Public Health degree in epidemiology from UAB in May 2000, and

17 completed an internal medicine residency program at UAB in June

18 2000, and he is board certified in both internal medicine and

19 infectious diseases; and

20	WHEREAS, Dr. Dobbs worked as an internal medicine and
21	infectious disease physician in Laurel and Hattiesburg before
22	beginning his career at the Department of Health in 2008, where he
23	served in numerous roles, including District Health Officer for
24	Districts 7 and 8 from July 2008 to July 2012, State
25	Epidemiologist from August 2012 to September 2016, state TB
26	consultant in 2009, and infectious disease consultant from
27	September 2016 to the present; and
28	WHEREAS, after working as Chief Medical Officer and Vice
29	President for Quality at South Central Regional Medical Center in
30	Laurel from September 2016 to June 2018, Dr. Dobbs returned to the
31	Department of Health to serve as Deputy State Health Officer from
32	July 2018 to December 2018, when he was appointed by the State
33	Board of Health to head the agency as State Health Officer; and
34	WHEREAS, Dr. Dobbs had only been State Health Officer for a
35	little more than a year when he was abruptly thrust into dealing
36	with the greatest public health crisis of our generation and this
37	century as the novel coronavirus that causes COVID-19 spread
38	unchecked across the globe in a worldwide pandemic and arrived in
39	Mississippi in March 2020 and began rapidly infecting, sickening,
40	hospitalizing and killing our citizens; and
41	WHEREAS, Dr. Dobbs had to deal with the enormous and
42	ever-increasing stress and strain on the state's health care
43	system with diminished resources at the Department of Health as
44	COVID-19 cases ran rampant and hospitals overflowed, which

45	threatened to totally overwhelm hospitals and health care
46	providers, and he led a team of professionals who quickly
47	developed a plan to combat the dire consequences of the pandemic,
48	lessen the severity of its massive impact on the health care
49	system and the people of the state, and confront the numerous
50	logistical and messaging challenges of the pandemic; and
51	WHEREAS, working tirelessly and incessantly through
52	relentless wave after wave of skyrocketing COVID-19 cases and
53	deaths, when rising hope would often give way to despair as the
54	pandemic continued with its deadly assault throughout our state,
55	Dr. Dobbs stayed calm and focused on the many demanding tasks
56	facing him and delivered a consistent message about what needed to
57	be done to stay safe and most effectively reduce the chances of
58	contracting COVID-19 and spreading it to others; and
59	WHEREAS, Dr. Dobbs was drawn to public health early in his
60	life, and he was already a veteran of public health campaigns when
61	Mississippi had its first case of COVID-19, many of them
62	undertaken after he became the State Epidemiologist in 2012, and
63	that background together with his education and wealth of
64	experience with infectious diseases, made him highly qualified and
65	the right person at the right time to address the immense
66	challenges of dealing with the pandemic; and
67	WHEREAS, colleagues of Dr. Dobbs say that his medical
68	background and temperament have made him superbly well suited for

his role as the leading public health voice in the state, being

70	someone who is well-spoken and has the courage of his convictions,
71	and who collaborates instead of dictates as a manager, persuades
72	instead of criticizes as a leader, is an exceptional listener
73	whether talking to a patient or a peer, is open to ideas from
74	others and builds consensus while staying on task; and
75	WHEREAS, Dr. Dobbs is known for always being available and
76	responsive to others seeking his advice and counsel no matter how
77	busy he is, as one who leads by example, and as a collaborative,
78	cooperative and communicative partner with others, and he is
79	highly respected for his professionalism, sterling personality and
80	stellar leadership throughout his tenure at the Department of
81	Health, especially during the COVID-19 pandemic; and
82	WHEREAS, Dr. Dobbs genuinely cares about other people and he
83	is known as a consummate physician who has exceptional skills with
84	patients, having a masterful ability to communicate with them
85	without lecturing, talk with anyone on their level, and simplify
86	medical issues to be understandable by patients and the public,
87	and by his actions and words throughout the pandemic, it appeared
88	that Dr. Dobbs considered every person in Mississippi to be his
89	patient and wanted to take care of them in the best way possible;
90	and
91	WHEREAS, the COVID-19 pandemic has been the defining event of
92	Dr. Dobbs' tenure as State Health Officer and he has been the
93	public face of the Department of Health while leading Mississippi
94	through the pandemic, but at the same time he was working

90	circlessiy to ensure that the department effectively carried out
96	its many other duties and responsibilities to the public, and he
97	is leaving the department in a better place than when he arrived;

99	WHEREAS, Dr. Dobbs' passion has always been infectious
100	disease treatment and he has served in various roles related to
101	that field, including medical director for the AIDS Healthcare
102	Foundation clinic in Jackson, clinical consultant for the
103	Southeastern National TB Center in Florida, and infectious disease
104	consultant for several hospitals in Mississippi; and
105	WHEREAS, before joining the Department of Health, Dr. Dobbs
106	held numerous faculty positions at colleges and universities
107	throughout the Southeast, including at the University of
108	Mississippi Medical Center, UAB and the University of Southern
109	Mississippi, and after two intense years of leading Mississippi
110	through the pandemic, he plans to return to the clinical side of
111	medicine, particularly the communicable disease treatment of
112	patients, and also step back into academia and teach and train
113	health care professionals about public health and infectious
114	diseases; and
115	WHEREAS, Dr. Dobbs has been a wonderful asset to the State of
116	Mississippi and its citizens during his service and leadership as
117	State Health Officer, a class act and a steady voice who guided us
118	during our time of crisis during the COVID-19 pandemic, a true
119	public servant who devoted himself to the safety and health of all

120	Mississippians and did about ten years of work during the past two
121	years, and his many contributions to public health are greatly
122	appreciated by the people of this state and he will be missed at
123	the Department of Health, but we know that he will continue
124	serving the citizens of Mississippi in other valuable ways as he
125	moves into the next phase of his life and career:
126	NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF
127	REPRESENTATIVES OF THE STATE OF MISSISSIPPI, That we heartily
128	commend and express our appreciation to Dr. Thomas Dobbs for his
129	invaluable service, dedication, commitment and tireless work for
130	the people of the State of Mississippi during his time as State
131	Health Officer, especially for steadfastly leading the state
132	through the daunting challenges of the COVID-19 public health
133	crisis, and we extend to him our sincere wishes for the best in
134	all of his future endeavors, including having more time to spend
135	with his wife, Dr. Kim Dobbs, and their two sons, who have been
136	his rocks of support as he was devoting so much of his time to the
137	people of our state during the pandemic.
