JOINT RESOLUTION NO. 1
(As Adopted by the House)

1 A JOINT RESOLUTION TO REAPPORTION THE HOUSE OF
2 REPRESENTATIVES OF THE STATE OF MISSISSIPPI IN ACCORDANCE WITH
3 SECTION 254, MISSISSIPPI CONSTITUTION OF 1890; AND FOR RELATED
4 PURPOSES.

5 WHEREAS, Section 254, Mississippi Constitution of 1890,
6 requires that the Mississippi Legislature shall apportion itself
7 by joint resolution in the second year following the 1980
8 decennial census and every ten (10) years thereafter; and

9 WHEREAS, it is the responsibility and official mandate of the
10 Legislature to reapportion the state in compliance with the
11 one-person, one-vote requirement of the federal Constitution into
12 election districts as close to equal in population as permissible
13 under the law; and

14 WHEREAS, to comply with the one-person, one-vote requirement,
15 the districts set out in this joint resolution shall become
16 effective for the primary and general elections conducted in 2023
17 that determine the membership of the 2024 Mississippi Legislature
18 and in the primaries, special and general election conducted for
19 the Mississippi Legislature thereafter; and



20 WHEREAS, Section 254, Mississippi Constitution of 1890,
21 provides that the House of Representatives shall consist of not
22 more than one hundred twenty-two (122) representatives, the number
23 of members to be determined by the Legislature:

24 NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE
25 STATE OF MISSISSIPPI, That the Mississippi House of
26 Representatives shall consist of one hundred twenty-two (122)
27 representatives who shall be elected from one hundred twenty-two
28 (122) single-member districts, composed as follows:

807 its designation within the description of a district. The
808 Chairman and Vice Chairman of the Standing Joint Legislative
809 Committee on Reapportionment shall file with the Secretary of
810 State of Mississippi the Split Precinct Block List developed in
811 conjunction with the plan contained in this joint resolution that
812 details the portions of the partial or split precincts that are
813 contained within a district by census block number, and such
814 document duly filed with the Secretary of State is hereby
815 incorporated into and shall be construed to be an integral part of
816 this joint resolution.

817 BE IT FURTHER RESOLVED, That the boundaries of the House of
818 Representatives districts described above shall be:

819 (a) The boundaries of the counties listed above as such
820 boundaries existed as of January 1, 2022; and

821 (b) The precinct boundaries along such House of
822 Representative district boundaries as the precinct boundaries are
823 contained in Census Bureau's Public Law 94-171 geographic support
824 products provided for use with the September 16 data deliveries



825 officially called the "2020 Census State Redistricting Data
826 (Public Law 94-171) Summary Files."

827 BE IT FURTHER RESOLVED, (1) That this resolution shall be
828 liberally construed to effectuate the purposes hereof and to
829 redistrict the House of Representatives districts of this state in
830 compliance with constitutional requirements. It is intended that
831 this resolution and the districts described herein completely
832 encompass all the area within the state. It is also intended that
833 such districts contain all the inhabitants in this state. It is
834 further intended that the redistricting provided for in this
835 resolution result in the creation of districts that are as close
836 to equal in population as permissible under the law. It is also
837 intended that no district shall include any of the area included
838 within the description of any other district.

839 (2) If the districts described in this resolution do not
840 carry out the purposes hereof because of: unintentional
841 omissions; duplications; overlapping areas; erroneous
842 nomenclature; lack of adequate maps or descriptions of political
843 subdivisions, wards or other divisions thereof, or of their
844 boundary lines; then the Secretary of State, at the request of the
845 Chairman or Vice Chairman of the Standing Joint Legislative
846 Committee on Reapportionment shall, by order, correct such
847 omissions, overlaps, erroneous nomenclature or other defects in
848 the description of districts so as to accomplish the purposes and
849 objectives of this resolution.



850 (3) In promulgating such orders, the Secretary of State, in
851 addition to achieving equality in the population of districts as
852 permissible under law and ensuring that all areas of the state
853 are completely and accurately encompassed in such districts, shall
854 be guided by the following standards:

855 (a) In any instance in which there is a conflict
856 between the description of a district as provided in this joint
857 resolution and the map of the House of Representative districts
858 developed by the Standing Joint Legislative Committee on
859 Reapportionment in conjunction with the adopted redistricting
860 plan, the map shall control; however, in instances in which the
861 map is inconclusive, the criteria provided in paragraphs (b)
862 through (f) of this subsection shall control any dispute or issue
863 regarding the composition of any House of Representative district;

864 (b) Gaps in the description of a district shall be
865 completed in a manner that results in a total description of the
866 district that is consonant with the description of adjacent
867 districts and results in complete contiguity of districts;

868 (c) Areas of the state included within the descriptions
869 of more than one (1) district shall be allocated to the district
870 having the lowest population;

871 (d) Areas of the state not included within the
872 descriptions of any district shall be allocated to the adjacent
873 district having the lowest population;



874 (e) In the event that the area subject to corrected
875 description or allocation as provided in paragraphs (b), (c) and
876 (d) of this subsection is of such size or contains such population
877 that its inclusion as a unit in any district would result in
878 substantial disparity in the size, shape or population of the
879 district, then the Secretary of State may allocate portions of the
880 area to two (2) or more districts; and

881 (f) In any allocation of area or correction of
882 descriptions made pursuant to this joint resolution, the Secretary
883 of State shall, consistent with the foregoing standards, preserve
884 the contiguity and compactness of districts and avoid the
885 unnecessary division of political subdivisions.

886 (4) Copies of such orders shall be filed by the Secretary of
887 State in his office and in the offices of the affected election
888 commissioners and registrars. The Secretary of State may adopt
889 reasonable rules regulating the procedure for applications for
890 orders under this resolution in the manner of serving and filing a
891 notice or copy of orders relating thereto. Upon the filing of an
892 order, the description of any affected district shall be deemed to
893 have been corrected in the manner provided in such order to the
894 full extent as if such correction had been contained in the
895 original description provided in this resolution.

896 BE IT FURTHER RESOLVED, That the redistricting of House of
897 Representatives districts and Senate districts shall be deemed to
898 be separate from each other. The invalidity of the districts of



899 one (1) house shall not affect or require the redistricting of the
900 other house.

901 BE IT FURTHER RESOLVED, That the Standing Joint Legislative
902 Committee on Reapportionment is directed to provide all
903 information necessary to assist the counties in identifying the
904 boundaries of the districts described in this resolution.

905 BE IT FURTHER RESOLVED, That the redistricting contained in
906 this resolution shall supersede any prior redistricting, and any
907 prior redistricting shall be null and void upon the date this
908 resolution is effectuated.

909 BE IT FURTHER RESOLVED, That the Joint Legislative Committee
910 on Compilation, Revision and Publication of Legislation is hereby
911 directed to see to it that this resolution is placed in the
912 editor's notes that follow Section 5-1-1, Mississippi Code of
913 1972.

914 BE IT FURTHER RESOLVED, That the Chairman and Vice Chairman
915 of the Standing Joint Legislative Committee on Reapportionment
916 shall file copies of this plan with the Mississippi Department of
917 Archives, the Secretary of State, the Clerk of the Mississippi
918 House of Representatives and the Secretary of the Mississippi
919 State Senate.

920 BE IT FURTHER RESOLVED, That if any paragraph, sentence,
921 clause, phrase or any part of this resolution is declared to be
922 unconstitutional or void or if for any reason is declared to be
923 invalid or of no effect, the remaining paragraphs, sentences,



924 clauses, phrases or parts thereof shall be in no manner affected
925 thereby but shall remain in full force and effect.

926 BE IT FURTHER RESOLVED, That the foregoing provisions of this
927 resolution shall take effect and be in force from and after
928 adoption.
