## SENATE BILL NO. 2425 (As Passed the Senate)

AN ACT TO AMEND SECTION 37-3-9, MISSISSIPPI CODE OF 1972, TO PROVIDE A LIMITATION ON THE SALARY OF THE STATE SUPERINTENDENT OF PUBLIC EDUCATION; TO AMEND SECTION 37-4-3, MISSISSIPPI CODE OF 1972, TO PROVIDE A LIMITATION ON THE SALARY OF THE EXECUTIVE DIRECTOR OF THE COMMUNITY COLLEGE BOARD; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 37-3-9, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 37-3-9. (1) There shall be a State Superintendent of Public
- 10 Education who shall be appointed by the State Board of Education,
- 11 with the advice and consent of the Senate, and serve at the
- 12 board's will and pleasure. He shall be the Chief Administrative
- 13 Officer for the State Department of Education and shall administer
- 14 the department in accordance with the policies established by the
- 15 State Board of Education. The State Superintendent of Education,
- 16 serving on July 1, \* \* \* 2021, shall continue to receive the
- 17 salary that he was receiving on January 1, \* \* \* 2021, until his
- 18 <u>contract term ends</u>. From and after the \* \* \* <u>expiration date of</u>
- 19 such superintendent's contract term that was active on July 1,

- 20 <u>2021</u>, the salary of the State Superintendent of Education shall be
- 21 established by the State Board of Education and shall not exceed
- 22 Two Hundred Fifty Thousand Dollars (\$250,000.00) per year. The
- 23 State Superintendent of Public Education shall have at least a
- 24 master's degree in any field and a minimum of five (5) years'
- 25 experience in administration in the educational field.
- 26 (2) The State Superintendent shall give bond in the penalty
- of Seventy-five Thousand Dollars (\$75,000.00), with sureties to be
- 28 approved by the Governor, conditioned according to law. The bond,
- 29 when approved, shall be filed and recorded in the Office of the
- 30 Secretary of State.
- 31 **SECTION 2**. Section 37-4-3, Mississippi Code of 1972, is
- 32 amended as follows:
- 37-4-3. (1) From and after July 1, 1986, there shall be a
- 34 Mississippi Community College Board which shall receive and
- 35 distribute funds appropriated by the Legislature for the use of
- 36 the public community and junior colleges and funds from federal
- 37 and other sources that are transmitted through the state
- 38 governmental organization for use by said colleges. This board
- 39 shall provide general coordination of the public community and
- 40 junior colleges, assemble reports and such other duties as may be
- 41 prescribed by law.
- 42 (2) The board shall consist of ten (10) members of which
- 43 none shall be an elected official. The Governor shall appoint two
- 44 (2) members from the First Mississippi Congressional District, one

- 45 (1) who shall serve an initial term of two (2) years and one (1)
- 46 who shall serve an initial term of five (5) years; two (2) members
- 47 from the Second Mississippi Congressional District, one (1) who
- 48 shall serve an initial term of five (5) years and one (1) who
- 49 shall serve an initial term of three (3) years; and two (2)
- 50 members from the Third Mississippi Congressional District, one (1)
- 51 who shall serve an initial term of four (4) years and one (1) who
- 52 shall serve an initial term of two (2) years; two (2) members from
- 53 the Fourth Mississippi Congressional District, one (1) who shall
- 54 serve an initial term of three (3) years and one (1) who shall
- 55 serve an initial term of four (4) years; and two (2) members from
- 56 the Fifth Mississippi Congressional District, one (1) who shall
- 57 serve an initial term of five (5) years and one (1) who shall
- 58 serve an initial term of two (2) years. All subsequent
- 59 appointments shall be for a term of six (6) years and continue
- 60 until their successors are appointed and qualify. An appointment
- 61 to fill a vacancy which arises for reasons other than by
- 62 expiration of a term of office shall be for the unexpired term
- 63 only. All members shall be appointed with the advice and consent
- 64 of the Senate.
- 65 (3) There shall be a chairman and vice chairman of the
- 66 board, elected by and from the membership of the board; and the
- 67 chairman shall be the presiding officer of the board. The board
- 68 shall adopt rules and regulations governing times and places for
- 69 meetings and governing the manner of conducting its business.

- 70 (4) The members of the board shall receive no annual salary,
- 71 but shall receive per diem compensation as authorized by Section
- 72 25-3-69, Mississippi Code of 1972, for each day devoted to the
- 73 discharge of official board duties and shall be entitled to
- 74 reimbursement for all actual and necessary expenses incurred in
- 75 the discharge of their duties, including mileage as authorized by
- 76 Section 25-3-41, Mississippi Code of 1972.
- 77 (5) The board shall name a director for the state system of
- 78 public junior and community colleges, who shall serve at the
- 79 pleasure of the board. Such director shall be the chief executive
- 80 officer of the board, give direction to the board staff, carry out
- 81 the policies set forth by the board, and work with the presidents
- 82 of the several community and junior colleges to assist them in
- 83 carrying out the mandates of the several boards of trustees and in
- 84 functioning within the state system and policies established by
- 85 the Mississippi Community College Board. The Mississippi
- 86 Community College Board shall set the salary of the director of
- 87 the board. The director serving on July 1, 2021, shall continue
- 88 to receive the salary that he was receiving on January 1, 2021,
- 89 <u>until his contract term ends</u>. From and after the expiration date
- 90 of such director's contract term that was active on July 1, 2021,
- 91 the salary of the director shall be established by the board and
- 92 shall not exceed Two Hundred Fifty Thousand Dollars (\$250,000.00)
- 93 per year. The Legislature shall provide adequate funds for the
- 94 Mississippi Community College Board, its activities and its staff.

95	(6)	The	powers	and	duties	of	the	Mississippi	Community
96	College	Board	shall 1	be:					

- 97 (a) To authorize disbursements of state-appropriated 98 funds to community and junior colleges through orders in the 99 minutes of the board.
- 100 (b) To make studies of the needs of the state as they
  101 relate to the mission of the community and junior colleges.
- 102 (c) To approve new, changes to and deletions of vocational and technical programs to the various colleges.
- 104 (d) To require community and junior colleges to supply
  105 such information as the board may request and compile, publish and
  106 make available such reports based thereon as the board may deem
  107 advisable.
- 108 (e) To approve proposed new attendance centers (campus 109 locations) as the local boards of trustees should determine to be 110 in the best interest of the district. Provided, however, that no 111 new community/junior college branch campus shall be approved 112 without an authorizing act of the Legislature.
- (f) To serve as the state approving agency for federal funds for proposed contracts to borrow money for the purpose of acquiring land, erecting, repairing, etc., dormitories, dwellings or apartments for students and/or faculty, such loans to be paid from revenue produced by such facilities as requested by local boards of trustees.

- (h) To approve any university branch campus offering
- 123 lower undergraduate level courses for credit.
- 124 (i) To appoint members to the Post-Secondary

- 126 (j) To appoint members to the Authority for Educational
- 127 Television.
- 128 (k) To contract with other boards, commissions,
- 129 governmental entities, foundations, corporations or individuals
- 130 for programs, services, grants and awards when such are needed for
- 131 the operation and development of the state public community and
- 132 junior college system.
- 133 (1) To fix standards for community and junior colleges
- 134 to qualify for appropriations, and qualifications for community
- 135 and junior college teachers.
- 136 (m) To have sign-off approval on the State Plan for
- 137 Vocational Education which is developed in cooperation with
- 138 appropriate units of the State Department of Education.
- (n) To approve or disapprove of any proposed inclusion
- 140 within municipal corporate limits of state-owned buildings and
- 141 grounds of any community college or junior college and to approve
- 142 or disapprove of land use development, zoning requirements,
- 143 building codes and delivery of governmental services applicable to

144	state-owned buildings and grounds of any community college or
145	junior college. Any agreement by a local board of trustees of a
146	community college or junior college to annexation of state-owned
147	property or other conditions described in this paragraph shall be
148	void unless approved by the board and by the board of supervisors
149	of the county in which the state-owned property is located.
150	<b>SECTION</b> $\underline{\underline{3}}$ . This act shall take effect and be in force from
151	and after July 1, 2022.
