## COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2601

AN ACT TO CREATE THE MISSISSIPPI PINK ALERT SYSTEM ACT OF 2022; TO PROVIDE CERTAIN DEFINITIONS; TO PROVIDE THE CRITERIA TO REQUEST AN ACTIVATION FOR A PINK ALERT; TO PROVIDE THE CRITERIA FOR ACTIVATION OF A PINK ALERT; TO PROVIDE CERTAIN DUTIES OF LOCAL LAW ENFORCEMENT AGENCIES AND THE DEPARTMENT OF PUBLIC SAFETY RELATING TO THE IMPLEMENTATION OF THE ACT; TO PROVIDE THE PROCEDURE THAT LAW ENFORCEMENT AGENCIES AND THE DEPARTMENT OF PUBLIC SAFETY MUST FOLLOW WHEN A MISSING PERSON CASE DOES NOT MEET THE PINK ALERT CRITERIA; AND FOR RELATED PURPOSES.

- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 <u>SECTION 1.</u> (1) This section shall be known and may be cited 12 as the "Mississippi Pink Alert System Act of 2022."
- 13 (2) As used in this section, the following terms shall have 14 the meanings ascribed herein unless the context clearly requires 15 otherwise:
- 16 (a) "E911" means Enhanced Universal Emergency Number
  17 Service or Enhanced 911 Service, which is a telephone exchange
  18 communications service by which a Public Safety Answering Point
  19 designated by the county or local communication district may
- 20 receive telephone calls dialed to the telephone number 911.

21 (	b)	"First	responders"	means	state	and	local	law

- 22 enforcement personnel, fire department personnel, emergency
- 23 medical personnel, emergency management personnel and public works
- 24 personnel who may be deployed to bioterrorism attacks, terrorist
- 25 attacks, catastrophic or natural disasters and emergencies.
- 26 (c) "Originating local law enforcement agency" means a
- 27 local police or sheriff's office that has jurisdiction over the
- 28 area where a person became missing.
- 29 (3) (a) The Bureau of Investigation of the Department of
- 30 Public Safety shall implement a statewide "Pink Alert System" that
- 31 has the purpose of providing a tiered, rapid response system to
- 32 notify the public about missing endangered persons who are
- 33 suspected victims of sex trafficking. The initial response may be
- 34 local, statewide or national based on available information about
- 35 the missing person.
- 36 (b) A Pink Alert activation request may be made only by
- 37 a law enforcement agency, and the Bureau of Investigation of the
- 38 Department of Public Safety may only activate a Pink Alert after a
- 39 request is made.
- 40 (c) To activate a Pink Alert, all of the following
- 41 criteria must be met:
- 42 (i) The missing person is believed to have been a
- 43 victim of sex trafficking;
- 44 (ii) The person is believed to be missing and in
- 45 imminent danger regardless of circumstance;

46	(111) The family, legal caregiver or custodian of
47	the missing person has submitted a missing person's report to the
48	local law enforcement agency in the jurisdiction where the person
49	became missing, with all waiting periods being waived; and
50	(iv) The law enforcement agency that has
51	jurisdiction of where the person became missing reports the

- 55 (d) To initiate a request to activate a Pink Alert, the 56 family, legal caregiver or custodian of the missing person must
- 57 file immediately a report of the missing person with the local law
- 58 enforcement agency where the person became missing that includes
- 59 the following information:
- (i) A description of the missing person, including
- 61 physical characteristics, clothing and photos, if available;
- 62 (ii) A description of the known circumstances
- 63 under which the person became missing, including the time, place,
- 64 direction, possible destinations, whether the person was walking
- or in a vehicle, and all other pertinent information concerning
- 66 where the person may have become missing; and
- 67 (iii) Updates on the missing person as new
- 68 information becomes available.
- 69 (e) The originating local law enforcement agency, after
  70 completing the investigation expeditiously and determining that

- 73 Waive any waiting periods for a missing
- person's report in order to galvanize the appropriate communities 74
- 75 rapidly to assist in the search for and the safe recovery of the
- 76 missing person in the case of a Pink Alert;
- 77 (ii) Notify the Mississippi Highway Patrol
- 78 Headquarters Communication Center and electronically send to the
- 79 center the completed Pink Alert forms and available photos, signed
- by the police chief, sheriff, commanding officer or his or her 80
- 81 designee;
- 82 (iii) Enter the information into the National
- 83 Crime Information Center (NCIC);
- 84 (iv) Using a tiered approach based on known
- 85 circumstances, initiate an alert bulletin to all local law
- 86 enforcement, E911 and first responder agencies to search the
- 87 immediate area;
- 88  $(\nabla)$ Activate secondary alert systems to residents,
- 89 businesses, and broadcast media in the immediate area;
- 90 Provide a twenty-four-hour phone number to (vi)
- 91 receive calls while continuing the investigation; and
- (vii) Update the family, legal caregiver or 92
- 93 custodian of the missing person as new information becomes
- available. 94

- 96 of Public Safety has been contacted by a local law enforcement
- 97 agency requesting a Pink Alert activation, the Criminal
- 98 Information Center shall consider before the activation of the
- 99 Pink Alert procedures by the Pink Alert coordinator, or his or her
- 100 designee, the information contained in the initial Pink Alert
- 101 report form to ensure that it meets all criteria specified in
- 102 subsection (3)(c) of this section. Elements of the missing person
- 103 case to be considered are:
- 104 (i) Threat of imminent harm or death to the
- 105 missing person because of age, health, mental or physical
- 106 disability, environmental or weather conditions;
- 107 (ii) Time of initial report in relation to the
- 108 time of disappearance, including whether the disappearance is
- 109 unexplained, involuntary or is under suspicious circumstances;
- 110 (iii) Witness information;
- 111 (iv) Possible domestic dispute involving the
- 112 missing person; and
- 113 (v) Other facts that indicate the missing person
- 114 is in danger of serious injury or death, including whether there
- is possible criminal intent toward the missing person or whether
- 116 someone witnessed the disappearance.
- 117 (b) Each case shall be reviewed on its own merits, and
- 118 if there are extenuating circumstances, the required criteria in

- 121 (c) Only the Pink Alert coordinator, or his or her
- 122 designee, may authorize activation of a statewide Pink Alert and
- 123 if an activation is authorized, the Criminal Information Center

- 125 (i) Prepare an announcement concerning the missing
- 126 person;
- 127 (ii) Contact the designated media stations to
- 128 activate the alert; and
- 129 (iii) Request the Mississippi Department of
- 130 Transportation to activate electronic signs, if appropriate.
- 131 (d) If the missing person is believed to be in a
- 132 vehicle, the Pink Alert coordinator shall send information and
- 133 available photos via emails and fax to the statewide
- 134 communications systems, news media and other forms of public
- 135 communication or electronic resources.
- 136 (5) (a) Following the initial alert, a Pink Alert
- 137 broadcast shall be updated by television and radio stations as
- 138 necessary until such time that an end of alert message is received
- 139 from the law enforcement agency that requested the initial Pink
- 140 Alert.
- 141 (b) Local and statewide broadcast stations shall
- 142 exercise their own independent discretions as to whether to repeat
- 143 the required broadcasts prescribed in this section more frequently

- 144 and shall determine the frequency in which the alert is
- 145 re-broadcast following the initial alert.
- 146 (c) The Pink Alert termination notification shall be
- 147 issued twenty-four (24) hours after the airing of the latest and
- 148 most current information or when the case has been resolved and
- 149 verification from the originating local law enforcement agency has
- 150 been received by the Department of Public Safety.
- 151 (6) (a) If the circumstances of a person's disappearance do
- 152 not meet the criteria for a Pink Alert to activate statewide
- 153 communication systems, the Bureau of Investigation of the
- 154 Department of Public Safety may offer an alternate form of mass
- 155 notification as provided in this section.
- 156 (b) The alternate form of mass notification may be an
- 157 email that includes a photograph and the Pink Alert initial
- 158 reporting form that is sent through a statewide network of law
- 159 enforcement and first responder agencies, news media offices and
- 160 other forms of public communication.
- 161 (c) The email authorized in paragraph (b) of this
- 162 subsection (6) shall contain information taken from the Pink Alert
- 163 initial reporting form that is submitted by the originating local
- 164 law enforcement agency.
- 165 (d) The email alerting news media and law enforcement
- 166 agencies of a person's disappearance that does not meet the
- 167 criteria of a Pink Alert activation shall include the following
- 168 paragraph at the beginning of the email:

169	"The (name of law enforcement agency) has requested the
170	following information be provided to the Mississippi
171	news media and law enforcement agencies: At the
172	present time, information being provided to the
173	Mississippi Department of Public Safety by the ( <u>name of</u>
174	<pre>law enforcement agency) does not meet the criteria to</pre>
175	activate a Pink Alert. It is left to the discretion of
176	each law enforcement agency and news department
177	receiving this email as to whether the attached
178	information, regarding the disappearance of this person
179	and/or the photograph of this person, will be released
180	to the public."
181	(e) If further investigation into the disappearance

- (e) If further investigation into the disappearance 182 produces evidence that may change the initial circumstances as 183 reported to local law enforcement, the Department of Public Safety 184 may reconsider activating a Pink Alert.
- 185 SECTION 2. This act shall take effect and be in force from 186 and after July 1, 2022.
