SENATE BILL NO. 2893 (As Sent to Governor)

1 AN ACT TO AUTHORIZE JACKSON STATE UNIVERSITY TO ENTER INTO A 2 GROUND LEASE, SALE, MANAGEMENT OR MAINTENANCE AGREEMENTS WITH A 3 PRIVATE ENTITY RELATED TO THE DEVELOPMENT OF LAND OWNED OR TO BE OWNED BY THE UNIVERSITY; AND FOR RELATED PURPOSES. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** (1) Jackson State University, with the approval 6 7 of the Board of Trustees of State Institutions of Higher Learning, is authorized to enter into a ground lease, management and 8 9 maintenance agreement, or an agreement to lease or sell part of 10 its real property, or property which will have been acquired by Jackson State University from the Jackson State University 11 12 Development Foundation, to a private entity, its successors and 13 assigns, related to the ownership, leasing, renovating 14 development, construction, furnishing, maintenance and equipping of facilities by the private entity for the housing of Jackson 15 State University students, faculty, staff and visitors within such 16 17 facilities and/or other commercial development on property located within and outside the current campus of Jackson State University 18 19 in the City of Jackson, Hinds County, Mississippi.
