- 17 Public Accountant; and
- 18 WHEREAS, in 1989, Pat returned to her home state to work as a
- 19 Senior Securities Analyst for the Mississippi Secretary of State's

20 Office Securities Division. She established their first auditing 21 program and analyzed the financial records in securities fraud and 22 embezzlement cases. During the course of her employment, Pat testified in state and federal courts and conducted numerous 23 24 audits. Pat also served on the North American Securities 25 Administrators Association Uniform Examination Committee, helping to write and monitor examinations taken by financial advisors and 26 27 stockbrokers. In 1993, she was certified as a Fraud Examiner; and 28 WHEREAS, in 1996, at the request of her family, Pat returned 29 to Philadelphia, Mississippi, to work in the family business. 30 has worn many different hats in Thomasson Company. She currently serves as Chief Executive Officer and Chairman of the Board and 31 32 held both of these positions before the passing of her father in 33 2008; and WHEREAS, under Pat's leadership, Thomasson Company was 34 35 awarded the 2012 Governor's Cup Award for Small Business, the 2016 36 Oncor Omnis Supplier Award, and was recognized as a Vistra Energy Supplier Diversity Gold Star Supplier. Pat is a recent recipient 37 38 of the 2017 Volunteer of the Year Award from the Women's Business 39 Enterprise Council South and was named 2014 Business Woman of the 40 Year by Mississippi Business Journal. In 2015, Thomasson Company

received the Neshoba County Large Business of the Year Award, and

Pat received the Volunteer of the Year Award from the Neshoba

County Literacy Council; and

55	Leadership Mississippi; and past Treasurer and Board Member of the
56	Business and Industry Political Education Committee; and

58	philanthropic organizations, and it is with great pride that we
59	acknowledge the contributions of an outstanding Mississippi
60	citizen to her community and to the State of Mississippi:
