House Amendments to Senate Bill No. 2476

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 7 **SECTION 1.** Section 49-15-46, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 49-15-46. (1) Each vessel used to catch, take, carry or
- 10 transport oysters from the reefs of the State of Mississippi, or
- 11 engaged in transporting any oysters in any of the waters within
- 12 the territorial jurisdiction of the State of Mississippi, for
- 13 commercial use, shall annually, before beginning operations, be
- 14 licensed by the * * * department and pay the following license
- 15 fee:
- 16 (a) Fifty Dollars (\$50.00) on each in-state vessel or
- 17 boat used for tonging oysters or gathering oysters by hand;
- 18 (b) One Hundred Dollars (\$100.00) on each in-state
- 19 vessel or boat used for dredging oysters;
- 20 (c) One Hundred Dollars (\$100.00) on each out-of-state
- 21 vessel or boat used for tonging oysters or gathering oysters by
- 22 hand; or

- 23 (d) Two Hundred Dollars (\$200.00) on each out-of-state
- 24 vessel or boat used for dredging oysters * * *.
- 25 * * *
- 26 (2) * * * Each molluscan shellfish aquaculture operation
- 27 shall annually, before beginning operations, be licensed by the
- 28 department and pay the following license fee:
- 29 (a) Fifty Dollars (\$50.00) on each resident molluscan
- 30 shellfish aquaculture operation; or
- 31 (b) One Hundred Dollars (\$100.00) on each nonresident
- 32 molluscan shellfish aquaculture operation.
- 33 (3) The \star \star department may authorize the transfer of a
- 34 vessel license to a different vessel provided that the owner of
- 35 both vessels is the same titled owner.
- 36 (4) All oysters harvested in the State of Mississippi shall
- 37 be tagged. Tags shall be issued by the department and shall bear
- 38 the catcher's name, the date and origin of the catch, the shell
- 39 stock dealer's name and permit number. The department shall
- 40 number all tags issued and shall maintain a record of those tags.
- 41 The * * * department, in its discretion, may adopt any regulations
- 42 regarding the tagging of oysters and other shellfish.
- 43 (5) Each person catching or taking oysters from the waters
- 44 of the State of Mississippi for personal use shall obtain a permit
- 45 from the * * * department and pay an annual recreational oyster
- 46 permit fee of Ten Dollars (\$10.00). Oysters caught under a
- 47 recreational permit shall not be offered for sale. The limits on
- 48 the allowable catch of oysters for recreational purposes shall be

- 49 three (3) sacks per week. The department shall issue tags of a
- 50 distinguishing color to designate recreationally harvested
- 51 oysters, which shall be tagged on the same day of harvest in the
- 52 manner prescribed in subsection (4) of this section for
- 53 commercially harvested oysters or by regulation of the * * *
- 54 department.
- 55 (6) The * * * department shall assess and collect a shell
- 56 retention fee for the shells taken from waters within the
- 57 territorial jurisdiction of the State of Mississippi as follows:
- 58 (a) Commercial and recreational harvesters Fifteen
- 59 Cents (15¢) per sack paid to the department on the day of harvest;
- (b) Initial oyster processor, dealer or factory first
- 61 purchasing the oysters Fifteen Cents (15¢) per sack paid to the
- 62 department no later than the tenth day of the month following the
- 63 purchase, on forms submitted by the department;
- 64 (c) Commercial harvesters transporting their catch out
- of the state Fifty Cents (50¢) per sack paid to the department
- on the day of harvest, in addition to the fees paid in * * *
- 67 paragraph (a) of this subsection; and
- 68 (d) Commercial harvesters not selling their oysters to
- 69 a Mississippi dealer Fifteen Cents (15¢) per sack paid to the
- 70 department on the day of harvest, in addition to fees paid
- 71 in * * * paragraph (a) of this subsection.
- 72 Funds received from the shell retention fee shall be paid
- 73 into a special fund in the State Treasury to be appropriated by
- 74 the Legislature for use by the \star \star department to further oyster

- 75 production in this state, which includes plantings of oysters
- 76 and/or cultch materials.
- 77 (7) During open seasons, oysters may be taken only by hands,
- 78 tongs and dredges.
- 79 (8) Vessels licensed under Section 49-15-46 may keep in
- 80 whole, for personal consumption up to thirty-six (36) blue crabs
- 81 (portunidae family), per day. This exemption for personal
- 82 consumption does not apply to fish or crabs that are otherwise
- 83 illegal to possess or catch.
- 84 **SECTION 2.** This act shall take effect and be in force from
- 85 and after July 1, 2022, and shall stand repealed on June 30, 2022.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO AMEND SECTION 49-15-46, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE MISSISSIPPI DEPARTMENT OF MARINE RESOURCES TO LICENSE MOLLUSCAN SHELLFISH AQUACULTURE OPERATIONS AND TO LICENSE MULTIPLE VESSELS AT SUCH AQUACULTURE OPERATIONS; AND FOR RELATED PURPOSES.
