

House Amendments to Senate Bill No. 2525

TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

9 **SECTION 1.** Section 1, Chapter 393, Laws of 2014, is amended
10 as follows:

11 Section 1. (1) The Department of Finance and
12 Administration, acting on behalf of the Mississippi Department of
13 Archives and History, is authorized to donate to the U.S.
14 Department of the Interior, National Park Service, Vicksburg
15 National Military Park all the rights, title and interest in
16 certain real property under the possession and control of the
17 Department of Archives and History, located in the Second Judicial
18 District of Hinds County, Mississippi, subject to the requirements
19 and conditions prescribed in subsection (3) of this section. Upon
20 completing a field survey, the Department of Finance and
21 Administration, acting on behalf of the Mississippi Department of
22 Archives and History, is authorized to develop a legal description
23 and file necessary deeds to exclude a two-hundred-foot buffer to
24 extend southerly from the existing south right-of-way line of the
25 railroad property, thereby forming the north line of the National

26 Park Service property at the Champion Hill Battlefield property
27 described below, and to describe an access corridor to be retained
28 by the Mississippi Department of Archives and History. The
29 purpose of this boundary line is to identify ownership and to
30 assist in carrying out future park operations and maintenance.

367 (3) The State of Mississippi shall retain all mineral rights
368 in the property donated under the provisions of this section.

369 **SECTION 2.** This act shall take effect and be in force from
370 and after July 1, 2022, and shall stand repealed on June 30, 2022.

inserting in lieu thereof the following:**

1 AN ACT TO AMEND CHAPTER 393, LAWS OF 2014, TO AUTHORIZE THE
2 DEPARTMENT OF FINANCE AND ADMINISTRATION ACTING ON BEHALF OF THE
3 MISSISSIPPI DEPARTMENT OF ARCHIVES AND HISTORY TO RETAIN A
4 200-FOOT BUFFER ON THE NORTH SIDE OF THE CHAMPION HILL HISTORICAL
5 PROPERTY BETWEEN THE RAILROAD RIGHT-OF-WAY AND THE NATIONAL PARK
6 SERVICE PROPERTY AND AN ACCESS CORRIDOR AND TO FILE NECESSARY
7 DEEDS THEREFOR; AND FOR RELATED PURPOSES.
