## Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

## Senate Bill No. 2422

## **BY: Committee**

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

28 Section 31-7-9, Mississippi Code of 1972, is 29 amended as follows: 30 31-7-9. (1) (a) The Office of Purchasing, Travel and Fleet 31 Management shall adopt purchasing regulations governing the 32 purchase by any agency of any commodity or commodities and 33 establishing standards and specifications for a commodity or 34 commodities and the maximum fair prices of a commodity or 35 commodities, subject to the approval of the Public Procurement 36 Review Board. It shall have the power to amend, add to or 37 eliminate purchasing regulations. The adoption of, amendment,



- 38 addition to or elimination of purchasing regulations shall be 39 based upon a determination by the Office of Purchasing, Travel and Fleet Management with the approval of the Public Procurement 40 Review Board, that such action is reasonable and practicable and 41 42 advantageous to promote efficiency and economy in the purchase of 43 commodities by the agencies of the state. Upon the adoption of 44 any purchasing regulation, or an amendment, addition or 45 elimination therein, copies of same shall be furnished to the 46 State Auditor and to all agencies affected thereby. Thereafter, and except as otherwise may be provided in subsection (2) of this 47 48 section, no agency of the state shall purchase any commodities 49 covered by existing purchasing regulations unless such commodities 50 be in conformity with the standards and specifications set forth 51 in the purchasing regulations and unless the price thereof does 52 not exceed the maximum fair price established by such purchasing 53 regulations. The Office of Purchasing, Travel and Fleet 54 Management shall furnish to any county or municipality or other 55 local public agency of the state requesting same, copies of 56 purchasing regulations adopted by the Office of Purchasing, Travel 57 and Fleet Management and any amendments, changes or eliminations
- 59 (b) The Office of Purchasing, Travel and Fleet
  60 Management may adopt purchasing regulations governing the use of
  61 credit cards, procurement cards and purchasing club membership
  62 cards to be used by state agencies, governing authorities of

- 63 counties and municipalities, school districts and the Chickasawhay
- 64 Natural Gas District. Use of the cards shall be in strict
- 65 compliance with the regulations promulgated by the office. Any
- 66 amounts due on the cards shall incur interest charges as set forth
- 67 in Section 31-7-305 and shall not be considered debt.
- 68 (c) Pursuant to the provision of Section 37-61-33(3),
- 69 the Office of Purchasing, Travel and Fleet Management of the
- 70 Department of Finance and Administration, which by July 1 shall
- 71 have received from the provider of procurement cards with whom it
- 72 has contracted for such services, is authorized to issue
- 73 procurement cards or credentials for a digital solution to all
- 74 public school district classroom teachers, teachers employed by a
- 75 university-based program, full- and part-time gifted and special
- 76 education teachers and other necessary direct support
- 77 personnel \* \* \* on August 1 before the beginning of the school
- 78 year for the purchase of instructional supplies using Educational
- 79 Enhancement Funds. The cards will be issued in equal amounts per
- 80 teacher determined by the total number of qualifying personnel and
- 81 the then current state appropriation for classroom instructional
- 82 supplies under the Education Enhancement Fund. All purchases
- 83 shall be in accordance with state law and teachers are responsible
- 84 for verification of capital asset requirements when pooling monies
- 85 to purchase equipment. All unexpended amounts remaining on
- 86 procurement cards on December 31 shall expire on that date and
- 87 returned to the fund for reallocation to STEM, arts and gifted



- 88 teachers on January 31 of the second term of the school year.
- 89 Thereafter, the cards will expire on a predetermined date at the
- 90 end of each school year. All unexpended amounts will be carried
- 91 forward, to be combined with the following year's instructional
- 92 supply fund allocation, and reallocated for the following year.
- 93 The Department of Finance and Administration is authorized to loan
- 94 any start-up funds at the beginning of the school year to fund
- 95 this procurement system for instructional supplies with loan
- 96 repayment being made from sales tax receipts earmarked for the
- 97 Education Enhancement Fund.
- 98 (d) In a sale of goods or services, the seller shall
- 99 not impose a surcharge on a buyer who uses a state-issued credit
- 100 card, procurement card, travel card, or fuel card. The Department
- 101 of Finance and Administration shall have exclusive jurisdiction to
- 102 enforce and adopt rules relating to this paragraph. Any rules
- 103 adopted under this paragraph shall be consistent with federal laws
- 104 and regulations governing credit card transactions described by
- 105 this paragraph. This paragraph does not create a cause of action
- 106 against an individual for a violation of this paragraph.
- 107 (2) The Office of Purchasing, Travel and Fleet Management
- 108 shall adopt, subject to the approval of the Public Procurement
- 109 Review Board, purchasing regulations governing the purchase of
- 110 unmarked vehicles to be used by the Bureau of Narcotics and
- 111 Department of Public Safety in official investigations pursuant to
- 112 Section 25-1-87. Such regulations shall ensure that purchases of

- such vehicles shall be at a fair price and shall take into

  114 consideration the peculiar needs of the Bureau of Narcotics and

  115 Department of Public Safety in undercover operations.
- 116 (3) The Office of Purchasing, Travel and Fleet Management 117 shall adopt, subject to the approval of the Public Procurement 118 Review Board, regulations governing the certification process for certified purchasing offices, including the Mississippi Purchasing 119 120 Certification Program, which shall be required of all purchasing 121 agents at state agencies. Such regulations shall require entities desiring to be classified as certified purchasing offices to 122 123 submit applications and applicable documents on an annual basis, 124 and in the case of a state agency purchasing office, to have one 125 hundred percent (100%) participation and completion by purchasing 126 agents in the Mississippi Purchasing Certification Program, at 127 which time the Office of Purchasing, Travel and Fleet Management may provide the governing entity with a certification valid for 128 129 one (1) year from the date of issuance. The Office of Purchasing, 130 Travel and Fleet Management shall set a fee in an amount that 131 recovers its costs to administer the Mississippi Purchasing 132 Certification Program, which shall be assessed to the 133 participating state agencies.
  - (4) The Office of Purchasing, Travel and Fleet Management shall adopt purchasing regulations authorizing rural water associations to purchase at the state contract price afforded to agencies and governing authorities under this chapter.

- SECTION 2. Section 37-61-33, Mississippi Code of 1972, is
- 139 amended as follows:
- 140 37-61-33. (1) There is created within the State Treasury a
- 141 special fund to be designated the "Education Enhancement Fund"
- 142 into which shall be deposited all the revenues collected pursuant
- 143 to Sections 27-65-75(7) and (8) and 27-67-31(a) and (b).
- 144 (2) Of the amount deposited into the Education Enhancement
- 145 Fund, Sixteen Million Dollars (\$16,000,000.00) shall be
- 146 appropriated each fiscal year to the State Department of Education
- 147 to be distributed to all school districts. Such money shall be
- 148 distributed to all school districts in the proportion that the
- 149 average daily attendance of each school district bears to the
- 150 average daily attendance of all school districts within the state
- 151 for the following purposes:
- 152 (a) Purchasing, erecting, repairing, equipping,
- 153 remodeling and enlarging school buildings and related facilities,
- 154 including gymnasiums, auditoriums, lunchrooms, vocational training
- 155 buildings, libraries, teachers' homes, school barns,
- 156 transportation vehicles (which shall include new and used
- 157 transportation vehicles) and garages for transportation vehicles,
- 158 and purchasing land therefor.
- 159 (b) Establishing and equipping school athletic fields
- 160 and necessary facilities connected therewith, and purchasing land
- 161 therefor.



- (c) Providing necessary water, light, heating,
  air-conditioning and sewerage facilities for school buildings, and
  purchasing land therefor.
- 165 As a pledge to pay all or a portion of the debt service on debt issued by the school district under Sections 166 167 37-59-1 through 37-59-45, 37-59-101 through 37-59-115, 37-7-351168 through 37-7-359, 37-41-89 through 37-41-99, 37-7-301, 37-7-302 169 and 37-41-81, or debt issued by boards of supervisors for 170 agricultural high schools pursuant to Section 37-27-65, if such 171 pledge is accomplished pursuant to a written contract or 172 resolution approved and spread upon the minutes of an official 173 meeting of the district's school board or board of supervisors. 174 The annual grant to such district in any subsequent year during 175 the term of the resolution or contract shall not be reduced below 176 an amount equal to the district's grant amount for the year in 177 which the contract or resolution was adopted. The intent of this 178 provision is to allow school districts to irrevocably pledge a certain, constant stream of revenue as security for long-term 179 obligations issued under the code sections enumerated in this 180 181 paragraph or as otherwise allowed by law. It is the intent of the 182 Legislature that the provisions of this paragraph shall be 183 cumulative and supplemental to any existing funding programs or 184 other authority conferred upon school districts or school boards.
