The following sum, or so much thereof as may be 6 necessary, is hereby appropriated out of any money in the State 7 General Fund not otherwise appropriated, for the purpose of 8 defraying the expenses of the State Department of Agriculture and 9 Commerce, including the Divisions of Support, Plant Industry, 10 Farmers Central Market, Fair Commission, Livestock Coliseum, Industrial Showcase, and Trade Mart Building, for the fiscal year 11 12 beginning July 1, 2022, and ending June 30, 2023..... 13\$ 8,422,827.00.

14 SECTION 2. The following sum, or so much thereof as may be 15 necessary, is hereby authorized for expenditure out of any special source funds, which are collected by or otherwise become available 16 17 for the purpose of defraying the expenses of the State Department 18 of Agriculture and Commerce, including the Divisions of Support 19 and Plant Industry, Farmers Central Market, Fair Commission, Livestock Coliseum, Industrial Showcase, and Trade Mart Building 20 for the fiscal year beginning July 1, 2022, and ending 21 22 June 30, 2023.....\$ 12,468,036.00. The funds authorized for expenditure under the provisions of 23 24 this section include subscription fees produced from the Market 25 Bulletin and admission fees produced from the Mississippi 26 Agriculture and Forestry Museum. 27 SECTION 3. Of the funds appropriated under the provisions of this act, the following positions are authorized: 28 29 AUTHORIZED POSITIONS: 30 Permanent: Full Time..... 206 31 Part Time..... 8 32 Time-Limited: Full Time..... 13 33 Part Time.... 0 34 With the funds herein appropriated, it shall be the agency's 35 responsibility to make certain that funds required for Personal Services for Fiscal Year 2024 do not exceed Fiscal Year 2023 funds 36 37 appropriated for that purpose unless programs or positions are added to the agency's Fiscal Year 2023 budget by the Mississippi 38

39 Legislature. The Legislature shall determine the agency's 40 personal services appropriation, which shall be published by the State Personnel Board. Additionally, the State Personnel Board 41 42 shall determine and publish the projected annualized payroll costs 43 based on current employees. It shall be the responsibility of the 44 agency head to ensure that actual personnel expenditures for Fiscal Year 2023 do not exceed the data provided by the 45 46 Legislative Budget Office. If the agency's Fiscal Year 2023 47 projected cost exceeds the annualized costs, no salary actions 48 shall be processed by the State Personnel Board with the exception 49 of new hires that are determined to be essential for the agency.

50 Any transfers or escalations shall be made in accordance with 51 the terms, conditions and procedures established by law or 52 allowable under the terms set forth within this act. The State 53 Personnel Board shall not escalate positions without written 54 approval from the Department of Finance and Administration. The 55 Department of Finance and Administration shall not provide written 56 approval to escalate any funds for salaries and/or positions 57 without proof of availability of new or additional funds above the 58 appropriated level.

59 No general funds authorized to be expended herein shall be 60 used to replace federal funds and/or other special funds which are 61 being used for salaries authorized under the provisions of this 62 act and which are withdrawn and no longer available.

None of the funds herein appropriated shall be used in violation of Internal Revenue Service's Publication 15-A relating to the reporting of income paid to contract employees, as interpreted by the Office of the State Auditor.

Funds have been appropriated herein for the purpose of funding Project SEC2 minimum salaries for all employees covered under the Colonel Guy Groff/Neville Kenning Variable Compensation Plan. It shall be the agency's responsibility to ensure that the funds are used to increase all employees' salaries up to the minimum level as determined by the State Personnel Board.

73 SECTION 4. In addition to all other sums herein 74 appropriated, the following sum, or so much thereof as may be 75 necessary, is hereby appropriated out of any money in the State 76 Treasury to the credit of the Beaver Control Program or from any 77 other special source funds made available to the Beaver Control 78 Program, to the Department of Agriculture and Commerce for the 79 support of the Beaver Control Program for the fiscal year 80 beginning July 1, 2022, and ending June 30, 2023..... 81\$ 1,100,000.00. 82 Of the special funds authorized in this section, Six Hundred 83 Fifty Thousand Dollars (\$650,000.00) shall be derived from funds 84 received from the Mississippi Department of Transportation and 85 from fees charged private persons/organizations, and Two Hundred 86 Thousand Dollars (\$200,000.00) shall be derived from funds 87 received from the State Forestry Commission. participate must pay up to Seven Thousand Five Hundred Dollars (\$7,500.00) and if any county wishes to pay any additional funds than provided, those funds may be used only in said county.

SECTION 5. Of the funds appropriated in Section 2, the 91 92 following sum, or so much thereof as may be necessary, shall be 93 derived from the Mississippi Department of Agriculture and 94 Commerce - Fruit and Vegetable Revolving Fund, for the purpose of 95 defraying the expenses of the department.....\$ 600,000.00. 96 SECTION 6. Of the funds appropriated in Section 2, 97 Seventy-four Thousand Eight Hundred Five Dollars (\$74,805.00) 98 shall be provided for the support of the Mississippi Eqg Marketing

99 Board.

SECTION 7. In compliance with the "Mississippi Performance Budget and Strategic Planning Act of 1994," it is the intent of the Legislature that the funds provided herein shall be utilized in the most efficient and effective manner possible to achieve the intended mission of this agency. 187 A reporting of the degree to which the performance targets 188 set above have been or are being achieved shall be provided in the 189 agency's budget request submitted to the Joint Legislative Budget 190 Committee for Fiscal Year 2024.

191 SECTION 8. The funds appropriated and authorized to be 192 expended under the provisions of this act shall be expended for 193 the purpose of defraying all expenses incurred by the State 194 Department of Agriculture and Commerce in the operation of all 195 programs and activities (except operation of the State Lime 196 Plants, Veterinary Laboratory, Pink Bollworm-Plant Quarantine 197 Inspection Stations and Fire Ant Program) authorized to be 198 conducted and carried on by said department; including, but not 199 limited to: the administration of the Feed, Fertilizer and Dairy 200 Act; the Weights and Measures Act; the Meat Inspection Act of 201 1968; the Mississippi Pure Seed Law; and the following additional 202 programs and activities: enforcement of the egg law; publication 203 and distribution of the Mississippi Market Bulletin, agricultural 204 statistics, market news service at Stoneville, Mississippi; and 205 inspection, grading and certifying of fruits, vegetables, hay, 206 grain, meat and meat products, milk and dairy products, pecans, 207 seed and syrup.

208 **SECTION 9.** The Mississippi Department of Agriculture and 209 Commerce, with the assistance of the State Department of Audit and 210 the Department of Finance and Administration, shall establish 211 nonbudgeted enterprise funds for all "for-profit" activities

212 related to the Mississippi Agriculture and Forestry Museum. The 213 funds shall be maintained in accordance with generally accepted 214 accounting principles and regulations prescribed by the Department 215 of Finance and Administration.

216 SECTION 10. Of the funds provided by the provisions of this 217 act, it is the intent of the Legislature that not more than Thirty 218 Thousand Dollars (\$30,000.00) shall be expended for the Mississippi Senior Farmers' Market Nutrition Pilot Program, which 219 220 shall be established by the State Department of Agriculture and Commerce to serve senior citizens above sixty (60) years of age 221 222 who fall within one hundred thirty percent (130%) of the poverty 223 The Commissioner of Agriculture may promulgate rules and level. 224 regulations necessary to implement the Mississippi Senior Farmers' 225 Market Nutrition Pilot Program.

226 SECTION 11. It is the intention of the Legislature that 227 whenever two (2) or more bids are received by this agency for the 228 purchase of commodities or equipment, and whenever all things 229 stated in such received bids are equal with respect to price, 230 quality and service, the Mississippi Industries for the Blind 231 shall be given preference. A similar preference shall be given to 232 the Mississippi Industries for the Blind whenever purchases are 233 made without competitive bids.

234 **SECTION 12.** It is the intention of the Legislature that the 235 Department of Agriculture and Commerce shall maintain complete 236 accounting and personnel records related to the expenditure of all

funds appropriated under this act and that such records shall be in the same format and level of detail as maintained for Fiscal Year 2022. It is further the intention of the Legislature that the agency's budget request for Fiscal Year 2024 shall be submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail provided during the Fiscal Year 2023 budget request process.

244 SECTION 13. The money herein appropriated shall be paid by 245 the State Treasurer out of any money in the State Treasury to the 246 credit of the proper fund or funds as set forth in this act, upon 247 warrants issued by the State Fiscal Officer; and the State Fiscal 248 Officer shall issue his warrants upon requisitions signed by the 249 proper person, officer or officers in the manner provided by law. 250 SECTION 14. This act shall take effect and be in force from 251 and after July 1, 2022, and shall stand repealed from and after 252 June 30, 2022, and shall stand repealed from and after June 29,
