16 With the funds herein appropriated, it shall be the agency's responsibility to make certain that funds required for Personal 17 Services for Fiscal Year 2024 do not exceed Fiscal Year 2023 funds 18 19 appropriated for that purpose unless programs or positions are 20 added to the agency's Fiscal Year 2023 budget by the Mississippi Legislature. The Legislature shall determine the agency's 21 22 personal services appropriation, which shall be published by the 23 State Personnel Board. Additionally, the State Personnel Board 24 shall determine and publish the projected annualized payroll costs 25 based on current employees. It shall be the responsibility of the 26 agency head to ensure that actual personnel expenditures for 27 Fiscal Year 2023 do not exceed the data provided by the 28 Legislative Budget Office. If the agency's Fiscal Year 2023 29 projected cost exceeds the annualized costs, no salary actions 30 shall be processed by the State Personnel Board with the exception 31 of new hires that are determined to be essential for the agency.

Any transfers or escalations shall be made in accordance with the terms, conditions and procedures established by law or allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or positions

39 without proof of availability of new or additional funds above the 40 appropriated level.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

None of the funds herein appropriated shall be used in violation of Internal Revenue Service's Publication 15-A relating to the reporting of income paid to contract employees, as interpreted by the Office of the State Auditor.

Funds have been appropriated herein for the purpose of funding Project SEC2 minimum salaries for all employees covered under the Colonel Guy Groff/Neville Kenning Variable Compensation Plan. It shall be the agency's responsibility to ensure that the funds are used to increase all employees' salaries up to the minimum level as determined by the State Personnel Board.

55 SECTION 3. Of the funds appropriated in this act, it is the intention of the Legislature that the State Board of Contractors 56 57 may expend funds not to exceed Two Million Three Hundred Thousand 58 Dollars (\$2,300,000.00) for the purpose of defraying the cost of 59 (1) enforcement as set forth in Section 31-3-21, Mississippi Code 60 of 1972, (2) enlisting of any private collection firm(s) to locate and collect any uncollected fines, and (3) administrative costs 61 associated with collections. Any funds spent for this purpose 62

63 shall be subject to a performance audit if requested by the64 Appropriations Chairmen in either the House or Senate.

65 **SECTION 4.** It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the 66 67 purchase of commodities or equipment, and whenever all things 68 stated in such received bids are equal with respect to price, 69 quality and service, the Mississippi Industries for the Blind 70 shall be given preference. A similar preference shall be given to 71 the Mississippi Industries for the Blind whenever purchases are 72 made without competitive bids.

SECTION 5. It is the intention of the Legislature that the funds herein appropriated shall be expended in compliance with Section 27-104-25, Mississippi Code of 1972, that no state agency shall incur obligations or indebtedness in excess of their appropriation and that the responsible officers, either personally or upon their official bonds, shall be held responsible for actions contrary to this provision.

SECTION 6. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law.

86 **SECTION 7.** This act shall take effect and be in force from 87 and after July 1, 2022.
