

## Senate Amendments to House Bill No. 1035

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

### AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

11        SECTION 1. (1) The Mississippi Commission on Wildlife,  
12 Fisheries and Parks shall establish and regulate special hunts  
13 during velvet hunting season, outside of the regular open season  
14 on deer. Velvet hunting season shall begin on September 10, and  
15 end no later than September 20, and shall be for no less than  
16 three (3) consecutive days in length, and for no more than five  
17 (5) consecutive days in length, and only hunting with bow and  
18 arrow or crossbows shall be allowed during such season. The  
19 special season shall be open on private lands and any Wildlife  
20 Management Areas as deemed appropriate by the department. Only  
21 bucks that meet the antler criteria for the respective deer  
22 management unit may be harvested.

23        (2) The commission shall establish a special hunting permit  
24 for velvet hunting season. Such special hunting permit for velvet  
25 hunting season shall be authorized for a time period beginning on  
26 September 10, and ending no later than September 20, and shall be  
27 valid for no less than three (3) consecutive days in length, and

28 for no more than five (5) consecutive days in length. The  
29 commission shall, set the cost of permits.

30 **SECTION 2.** Section 49-7-31, Mississippi Code of 1972, is  
31 amended as follows:

32 49-7-31. (1) The open season on deer shall be as follows:

33 (a) With bow and arrow: October 1 through the Friday  
34 prior to Thanksgiving.

35 (b) With guns and with dogs: from the Saturday prior  
36 to Thanksgiving through December 1.

37 (c) With primitive weapons and without dogs: December  
38 2 through December 15.

39 (d) With guns and without dogs: December 16 through  
40 December 23. However, the commission may allow hunting statewide  
41 or in specific areas with any legal weapon which it may designate  
42 without dogs after the end of the last season for hunting deer  
43 with guns and with dogs, but the season with legal designated  
44 weapons and without dogs shall not extend beyond January 31.

45 (e) The commission shall establish an extended season  
46 with primitive weapons and bow and arrow without dogs from  
47 February 1 through February 15 for the area south of U.S. Highway  
48 84 and east of Mississippi Highway 35 only for legal bucks. Any  
49 antlered deer taken in this area during any open season under this  
50 section must be a legal buck as defined in this paragraph. For  
51 purposes of this paragraph, the term "legal buck" means a deer  
52 with antlers of four (4) points or more with a minimum inside  
53 spread of ten (10) inches or a minimum main beam length of

54 thirteen (13) inches. The commission may regulate the taking of  
55 deer with antlers of four (4) points or less under this paragraph  
56 for the proper management of antlered deer. The commission may  
57 delay the opening date and change the length of bow and arrow  
58 season in paragraph (a) in this area.

59 (f) With guns and with dogs: December 24 through a  
60 date fixed by the commission that will provide a total of  
61 thirty-nine (39) days of hunting deer with guns and with dogs when  
62 added to the number of days provided for hunting deer with guns  
63 and with dogs in paragraph (b).

64 (g) When the open season on deer ends on a Friday, the  
65 commission shall have the authority to extend the season until  
66 thirty (30) minutes after sunset on the following Sunday.

67 (2) The commission may set and regulate the deer seasons on  
68 wildlife management areas which it administers.

69 (3) (a) The commission may allow the harvesting of  
70 antlerless deer in the districts or zones upon the recommendation  
71 of the executive director based upon good and substantial  
72 quantitative data and research evaluations that demonstrate that  
73 the harvesting is necessary to properly manage the herd.

74 (b) The commission, only upon the recommendation of the  
75 executive director, may allow the harvesting of antlerless deer  
76 during the deer season with guns and with dogs by a majority vote  
77 of the commission.

78 (c) Nothing in this subsection prohibits the harvesting  
79 of either-sex deer by landowners or leaseholders on private lands

80 under the deer management assistance program prescribed or  
81 approved by the executive director.

82 (4) The commission may provide a special permit for the  
83 harvesting of deer when they are depredating and destroying crops.  
84 The department shall supervise the harvesting and provide for the  
85 salvaging of the meat of the animals. The commission may  
86 authorize the department to assist any farmer in this state, who  
87 sustains crop damage by wildlife, in eradication of the problem  
88 wildlife.

89 (5) (a) During any open season on deer with primitive  
90 weapons after November 30, a person may use any legal weapon of  
91 choice on private lands only, if the person is:

92 (i) The title owner of the land;

93 (ii) The lessee of the hunting rights on the land;

94 (iii) A member of a hunting club leasing the  
95 hunting rights on the land; or

96 (iv) A guest of a person specified in subparagraph  
97 (i), (ii) or (iii).

98 (b) If the person is required to have a hunting  
99 license, the person must have a primitive weapon license,  
100 Sportsman's License or a Lifetime Sportsman's License.

101 (6) The commission shall establish and regulate special  
102 hunts during velvet hunting season, outside of the regular open  
103 season on deer, as provided in Section 1 of this act.

104 **SECTION 3.** This act shall take effect and be in force from  
105 and after July 1, 2022, and shall stand repealed on June 30, 2022.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1           AN ACT TO REQUIRE THE COMMISSION ON WILDLIFE, FISHERIES AND  
2   PARKS TO ESTABLISH AND REGULATE SPECIAL HUNTS DURING VELVET  
3   HUNTING SEASON; TO PROVIDE THAT VELVET HUNTING SEASON SHALL BEGIN  
4   ON SEPTEMBER 10 AND END SEPTEMBER 20; TO REQUIRE THE COMMISSION TO  
5   ESTABLISH A SPECIAL HUNTING PERMIT FOR VELVET HUNTING SEASON; TO  
6   AMEND SECTION 49-7-31, MISSISSIPPI CODE OF 1972, WHICH RELATES TO  
7   OPEN SEASON ON DEER, TO REQUIRE THE COMMISSION TO ESTABLISH AND  
8   REGULATE SPECIAL HUNTS DURING VELVET HUNTING SEASON; AND FOR  
9   RELATED PURPOSES.
