Senate Amendments to House Bill No. 1550

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

8	SECTION 1. The following sum, or so much of it as may be
9	necessary, is appropriated out of any money in the Capital Expense
10	Fund not otherwise appropriated, to the Department of Finance and
11	Administration for the purpose of providing funds for the first
12	phase of construction for the new Department of Public Safety
13	headquarters building, for the fiscal year beginning July 1, 2021,
14	and ending June 30, 2022\$ 39,400,000.00.
15	SECTION 2. In addition to all other sums herein
16	appropriated, the following sum, or so much thereof as may be
17	necessary, is hereby appropriated out of any money in the Capital
18	Expense Fund not otherwise appropriated, to the State Department
19	of Health for the purpose of providing reimbursable grants as
20	described in this section, for the period beginning July 1, 2021,
21	and ending June 30, 2022\$ 9,852,684.00.
22	The funds appropriated under this section shall be expended
23	by the State Department of Health as a reimbursable grant to
24	entities up to the difference between the 2021 and 2022 Victims of
	H. B. 1550

- 25 Crime Act (VOCA) grants awarded by the Department. In determining
- 26 reimbursable expenses, the State Department of Health shall use
- 27 allowable costs for VOCA funds as defined by the Office for
- 28 Victims of Crime.
- 29 **SECTION 3.** The money appropriated by this act shall be paid
- 30 by the State Treasurer out of any money in the Capital Expense
- 31 Fund not otherwise appropriated, upon warrants issued by the State
- 32 Fiscal Officer, and the State Fiscal Officer shall issue his
- 33 warrants upon requisitions signed by the proper person, officer or
- 34 officers in the manner provided by law.
- 35 **SECTION 4.** This act shall take effect and be in force from
- 36 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:
