Adopted COMMITTEE AMENDMENT NO 1 PROPOSED TO

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

8 SECTION 1. In addition to all other sums appropriated to the 9 department, the following sum, or so much of it as may be necessary, is appropriated out of any money in the Law Enforcement 10 11 Officers and Fire Fighters Death Benefits Trust Fund not otherwise 12 appropriated, to the Mississippi Department of Public Safety for 13 the purposes described in Section 45-2-1, for the fiscal year beginning July 1, 2021, and ending June 30, 2022...\$ 5,000,000.00. 14 15 SECTION 2. The funds appropriated under Section 1 of this 16 act may only be spent on the payment of death benefits for which



- 17 the cause of death is a death covered under the Safeguarding
- 18 America's First Responders Act of 2020.
- 19 **SECTION 3.** (1) As used in this section and Section 4 of
- 20 this act, the term "department" means the Department of Public
- 21 Safety.
- 22 (2) The department shall not disburse any funds appropriated
- 23 under this act to any recipient without first: (a) making an
- 24 individualized determination that the reimbursement sought is, in
- 25 the department's independent judgment, for necessary expenditures
- 26 eligible under Section 602 of the federal Social Security Act as
- 27 added by Section 9901 of the federal American Rescue Plan Act of
- 28 2021 (ARPA) and its implementing guidelines, guidance, rules,
- 29 regulations and/or other criteria, as may be amended or
- 30 supplemented from time to time, by the United States Department of
- 31 the Treasury; and (b) determining that the recipient has not
- 32 received and will not receive reimbursement for the expense in
- 33 question from any source of funds, including insurance proceeds,
- 34 other than those funds provided under Section 602 of the federal
- 35 Social Security Act as added by Section 9901 of ARPA. In
- 36 addition, the department shall ensure that all funds appropriated
- 37 under this act are disbursed in compliance with the Single Audit
- 38 Act (31 USC Sections 7501-7507) and the related provisions of the
- 39 Uniform Guidance, 2 CFR Section 200.303 regarding internal
- 40 controls, Sections 200.330 through 200.332 regarding sub-recipient



- 41 monitoring and management, and subpart F regarding audit
- 42 requirements.
- 43 **SECTION 4.** (1) As a condition of receiving and expending
- 44 the funds appropriated to the department under this act, the
- 45 department shall certify to the Department of Finance and
- 46 Administration that each expenditure of the funds appropriated to
- 47 the department under this act complies with the guidelines,
- 48 guidance, rules, regulations and/or other criteria, as may be
- 49 amended from time to time, of the United States Department of the
- 50 Treasury regarding the use of monies from the Coronavirus State
- 51 Fiscal Recovery Fund established by the American Rescue Plan Act
- 52 of 2021.
- 53 (2) If the Office of Inspector General of the United States
- 54 Department of the Treasury, or the Office of Inspector General of
- 55 any other federal agency having oversight over the use of monies
- 56 from the Coronavirus State Fiscal Recovery Fund established by the
- 57 American Rescue Plan Act of 2021 (a) determines that the
- 58 department or recipient has expended or otherwise used any of the
- 59 funds appropriated to the department under this act for any
- 60 purpose that is not in compliance with the guidelines, guidance,
- 61 rules, regulations and/or other criteria, as may be amended from
- 62 time to time, of the United States Department of the Treasury
- 63 regarding the use of monies from the Coronavirus State Fiscal
- 64 Recovery Fund established by the American Rescue Plan Act of 2021,
- 65 and (b) the State of Mississippi is required to repay the federal

- 66 government for any of those funds that the Office of the Inspector
- 67 General determined were expended or otherwise used improperly by
- 68 the department or recipient, then the department or recipient that
- 69 expended or otherwise used those funds improperly shall be
- 70 required to pay the amount of those funds to the State of
- 71 Mississippi for repayment to the federal government.
- 72 **SECTION 5.** This act shall take effect and be in force from
- 73 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO MAKE AN ADDITIONAL APPROPRIATION FROM THE LAW
ENFORCEMENT OFFICERS AND FIRE FIGHTERS DEATH BENEFITS TRUST FUND
TO THE MISSISSIPPI DEPARTMENT OF PUBLIC SAFETY; TO PROVIDE THAT
SUCH FUNDS MAY ONLY BE SPENT ON THE PAYMENT OF DEATH BENEFITS FOR
WHICH THE CAUSE OF DEATH IS A DEATH COVERED UNDER THE SAFEGUARDING
AMERICA'S FIRST RESPONDERS ACT OF 2020; AND FOR RELATED PURPOSES.
