COMMITTEE AMENDMENT NO 1 PROPOSED TO**

**House Bill No. 1600**

**BY: Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

50 **SECTION 3.** Of the funds appropriated in Section 2, One  
51 Hundred Twenty-six Thousand Four Hundred Seventy-two Dollars  
52 (\$126,472.00), or so much of that sum as may be necessary, is  
53 appropriated out of any money in the State Treasury to the credit  
54 of the Health Care Expendable Fund to the State Department of  
55 Education for the purpose of defraying the expenses of the  
56 department for the Mississippi Eye Screening Program for providing  
57 vision safety services.

58 **SECTION 4.** Of the funds appropriated in Section 2, the  
59 following sums, or so much of those sums as may be necessary, are  
60 derived out of any money in the State Treasury to the credit of  
61 the Education Enhancement Fund pursuant to Sections 27-65-75 and

107 With the funds herein appropriated, it shall be the agency's  
 108 responsibility to make certain that funds required for Personal  
 109 Services for Fiscal Year 2024 do not exceed Fiscal Year 2023 funds  
 110 appropriated for that purpose unless programs or positions are  
 111 added to the agency's Fiscal Year 2023 budget by the Mississippi  
 112 Legislature. The Legislature shall determine the agency's



113 personal services appropriation, which shall be published by the  
114 State Personnel Board. Additionally, the State Personnel Board  
115 shall determine and publish the projected annualized payroll costs  
116 based on current employees. It shall be the responsibility of the  
117 agency head to ensure that actual personnel expenditures for  
118 Fiscal Year 2023 do not exceed the data provided by the  
119 Legislative Budget Office. If the agency's Fiscal Year 2023  
120 projected cost exceeds the annualized costs, no salary actions  
121 shall be processed by the State Personnel Board with the exception  
122 of new hires that are determined to be essential for the agency.

123 Any transfers or escalations shall be made in accordance with  
124 the terms, conditions and procedures established by law or  
125 allowable under the terms set forth within this act. The State  
126 Personnel Board shall not escalate positions without written  
127 approval from the Department of Finance and Administration. The  
128 Department of Finance and Administration shall not provide written  
129 approval to escalate any funds for salaries and/or positions  
130 without proof of availability of new or additional funds above the  
131 appropriated level.

132 No general funds authorized to be expended herein shall be  
133 used to replace federal funds and/or other special funds which are  
134 being used for salaries authorized under the provisions of this  
135 act and which are withdrawn and no longer available.

136 None of the funds herein appropriated shall be used in  
137 violation of Internal Revenue Service's Publication 15-A relating



138 to the reporting of income paid to contract employees, as  
139 interpreted by the Office of the State Auditor.

140 Funds have been appropriated herein for the purpose of  
141 funding Project SEC2 minimum salaries for all employees covered  
142 under the Colonel Guy Groff/Neville Kenning Variable Compensation  
143 Plan. It shall be the agency's responsibility to ensure that the  
144 funds are used to increase all employees' salaries up to the  
145 minimum level as determined by the State Personnel Board.

146 **SECTION 6.** In compliance with the "Mississippi Performance  
147 Budget and Strategic Planning Act of 1994," it is the intent of  
148 the Legislature that the funds provided in this act shall be  
149 utilized in the most efficient and effective manner possible to  
150 achieve the intended mission of the State Department of Education,  
151 excluding the expenses of the Vocational and Technical Education  
152 Division. Based on the funding authorized, this agency shall make

269 A reporting of the degree to which the performance targets  
270 set above have been or are being achieved shall be provided in the  
271 agency's budget request submitted to the Joint Legislative Budget  
272 Committee for Fiscal Year 2024.

273 **SECTION 7.** No school district shall expend any funds,  
274 received under the School Ad Valorem Reduction Grant, unless such  
275 school district has specifically identified the amount of the  
276 grant within the published budget as required by Section 37-61-9,  
277 Mississippi Code of 1972. The published budget shall include the  
278 following statement: "Ad Valorem taxes will be \$\_\_\_\_\_ less as  
279 a result of the Ad Valorem Reduction Grants enacted by the  
280 Mississippi Legislature in 1992."

281 **SECTION 8.** Of the funds appropriated in Section 2, funds in  
282 the amount of One Million Dollars (\$1,000,000.00) shall come from  
283 income derived from the principal of the Education Improvement  
284 Trust Fund created by Section 206A, Mississippi Constitution of  
285 1890, and One Million Dollars (\$1,000,000.00) shall be used for  
286 the School for Math and Science.



287           **SECTION 9.** Of the funds appropriated under the provisions of  
288 this act, the following positions are authorized for the  
289 Vocational and Technical Education Division of the State  
290 Department of Education:

337 Eighty-four Dollars (\$229,684.00) is authorized for the support of  
338 vocational and technical education programs as authorized in  
339 Section 37-31-13, Mississippi Code of 1972, for a period in excess  
340 of ten (10) months in a calendar year.

341 **SECTION 11.** It is the intention of the Legislature that the  
342 Vocational and Technical Education Division of the State  
343 Department of Education shall, with the funds appropriated in  
344 Section 1, transfer no more than Seventy-five Thousand Dollars  
345 (\$75,000.00) to the Mississippi Soil and Water Conservation  
346 Commission for the purpose of providing matching funds to purchase  
347 soil conservation equipment.

348 **SECTION 12.** Of the funds appropriated in this act, no more  
349 than One Hundred Seventy-five Thousand Dollars (\$175,000.00) is  
350 provided for the purpose of supporting the Future Farmers of  
351 America Center.

352 **SECTION 13.** The State Department of Education shall transfer  
353 the designated amounts to the appropriate entities, which shall  
354 assume full responsibility for the expenditure of these funds in  
355 accordance with state laws and accept all responsibility for any  
356 improper expenditure, for the following:

375       **SECTION 14.** Of the funds appropriated in this act, an amount  
376 not to exceed One Million Five Hundred Thousand Dollars  
377 (\$1,500,000.00) shall be used for technological methods for  
378 agricultural programs, computer science, engineering or robotic  
379 engineering programs and equipment upgrades and Mississippi  
380 Elementary (ME) STEM and STEAM programs from the Career and  
381 Technical Education Division of the State Department of Education.  
382 All programs must meet Mississippi Science Standards and/or  
383 College and Career Standards.

384       Of the funds appropriated in this section, an amount not to  
385 exceed One Million Dollars (\$1,000,000.00) shall be distributed to  
386 the Mississippi State University Center for Cyber Education and





387 used for computer science programs development and teacher  
388 training for elementary schools, middle schools, and high schools  
389 for the purpose of developing K-12 computer science curricula,  
390 including both academic and career and technical education  
391 programs, developing and delivering teacher training, and working  
392 with the State Board of Education and Institutions of Higher  
393 Learning in the state to develop teacher preparation programs for  
394 computer science endorsements. All programs must meet the 2018  
395 Mississippi Computer Science Standards and/or Mississippi College  
396 and Career Standards.

397       **SECTION 15.** Of the funds appropriated in Section 1, the sum  
398 of Sixty-two Thousand One Hundred Ninety-one Dollars (\$62,191.00),  
399 which is the aggregate sum that the school districts in the  
400 Chickasaw Cession receive annually from interest payments from the  
401 Chickasaw School Fund under Section 212, Mississippi Constitution  
402 of 1890, shall be deducted from the allocations to the school  
403 districts as provided in Section 29-3-137, Mississippi Code of  
404 1972, and shall be distributed among the school districts in the  
405 Chickasaw Cession by the State Department of Education in the  
406 manner that those interest payments were distributed during Fiscal  
407 Year 1985.

408       **SECTION 16.** Of the funds provided in this act for the  
409 purpose of funding the Mississippi Adequate Education Program as  
410 determined under Section 37-151-7, Mississippi Code of 1972, the



411 base student cost in Fiscal Year 2023 shall be Six Thousand Five  
412 Hundred Thirty-two Dollars and Twenty Cents (\$6,532.20).

413 **SECTION 17.** With the funds provided in this act, it is the  
414 intention of the Legislature that School Attendance Officers and  
415 academic teachers at the Mississippi School for the Deaf and the  
416 Mississippi School for the Blind shall receive their annual  
417 increment.

418 **SECTION 18.** It is the intention of the Legislature that the  
419 State Board of Education shall maintain complete accounting and  
420 personnel records related to the expenditure of all funds  
421 appropriated in this act and that those records shall be in the  
422 same format and level of detail as maintained for Fiscal Year  
423 2022. It is further the intention of the Legislature that the  
424 budget requests for Fiscal Year 2024 shall be submitted to the  
425 Joint Legislative Budget Committee in a format and level of detail  
426 comparable to the format and level of detail provided during the  
427 Fiscal Year 2023 budget request process for each agency and  
428 institution appropriated funds within the provisions of this act.

429 **SECTION 19.** Of the funds appropriated in Section 1(a) to the  
430 State Board of Education, not less than Twenty-three Million  
431 Eighty Thousand Dollars (\$23,080,000.00) shall be used for  
432 National Board Certification. Of this amount, Six Hundred  
433 Thousand Dollars (\$600,000.00) shall be used for the World Class  
434 Teacher Program providing instruction and assistance to teachers  
435 seeking National Board Certification.



436           **SECTION 20.** Of the funds appropriated in Section 1 and  
437 Section 4(a) not less than Fifteen Million Fifty-eight Thousand  
438 Dollars (\$15,058,000.00) shall be used for the Educable Child  
439 Program. It is the intention of the Legislature that the State  
440 Board of Education shall allocate funding for the Educable Child  
441 Program based upon a recalculated formula in a manner to include  
442 only those billable days funded through appropriation of state  
443 funds and not District funds. It is the intent of the Legislature  
444 that the Educable Child funds shall be exempt from budget cuts  
445 made to the Department of Education by the Legislature and/or the  
446 Office of the Governor.

447           **SECTION 21.** Of the funds appropriated in Section 1(a) and  
448 Section 4(a), not less than Three Million Dollars (\$3,000,000.00)  
449 shall be used for the Education Scholarship Account (ESA) Program.  
450 It is the intent of the Legislature that the Education Scholarship  
451 Account (ESA) funds shall not be reduced by the State Department  
452 of Education and/or the Office of the Governor.

453           **SECTION 22.** The public school districts of the state are  
454 authorized at their discretion to pay with local funds one hundred  
455 percent (100%) of the cost of the health insurance premiums of the  
456 State and School Employees Health Insurance Plan for all retired  
457 members of the Public Employees' Retirement System who are  
458 employed as school bus drivers by the school districts. It is the  
459 intention of the Legislature that no state funds shall be used for  
460 this purpose.



461           **SECTION 23.** It is the intention of the Legislature that  
462 whenever two (2) or more bids are received by this agency for the  
463 purchase of commodities or equipment, and whenever all things  
464 stated in those received bids are equal with respect to price,  
465 quality and service, the Mississippi Industries for the Blind  
466 shall be given preference. A similar preference shall be given to  
467 the Mississippi Industries for the Blind whenever purchases are  
468 made without competitive bids.

469           **SECTION 24.** Of the funds appropriated in Section 1, not less  
470 than Six Million Three Hundred Twenty-one Thousand Nine Hundred  
471 Twenty-seven Dollars (\$6,321,927.00) shall be used for the  
472 Compulsory School Attendance Office and School Attendance  
473 Officers.

474           **SECTION 25.** Of the funds appropriated in this act, it is the  
475 intention of the Legislature that Three Million Sixty Thousand  
476 Dollars (\$3,060,000.00) shall be used for the Mary  
477 Kirkpatrick-Mary Sprayberry Public School Nurse Program. The  
478 amount of Three Million Sixty Thousand Dollars (\$3,060,000.00) is  
479 provided from the Department of Health.

480           **SECTION 26.** The State Department of Education shall contract  
481 with a Certified Public Accountant to calculate components of the  
482 Mississippi Adequate Education Program to include the base student  
483 cost, school district allocations, total program cost, add-on  
484 programs, and any other required components of Section 37-151-7,  
485 Mississippi Code of 1972. The contractor shall be responsible for



486 calculating the estimates of these components due to the  
487 Legislative Budget Office and the Governor by August 1 and the  
488 final estimates due to the Legislative Budget Office and the  
489 Governor no later than January 2. A report detailing the funding  
490 of this contract shall be submitted by the State Department of  
491 Education to the Legislature no later than January 30, 2023.

492 **SECTION 27.** Of the funds appropriated in this act, it is the  
493 intention of the Legislature that Twenty Million Dollars  
494 (\$20,000,000.00) from the Public School Building Fund shall be  
495 used for the Mississippi Adequate Education Program.

496 **SECTION 28.** It is the intention of the Legislature that the  
497 State Board of Education shall charge a fee for room and board for  
498 students who enroll in the Mississippi School for Mathematics and  
499 Science and the Mississippi School of Arts. Such fees will be  
500 waived for any student enrolled in the State Children's Health  
501 Insurance Program. The amount of such fees shall be Five Hundred  
502 Dollars (\$500.00) for each semester.

503 **SECTION 29.** It is the intent of the Legislature that each  
504 eligible employee who meets the National Board requirements under  
505 Section 37-19-7(2), Mississippi Code of 1972, shall be paid the  
506 full supplement and that such supplement shall be included on a  
507 prorated basis in the employee's monthly paycheck.

508 **SECTION 30.** It is the intention of the Legislature that the  
509 Mississippi Department of Education may loan any general or  
510 special source fund amount, not to exceed Five Million Dollars



511 (\$5,000,000.00), to any school district for the purpose of  
512 providing funds to school districts through the Emergency  
513 Assistance Fund as outlined in Section 37-17-6, Mississippi Code  
514 of 1972, during the period beginning July 1, 2022, and ending  
515 June 30, 2023. The school districts receiving these loans shall  
516 repay the Mississippi Department of Education the amount of the  
517 loan on or before June 30, 2023.

518 **SECTION 31.** Of the funds appropriated in Section 1(a), Seven  
519 Hundred Thousand Dollars (\$700,000.00) shall be transferred to the  
520 Board of Health no later than December 31, 2022.

521 **SECTION 32.** Any school district receiving funds through Save  
522 the Children and Stride may provide a ten percent (10%) match from  
523 local funds for implementation of the program.

524 **SECTION 33.** Of the funds appropriated in Section 1(a), Two  
525 Million Dollars (\$2,000,000.00) is provided for the Mississippi  
526 Community Oriented Policing Services in Schools (MCOPS) grant  
527 program. A portion of these funds not to exceed three percent (3%)  
528 may be used for training and administrative costs related to  
529 oversight and auditing of the program.

530 **SECTION 34.** Of the funds appropriated in Section 1(a) and  
531 Section 2(a), Sixteen Million Dollars (\$16,000,000.00) is provided  
532 for an Early Childhood Education Initiative program. The funding  
533 shall be provided to early learning collaboratives in Fiscal Year  
534 2023 as follows: no less than Two Thousand Five Hundred Dollars  
535 (\$2,500.00) per student in a full-day program and no less than One



536 Thousand Two Hundred Fifty Dollars (\$1,250.00) per student in a  
537 half-day program. Funds must be matched as provided by Section  
538 37-21-51.

539 **SECTION 35.** Of the funds appropriated in Section 1(a) and  
540 Section 4(a), Fifteen Million Ninety-four Thousand Five Hundred  
541 Dollars (\$15,094,500.00) shall be used for the Literacy Initiative  
542 and Assessment.

543 **SECTION 36.** Of the funds appropriated herein, funding is  
544 provided for the ACT test, which is the college readiness portion  
545 of the state accountability model.

546 **SECTION 37.** Of the funds appropriated in Section 1(a), Two  
547 Million Six Hundred Sixty-seven Thousand Three Hundred  
548 Thirty-seven Dollars (\$2,667,337.00) shall be used for the  
549 Mississippi School of the Arts and Three Million Eight Hundred  
550 Eighty-two Thousand Eight Hundred Ninety-four Dollars  
551 (\$3,882,894.00) shall be used for the Mississippi School for  
552 Mathematics and Science. It is the intention of the Legislature  
553 that of the funds appropriated in Section 1(a) for the Mississippi  
554 School of the Arts, One Million Three Hundred Thirty-three  
555 Thousand Six Hundred Sixty-nine Dollars (\$1,333,669.00) shall be  
556 paid to the school no later than July 10, 2022, and One Million  
557 Three Hundred Thirty-three Thousand Six Hundred Sixty-nine Dollars  
558 (\$1,333,669.00) shall be paid no later than January 10, 2023. All  
559 funds appropriated from Section 4(a) for the Mississippi School of  
560 the Arts shall be paid to the school each month within ten (10)



561 working days after such amount was received by the Department of  
562 Education. It is the intention of the Legislature that the State  
563 Board of Education shall not reduce the appropriated amounts  
564 provided in this act for the Mississippi School of the Arts and  
565 the Mississippi School for Mathematics and Science.

566         **SECTION 38.** Of the funds appropriated in Section 1(b) and  
567 Section 2(b), Five Hundred Thousand Dollars (\$500,000.00) is  
568 provided for career and technical grants to schools for qualified  
569 students as authorized by Section 37-153-15, Mississippi Code of  
570 1972.

571         **SECTION 39.** Of the funds appropriated in this act, the  
572 following amounts shall be available to the Schools for the Blind  
573 and Deaf: Nine Million Nine Hundred Ninety Thousand One Hundred  
574 Seventy-six Dollars (\$9,990,176.00) from Section 1(a), One Million  
575 Two Hundred Seven Thousand Thirty-seven Dollars (\$1,207,037.00)  
576 from Section 4(a), and Two Million One Hundred Fifty-nine Thousand  
577 Seven Hundred Twenty-five Dollars (\$2,159,725.00) from Section  
578 2(a).

579         **SECTION 40.** Of the funds appropriated in Section 1(a), an  
580 amount not to exceed One Hundred Seventy-seven Million Two Hundred  
581 Thirty-seven Thousand Four Hundred Eighty-one Dollars  
582 (\$177,237,481.00) shall be allocated for the purpose of providing  
583 funds to each public school district in the state for an annual  
584 salary increase as prescribed in the Minimum Salary Schedule in





585 Sections 37-19-7 and 37-21-7, for the 2022-2023 school year, and  
586 school years thereafter.

587       **SECTION 41.** Of the funds appropriated in this act, an amount  
588 not to exceed Four Million Six Hundred Eighty Thousand Four  
589 Hundred Fourteen Dollars (\$4,680,414.00) is authorized to fully  
590 fund the contract between the Department of Education and the  
591 Research & Curriculum Unit at Mississippi State University to fund  
592 career and technical curricula, services to secondary schools and  
593 career and technical assessments.

594       **SECTION 42.** The following sum, or so much thereof as may be  
595 necessary, is reappropriated out of any money in the Education  
596 Enhancement Fund not otherwise appropriated for the Department of  
597 Education for the purpose of reauthorizing the expenditure of  
598 Education Enhancement Fund, as authorized in HB 1387, 2021 Regular  
599 Session, to provide upgrades for the Mississippi Student  
600 Information System for the fiscal year beginning July 1, 2022, and  
601 ending June 30, 2023.....\$ 5,100,000.00.

602       Notwithstanding the amount reappropriated under the  
603 provisions of this section, in no event shall the amount expended  
604 exceed the unexpended balance as of June 30, 2022.

605       **SECTION 43.** The money appropriated in this act shall be paid  
606 by the State Treasurer out of any money in the proper fund or  
607 funds as set forth in this act, upon warrants issued by the State  
608 Fiscal Officer; and the State Fiscal Officer shall issue his



609 warrants upon requisitions signed by the proper person, officer or  
610 officers in the manner provided by law.

611         **SECTION 44.** It is the intent of the Legislature that each  
612 eligible professional school counselor employee who meets the year  
613 of teaching experience requirements under Section 37-151-5(m),  
614 Mississippi Code of 1972, shall be considered having a year of  
615 experience for purposes of the annual experience salary increment.

616         **SECTION 45.** This act shall take effect and be in force from  
617 and after July 1, 2022, and shall stand repealed June 29, 2022.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**
