Amend by striking all after the enacting clause and inserting in lieu thereof the following:

L 8	SECTION 3. None of the funds appropriated by this act shall

23	or regulations that implement state or federal law.
24	SECTION 4. Of the funds appropriated under the provisions of
25	Section 1 of this act and authorized for expenditure under the
26	provisions of Section 2 of this act, not more than the amounts set
27	forth below shall be expended; however, notwithstanding any other
28	provision in this act, it is the intent of the Legislature that
29	any amount of funds and positions may be transferred between the
30	Department of Human Services and the Department of Child
31	Protection Services in order to comply with agreements made by the
32	State of Mississippi with the United States District Court in
33	reference to the Olivia Y., et al. lawsuit.

- No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.
- None of the funds herein appropriated shall be used in violation of Internal Revenue Service's Publication 15-A relating to the reporting of income paid to contract employees, as interpreted by the Office of the State Auditor.
- Funds have been appropriated herein for the purpose of
  funding Project SEC2 minimum salaries for all employees covered
  under the Colonel Guy Groff/Neville Kenning Variable Compensation
  Plan. It shall be the agency's responsibility to ensure that the
  funds are used to increase all employees' salaries up to the
  minimum level as determined by the State Personnel Board.
- SECTION 5. It is the intention of the Legislature that the
  Department of Human Services and Department of Child Protection



- 138 Services shall maintain complete accounting and personnel records
- 139 related to the expenditure of all funds appropriated under this

- 147 **SECTION 6.** Of the funds appropriated in Section 2 herein to
- 148 the Department of Human Services, One Million Dollars
- 149 (\$1,000,000.00) shall be transferred to the Department of Health,
- 150 Child Care Licensure Program from the Child Care Development Fund
- 151 or other appropriate special fund. These funds are to be
- transferred to the Board of Health no later than July 31, 2022.
- 153 The Department of Health shall make a complete accounting to the
- 154 Department of Human Services detailing the uses of these funds in
- 155 accordance with federal and state regulations.
- 156 **SECTION 7.** It is the intention of the Legislature that
- 157 whenever two (2) or more bids are received by this agency for the
- 158 purchase of commodities or equipment, and whenever all things
- 159 stated in such received bids are equal with respect to price,
- 160 quality and service, the Mississippi Industries for the Blind
- 161 shall be given preference. A similar preference shall be given to



- 162 the Mississippi Industries for the Blind whenever purchases are
- 163 made without competitive bids.
- 164 **SECTION 8.** The Department of Human Services and the
- 165 Department of Child Protection Services are authorized to expend
- 166 available funds on technology or equipment upgrades or
- 167 replacements when it will generate savings through efficiency or
- 168 when the savings generated from such upgrades or replacements
- 169 exceed expenditures thereof.
- 170 **SECTION 9.** It is the intention of the Legislature that none
- 171 of the funds provided herein shall be used to pay certain
- 172 utilities for state furnished housing for any employees. Such
- 173 utilities shall include electricity, natural gas, butane, propane,
- 174 cable and phone services. Where actual cost cannot be determined,
- 175 the agency shall be required to provide meters to be in compliance
- 176 with legislative intent. Such state furnished housing shall
- 177 include single-family and multi-family residences but shall not
- 178 include any dormitory residences. Allowances for such utilities
- 179 shall be prohibited.
- 180 **SECTION 10.** In compliance with the "Mississippi Performance
- 181 Budget and Strategic Planning Act of 1994," it is the intent of
- 182 the Legislature that the funds provided herein shall be utilized
- 183 in the most efficient and effective manner possible to achieve the
- 184 intended mission of this agency. Based on the funding authorized,
- 185 this agency shall make every effort to attain the targeted
- 186 performance measures provided below:

285	SECTION 11. It is the intent of the Legislature that the

Department of Human Services, Division of Child Support

- 287 Enforcement, make a concentrated effort to increase collections of
- 288 past due child support payments. On or before January 1, 2023,
- 289 the Executive Director of the Department of Human Services shall
- 290 submit a report to the Legislative Budget Office detailing
- 291 year-to-date performance measures in the Child Support Enforcement
- 292 Program compared with the prior year.
- 293 **SECTION 12.** It is the intention of the Legislature that the
- 294 Department of Human Services shall have the authority to spend
- 295 such additional funds as it shall receive from the federal
- 296 government in incentives or the federal match on those incentives
- 297 for the purpose of child support enforcement.
- 298 **SECTION 13.** Of the funds appropriated in Section 1, Two
- 299 Hundred Fifty Thousand Dollars (\$250,000.00) shall be transferred
- 300 to the Juvenile Facility Monitoring Unit at the Department of
- 301 Public Safety no later than July 31, 2022.
- 302 **SECTION 14.** Of the funds appropriated herein, to the
- 303 Department of Human Services One Million Dollars (\$1,000,000.00),
- 304 is provided for the support of the Home Delivered Meals Program
- 305 and any additional funds that may be appropriated to this program.
- 306 **SECTION 15.** Of the funds provided in Section 1, herein to
- 307 the Department of Human Services, an amount not to exceed One
- 308 Hundred Thousand Dollars (\$100,000.00) is provided to fund the
- 309 Senior Olympics Program.
- 310 **SECTION 16.** Of the funds appropriated in Section 1, herein
- 311 to the Department of Child Protection Services, it is the

- 312 intention of the Legislature that Ninety-three Thousand Six
- 313 Hundred One Dollars (\$93,601.00) shall be allocated to the
- 314 Mississippi Children's Trust Fund supported from General Fund
- 315 court assessments.
- 316 **SECTION 17.** It is the intention of the Legislature that the
- 317 Governor's Office, Division of Medicaid and the Department of
- 318 Human Services shall continue to work together to implement HB
- 319 1090 of the 2017 Regular Session, known as the "Medicaid and Human
- 320 Services Transparency and Fraud Prevention Act".
- 321 **SECTION 18.** Of the funds appropriated by this act, pursuant
- 322 to HB 571, 2019 Regular Session, Two Hundred Fifty Thousand
- 323 Dollars (\$250,000.00) is provided for maintaining a 24-hour
- 324 hotline that is to be manned at all times, and for a coordinator
- 325 to work with the Department of Public Safety, and to contract with
- 326 outside agencies or service providers to organize for the
- 327 provision of specialized services, including counseling services
- 328 and other appropriate care to children who have been victims of
- 329 commercial and sexual exploitation or human trafficking.
- 330 **SECTION 19.** As a condition of receiving and expending any
- 331 funds appropriated under this act, the Department of Human
- 332 Services:
- 333 (a) Shall use a competitive procurement process for
- 334 entering into all TANF subgrant agreements with non-state entities
- 335 when the federal government does not direct to whom the funds must
- 336 be subgranted;



331	(b) Upon awarding of a grant to any subgrantee of the
338	department, shall require the subgrantee to submit a monthly
339	report to the department that contains, but is not limited to, all

- 351 (c) Shall not advance funds to a subgrantee for more
- 352 than sixty (60) days; and
- 353 (d) Shall reimburse a subgrantee for expenses only
- 354 after the required documentation is provided and is approved by
- 355 the department.
- 356 **SECTION 20.** The following sum, or so much thereof as may be
- 357 necessary, is reappropriated out of any money in the Capital
- 358 Expense Fund not otherwise appropriated for the Department of
- 359 Child Protection Services for the purpose of reauthorizing the
- 360 expenditure of Capital Expense Fund, as reappropriated in HB 1398,
- 361 2021 Regular Session, for information technology system

364	Notwithstanding the amount reappropriated under the
365	provisions of this section, in no event shall the amount expended
366	exceed the unexpended balance as of June 30, 2022.
367	SECTION 21. The following sum, or so much thereof as may be
368	necessary, is reappropriated out of any money in the Capital
369	Expense Fund not otherwise appropriated for the Department of
370	Human Services for the purpose of reauthorizing the expenditure of
371	Capital Expense Funds, as authorized in HB 1398, 2021 Regular
372	Session to provide for computer expenses for the fiscal year
373	beginning July 1, 2022, and ending June 30, 2023
374	\$ 5,000,000.00
375	SECTION 22. It is the intent of the Legislature, that within
376	the funds available, the Department of Human Services may provide
377	any qualifying grants of CARES Act or American Rescue Act funding
378	in an amount not to exceed One Million Five Hundred Thousand
379	Dollars (\$1,500,000.00) to the three (3) regional food banks that
380	serve Mississippi, including Feed the Gulf Coast, Mid-South Food
381	Bank, and Mississippi Food Network.
382	SECTION 23. The money herein appropriated shall be paid by
383	the State Treasurer out of any money in the State Treasury to the
384	credit of the proper fund or funds as set forth in this act, upon
385	warrants issued by the State Fiscal Officer; and the State Fiscal

- Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law.
- 388 **SECTION 24.** This act shall take effect and be in force from and after July 1, 2022, and shall stand repealed June 29, 2022.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION TO THE DEPARTMENT OF HUMAN SERVICES; AND FOR RELATED PURPOSES, FOR THE FISCAL YEAR 2023.
