HOUSE BILL NO. 37

- AN ACT TO AMEND SECTION 19-5-171, MISSISSIPPI CODE OF
- 2 1972, TO DELETE THE PROVISION OF LAW PROVIDING FOR THE
- 3 COMPENSATION OF THE COMMISSIONERS OF THE STANDARD DEDEAUX WATER
- 4 DISTRICT; AND FOR RELATED PURPOSES.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 19-5-171, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 19-5-171. (1) Every resident citizen of the county in which
- 9 is located any district created under Sections 19-5-151 through
- 10 19-5-207, of good reputation, being the owner of land or the
- 11 conductor of a business situated within the district and being
- 12 over twenty-five (25) years of age and of sound mind and judgment,
- 13 shall be eligible to hold the office of commissioner.
- 14 (2) Except as provided in Section 19-5-164(3), each person
- 15 appointed or elected as a commissioner, before entering upon the
- 16 discharge of the duties of the person's office, shall be required
- 17 to execute a bond payable to the State of Mississippi in the penal
- 18 sum of not less than Fifty Thousand Dollars (\$50,000.00)

19 conditioned that the person will faithfully discharge the duties

- 20 of the office. Each bond shall be approved by the clerk of the
- 21 board of supervisors and filed with the clerk.
- 22 (3) Each commissioner shall take and subscribe to an oath of
- 23 office prescribed in Section 268, Mississippi Constitution of
- 24 1890, before the clerk of the board of supervisors that the person
- 25 will faithfully discharge the duties of the office of
- 26 commissioner, which oath shall also be filed with the clerk and
- 27 preserved with the official bond.
- 28 (4) Except as provided in subsection (5), the commissioners
- 29 so appointed or elected and qualified shall be compensated for
- 30 their services for each meeting of the board of commissioners
- 31 attended, either regular or special, at a rate to be fixed by the
- 32 board of supervisors, not to exceed the rate established in
- 33 Section 25-3-69 for officers of state boards, commissions and
- 34 agencies, and shall be reimbursed for all expenses necessarily
- 35 incurred in the discharge of their official duties in accordance
- 36 with Section 25-3-41. However, in no one (1) calendar year shall
- 37 any commissioner be compensated for more than twenty-four (24)
- 38 meetings.
- 39 (5) (a) The commissioners of the Hancock County Water and
- 40 Sewer District shall be compensated for their services at a rate
- 41 up to Eighty-four Dollars (\$84.00) per day for each meeting of the
- 42 board of commissioners attended, either regular or special, and
- 43 shall be reimbursed for all expenses necessarily incurred in the

- 44 discharge of their official duties in accordance with Section
- 45 25-3-41.
- 46 (b) The commissioners of the Kiln Utility and Fire
- 47 District of Hancock County shall be compensated for their services
- 48 at a rate up to Eighty-four Dollars (\$84.00) per day for each
- 49 meeting of the board of commissioners attended, either regular or
- 50 special, and shall be reimbursed for all expenses necessarily
- 51 incurred in the discharge of their official duties in accordance
- 52 with Section 25-3-41.
- 53 (c) The commissioners of the Pearlington Water and
- 54 Sewer District of Hancock County shall be compensated for their
- 55 services at a rate up to Eighty-four Dollars (\$84.00) per day for
- 56 each meeting of the board of commissioners attended, either
- 57 regular or special, and shall be reimbursed for all expenses
- 58 necessarily incurred in the discharge of their official duties in
- 59 accordance with Section 25-3-41.
- 60 (d) The commissioners of the Diamondhead Water and
- 61 Sewer District of Hancock County shall be compensated for their
- 62 services at a rate up to the Eighty-four Dollars (\$84.00) per day
- 63 for each meeting of the board of commissioners attended, either
- 64 regular or special, and shall be reimbursed for all expenses
- 65 necessarily incurred in the discharge of their official duties in
- 66 accordance with Section 25-3-41.
- 67 (e) The commissioners of the Hancock County Solid Waste
- 68 Authority shall be compensated for their services at a rate up to

- 69 the Eighty-four Dollars (\$84.00) per day for each meeting of the
- 70 board of commissioners attended, either regular or special, and
- 71 shall be reimbursed for all expenses necessarily incurred in the
- 72 discharge of their official duties in accordance with Section
- 73 25-3-41.

- 75 **SECTION 2.** This act shall take effect and be in force from
- 76 and after July 1, 2023.
