## HOUSE BILL NO. 39

- AN ACT TO AMEND SECTION 5-8-13, MISSISSIPPI CODE OF 1972, TO PROHIBIT A MEMBER OF THE LEGISLATURE FROM ENGAGING IN ANY ACTIVITY OR PERFORMING ANY FUNCTION THAT REQUIRES REGISTRATION AS A
- 4 LOBBYIST FOR A PERIOD OF ONE YEAR FROM AND AFTER THE EXPIRATION OF 5 HIS OR HER TERM OF OFFICE; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 5-8-13, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 5-8-13. (1) A lobbyist shall not contract to receive or
- 10 accept compensation dependent upon the success or failure of a
- 11 legislative or executive action.
- 12 (2) A lobbyist or lobbyist's client shall not knowingly or
- 13 willfully make or cause to be made a false statement or
- 14 misrepresentation of facts to an executive, legislative or public
- 15 official or public employee, or to the public in general with the
- 16 intent to affect the outcome of a legislative or executive action.
- 17 (3) A lobbyist or lobbyist's client shall not cause a
- 18 legislative or executive action for the purpose of obtaining

- 20 legislative or executive action.
- 21 (4) An executive, legislative or public official or public
- 22 employee shall not be a lobbyist, except that he may act as a
- 23 lobbyist when acting in his official capacity. No member of the
- 24 Legislature shall engage in any activity or perform any function
- 25 that requires registration as a lobbyist under the provisions of
- 26 this chapter for a period of one (1) year from and after
- 27 expiration of his or her term of office.
- 28 (5) A lobbyist must disclose anything of value given in
- 29 whole or in part to any executive, legislative or public official
- 30 or public employee.
- 31 **SECTION 2.** This act shall take effect and be in force from
- 32 and after July 1, 2023.
