HOUSE BILL NO. 49

AN ACT TO AMEND SECTION 49-7-153, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE DEPARTMENT OF WILDLIFE, FISHERIES AND PARKS TO ISSUE A NATIVE SON OR DAUGHTER RESIDENT LIFETIME SPORTSMAN HUNTING AND FISHING LICENSE IF OFFICIAL DOCUMENTS REFLECT THAT ONE OF THE 5 APPLICANT'S PARENTS WAS BORN IN THE STATE OF MISSISSIPPI AND WAS ON ACTIVE MILITARY SERVICE AT THE TIME OF THE APPLICANT'S BIRTH; 7 TO REQUIRE AN APPLICANT FOR SUCH LICENSE TO PROVIDE A CERTIFIED 8 COPY OF AN ORIGINAL BIRTH CERTIFICATE OF SUCH PARENT SHOWING THAT 9 THE PARENT WAS BORN IN MISSISSIPPI AND PROVIDE OFFICIAL DOCUMENTS 10 INDICATING THAT SUCH PARENT WAS ON ACTIVE MILITARY SERVICE AT THE TIME OF THE APPLICANT'S BIRTH; TO PROVIDE THAT AN APPLICANT FOR 11 12 SUCH LICENSE SHALL NOT BE REQUIRED TO HAVE BEEN DOMICILED IN THIS 13 STATE FOR EIGHTEEN CONSECUTIVE MONTHS IMMEDIATELY PRECEDING THE 14 DATE OF HIS OR HER APPLICATION FOR A LICENSE; AND FOR RELATED 1.5 PURPOSES.

- 16 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 17 **SECTION 1.** Section 49-7-153, Mississippi Code of 1972, is
- 18 amended as follows:
- 19 49-7-153. (1) Any resident may purchase a lifetime
- 20 sportsman hunting and fishing license by filing an application in
- 21 the office of the department. The license shall qualify the
- 22 licensee to take all fish, game and fowl, except waterfowl,
- 23 including deer and turkey, in the manner provided by law. The
- 24 license shall also permit the licensee to hunt with primitive

- 25 weapons and bow and arrow, and to fish in the public waters of the
- 26 state, including the taking of crabs, oysters, shrimp and any
- 27 saltwater fish authorized to be taken under a recreational
- 28 license.
- 29 (2) The department may issue a resident lifetime sportsman
- 30 license at a fee to be determined by the commission at an amount
- 31 not less than One Thousand Dollars (\$1,000.00) for a person
- 32 thirteen (13) years of age or older and not less than Five Hundred
- 33 Dollars (\$500.00) for a person under thirteen (13) years of age.
- 34 All lifetime licenses shall be issued from the office of the
- 35 department. Each application for a lifetime license must be
- 36 accompanied by a certified copy of the birth certificate of the
- 37 individual to be named as the license holder, if the individual is
- 38 twelve (12) years of age or under.
- 39 (3) The commission shall establish proof of residency
- 40 requirements for the purchase of a lifetime license, and shall
- 41 also establish such restrictions on and regulations for lifetime
- 42 licenses as it deems necessary and proper. Except as otherwise
- 43 provided in this section, an applicant for a resident lifetime
- 44 license must have been domiciled in this state for eighteen (18)
- 45 consecutive months immediately preceding the date of his
- 46 application for a license. The burden of proving domicile shall
- 47 be on the applicant.
- 48 (4) The department may issue a native son or daughter
- 49 resident lifetime sportsman hunting and fishing license if

- 53 Such license may be issued at a fee to be determined by the
- 54 commission at an amount not less than One Thousand Dollars

- 55 (\$1,000.00) for a person thirteen (13) years of age or older and
- not less than Five Hundred Dollars (\$500.00) for a person under 56
- 57 thirteen (13) years of age.
- 58 The applicant must provide a certified copy of an original
- 59 birth certificate of such parent showing that the parent was born
- 60 in Mississippi and provide official documents indicating that such
- 61 parent was on active military service at the time of the
- 62 applicant's birth.
- 63 An applicant for such license shall not be required to
- 64 have been domiciled in this state for eighteen (18) consecutive
- 65 months immediately preceding the date of his or her application
- 66 for a license.
- 67 (* * *5) The department may issue a native son or daughter
- 68 nonresident lifetime sportsman hunting and fishing license.
- commission shall establish the fee, but the fee shall not be less 69
- 70 than One Thousand Five Hundred Dollars (\$1,500.00). The applicant
- 71 must provide a certified copy of the original birth certificate
- 72 showing that the applicant was born in Mississippi and/or if the
- 73 parents' address was in Mississippi at the time of birth as shown
- on the birth certificate or other documents and/or official 74

- 75 documents reflect that one of said parents was on active military
- 76 service outside the State of Mississippi at the time of said
- 77 birth.
- 78 * * * Except as otherwise provided in this section, if the
- 79 birth certificate of each parent reflects that each parent was
- 80 born in the State of Mississippi, then any child born outside the
- 81 State of Mississippi of those parents may be issued a nonresident
- 82 lifetime sportsman license for the above set out fee.
- 83 (* * *6) Any materially false statement contained in an
- 84 application for a lifetime license renders void the license issued
- 85 pursuant to that application, and subjects the applicant to
- 86 criminal prosecution under Section 49-7-45.
- 87 (* * *7) Nothing in this section exempts an applicant for a
- 88 lifetime license from meeting other qualifications or requirements
- 89 otherwise established by law for the privilege of hunting or
- 90 fishing.
- 91 **SECTION 2.** This act shall take effect and be in force from
- 92 and after July 1, 2023.
