HOUSE BILL NO. 52

1 AN ACT TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE
2 LICENSE TAGS TO SUPPORTERS OF NORTHEAST JONES HIGH SCHOOL; TO
3 PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF SUCH LICENSE TAGS;
4 TO PROVIDE FOR THE DISTRIBUTION OF THE ADDITIONAL FEE COLLECTED
5 FROM THE ISSUANCE OF SUCH LICENSE TAGS; AND FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** (1) Any owner of a motor vehicle who is a
8 resident of this state, upon payment of the road and bridge
9 privilege taxes, ad valorem taxes and registration fees as
10 prescribed by law for private carriers of passengers, pickup
11 trucks and other noncommercial motor vehicles, and upon payment of
12 an additional fee in the amount provided in subsection (3) of this
13 section, shall be issued a distinctive license tag for any motor
14 vehicle registered in his name identifying such person as a
15 supporter of Northeast Jones High School. The distinctive license
16 tags so issued shall be of such color and design as the Department
17 of Revenue, with the advice of the Principal of Northeast Jones
18 High School, may prescribe and shall consist of such letters or



19 numbers, or both, as may be necessary to distinguish each license
20 tag.

21 (2) Application for the distinctive license tags authorized
22 by this section shall be made to the county tax collector on forms
23 prescribed by the Department of Revenue. The application and the
24 additional fee imposed under subsection (3) of this section, less
25 Two Dollars (\$2.00) thereof to be retained by the tax collector,
26 shall be remitted to the Department of Revenue on a monthly basis
27 as prescribed by the department. The portion of the additional
28 fee retained by the tax collector shall be deposited into the
29 county general fund.

30 (3) Beginning with any registration year commencing on or
31 after July 1, 2023, any person applying for a distinctive license
32 tag under this section shall pay an additional fee in the amount
33 of Thirty Dollars (\$30.00) for each distinctive license tag
34 applied for under this section, which shall be in addition to all
35 other taxes and fees. The additional fee paid shall be for a
36 period of time to run concurrently with the vehicle's established
37 license tag year. The additional fee is due and payable at the
38 time the original application is made for a distinctive license
39 tag under this section and thereafter annually at the time of
40 renewal registration as long as the owner retains the distinctive
41 license tag. If the owner does not wish to retain the distinctive
42 license tag, he must surrender it to the local county tax
43 collector.



44 (4) The Department of Revenue shall deposit all fees into
45 the State Treasury on the day collected. At the end of each
46 month, the Department of Revenue shall certify to the State
47 Treasurer the total fees collected under this section from the
48 issuance of the distinctive license tags issued under this
49 section. The State Treasurer shall distribute such collections as
50 follows:

51 (a) Twenty-four Dollars (\$24.00) of each additional fee
52 collected on distinctive license tags issued pursuant to this
53 section shall be distributed to Northeast Jones High School for
54 use to purchase classroom supplies for teachers and to support of
55 the high school band program.

56 (b) One Dollar (\$1.00) of each additional fee collected
57 on distinctive license tags issued pursuant to this section shall
58 be deposited into the Mississippi Burn Care Fund created pursuant
59 to Section 7-9-70.

60 (c) Two Dollars (\$2.00) of each additional fee
61 collected on distinctive license tags issued pursuant to this
62 section shall be deposited to the credit of the State Highway Fund
63 to be expended solely for the repair, maintenance, construction or
64 reconstruction of highways.

65 (d) One Dollar (\$1.00) of each additional fee collected
66 on distinctive license tags issued pursuant to this section shall
67 be deposited to the credit of the special fund created in Section
68 27-19-44.2.



69 (5) A regular license tag must be properly displayed as
70 required by law until replaced by a distinctive license tag under
71 this section. The regular license tag must be surrendered to the
72 tax collector upon issuance of the distinctive license tag under
73 this section. The tax collector shall issue up to two (2) license
74 decals for each distinctive license tag issued under this section,
75 which will expire the same month and year as the regular license
76 tag.

77 (6) In the case of loss or theft of a distinctive license
78 tag issued under this section, the owner may make application and
79 affidavit for a replacement distinctive license tag as provided by
80 Section 27-19-37. The fee for a replacement distinctive license
81 tag shall be Ten Dollars (\$10.00). The tax collector receiving
82 such application and affidavit shall be entitled to retain and
83 deposit into the county general fund five percent (5%) of the fee
84 for such replacement license tag and the remainder shall be
85 distributed in the same manner as funds from the sale of regular
86 distinctive license tags issued under this section.

87 **SECTION 2.** This act shall take effect and be in force from
88 and after July 1, 2023.
