## HOUSE BILL NO. 288

AN ACT TO AMEND SECTION 77-2-9, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT CERTAIN PERSONNEL AND MEMBERS OF THE PUBLIC UTILITIES STAFF SHALL BE FILLED BY CONSULTING CONTRACT IN ADDITION TO BEING COMPETITIVELY APPOINTED BY THE EXECUTIVE DIRECTOR; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 **SECTION 1.** Section 77-2-9, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 77-2-9. (1) The executive director shall have general
- 10 charge of the operations and administration of the Public
- 11 Utilities Staff. It shall be the duty and responsibility of the
- 12 executive director to supervise and manage the offices and
- 13 personnel on the Public Utilities Staff and formulate written
- 14 policies and procedures for the effective and efficient operation
- 15 thereof. The executive director shall be responsible for hiring
- 16 persons on the staff who meet established qualifications for
- 17 comparable positions of duty and responsibility. The Public
- 18 Utilities Staff as formerly created in Section 77-3-8, Mississippi
- 19 Code of 1972, which consists of the Economic and Planning

- 20 Division, Legal Division, Engineering Division, Accounting
- 21 Division and Administrative Services Division, and has a State
- 22 Personnel Board organizational code of twenty thousand (20,000) or
- 23 larger, is abolished from and after August 31, 1990. All such
- 24 former employees shall be eligible to be rehired by the executive
- 25 director for positions on the Public Utilities Staff created
- 26 pursuant to Section 77-2-1. Such former employees shall not, by
- 27 virtue of abolishing such staff, lose any vacation or sick leave
- 28 benefits previously accrued and, if rehired, shall continue
- 29 vacation and sick leave as if they had not been terminated. For a
- 30 period of one (1) year after July 1, 1990, the personnel actions
- 31 of the Public Utilities Staff shall be exempt from State Personnel
- 32 Board procedures in order to give the Public Utilities Staff
- 33 flexibility in making an orderly, effective and timely transition
- 34 to the mandated reorganization.
- 35 (2) The following personnel and members of the Public
- 36 Utilities Staff shall be filled by consulting contract or
- 37 competitively appointed by the executive director and shall have
- 38 at least the knowledge, skills and abilities set forth herein.
- 39 These requirements shall not be waived, and possession thereof
- 40 shall be certified by the State Personnel Board:
- 41 (a) A chief engineer who is a graduate licensed
- 42 engineer and who has a thorough knowledge of engineering
- 43 principles as applied to the design, construction, operation,
- 44 maintenance and expansion of utility facilities and rate structure

- 45 determination. The chief engineer shall possess a thorough
- 46 knowledge of techniques and practices of public utility service
- 47 and regulation and shall have the ability to evaluate same and to
- 48 formulate accurate conclusions therefrom.
- 49 (b) A certified public accountant who possesses a
- 50 thorough knowledge of standard accounting procedures, techniques
- 51 and systems with specific reference to the utility industry. Such
- 52 accountant shall be experienced in public utility accounting and
- 53 shall have a thorough knowledge of the financial and
- 54 organizational structure of public utility companies to include
- 55 knowledge of the methods by which financing of major additions and
- 56 extensions to utility operations is acquired.
- 57 (c) A director of economics and planning who holds at
- 58 least a bachelor's degree in economics and possesses a thorough
- 59 knowledge of the principles and techniques of economic and
- 60 financial research and statistical analysis. The director of
- 61 economics and planning shall have a thorough knowledge of the
- 62 sources of economic, financial and statistical information and the
- 63 methods of utilizing these sources, as well as considerable
- 64 knowledge of capital markets with specific reference to utility
- 65 financing. This employee shall be experienced in conducting
- 66 analyses of the utility industry, the economy, cost of money,
- 67 availability and cost of fuel and energy and other related matters
- 68 within the authority of the commission.

- (e) A general counsel, who shall be a member of The
  Mississippi Bar, shall have practiced law for a minimum of five
  (5) years and who shall possess considerable knowledge of utility
  regulation generally and of the case law, statutory law and the
  common law relating thereto.
- 77 (3) It shall be the duty and responsibility of the Public 78 Utilities Staff by and through the executive director to:
- appropriate written recommendations to the commission with respect to the reasonableness of rates charged or proposed to be charged by any public utility and with respect to the consistency of such rates with the public policy of assuring an energy supply adequate to protect the public health and safety and to promote the general welfare;
- 86 (b) Review, investigate and make appropriate written 87 recommendations to the commission with respect to the service 88 furnished or proposed to be furnished by any utility;
- (c) When deemed necessary by the executive director, in the broad public interest of the State of Mississippi, the using and consuming public, and the public utilities, make written recommendations and reports to the commission regarding all

- ommission proceedings affecting the rates or service of any public utility;
- 95 (d) When deemed necessary by the executive director, in 96 the broad public interest of the State of Mississippi, the using 97 and consuming public, and the public utilities, petition the 98 commission to initiate proceedings to review, investigate and take 99 appropriate action with respect to the rates or service of public 100 utilities. Receipt of such petition shall be spread on the
- 101 minutes of the Public Service Commission. The commission shall,
- 102 within thirty (30) days of receipt of such petition, spread upon
- 103 its minutes and forward to the Executive Director of the Public
- 104 Utilities Staff a response detailing actions taken or proposed to
- 105 be taken;
- 106 (e) When deemed necessary by the executive director, in
- 107 the broad public interest of the State of Mississippi, the using
- 108 and consuming public, and the public utilities, make written
- 109 recommendations and reports to the commission regarding all
- 110 certificate applications filed and provide assistance to the
- 111 commission in making the analysis and plans required;
- 112 (f) When deemed necessary by the executive director, in
- 113 the broad public interest of the State of Mississippi, the using
- 114 and consuming public, and the public utilities, make written
- 115 recommendations and reports to the commission regarding all
- 116 proceedings wherein any public utility proposes to reduce or
- 117 abandon service to the public;

121	authority with respect to the enforcement of natural gas pipeline
122	safety law, or the federal railroad safety laws, rules or

- (i) When deemed necessary by the executive director, in the broad public interest of the State of Mississippi, the using and consuming public and the public utilities, review and investigate contracts of public utilities with affiliates or subsidiaries;
- (j) When deemed necessary by the executive director, in the broad public interest of the State of Mississippi, the using and consuming public, and the public utilities, advise the commission with respect to regulations and transactions;
- (k) When deemed necessary by the executive director, in the broad public interest of the State of Mississippi, the using and consuming public and the public utilities, review and make

- 160 commission, in a timely and expeditious manner, such information
- 161 and reports or conduct such investigations and provide such other
- 162 assistance as may be required in order to enforce the laws
- 163 providing for the regulation of public utilities.
- 164 (5) All written recommendations and reports provided to the
- 165 Public Service Commission from the Public Utilities Staff shall
- 166 bear the signature of the executive director, who shall maintain a

- 169 (6) In no event shall the duties and responsibilities of the
  170 Public Utilities Staff be exercised with regard to matters not
  171 within the jurisdiction and powers of the Public Service
  172 Commission.
- SECTION 2. This act shall take effect and be in force from and after July 1, 2023.
