HOUSE BILL NO. 352

- AN ACT TO AMEND SECTION 99-15-17, MISSISSIPPI CODE OF 1972,
 TO REVISE THE COMPENSATION FOR INDIGENT COUNSEL; TO BRING FORWARD
 SECTION 25-32-5, MISSISSIPPI CODE OF 1972, WHICH PROVIDES THE
 COMPENSATION FOR PUBLIC DEFENDERS, FOR PURPOSES OF AMENDMENT; TO
 BRING FORWARD SECTION 25-3-35, MISSISSIPPI CODE OF 1972, WHICH
 PROVIDES THE COMPENSATION FOR JUDGES AND DISTRICT ATTORNEYS, FOR
 PURPOSES OF AMENDMENT; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 99-15-17, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 99-15-17. The compensation for counsel for indigents
- 12 appointed as provided in Section 99-15-15, shall be approved and
- 13 allowed by the appropriate judge and in any one (1) case may
- 14 not \star \star be less than Three Thousand Dollars (\$3,000.00) for
- 15 representation in circuit court whether on appeal or originating
- 16 in said court. Provided, however, if said case is not appealed to
- 17 or does not originate in a court of record, the maximum
- 18 compensation shall not exceed * * * One Thousand Five Hundred
- 19 Dollars (\$1,500.00) for any one (1) case, the amount of such
- 20 compensation to be approved by a judge of the chancery court,

- 21 county court or circuit court in the county where the case arises.
- 22 Provided, however, in a capital case two (2) attorneys may be
- 23 appointed, and the compensation may * * * not be less than Four
- 24 Thousand Dollars (\$4,000.00) per case. If the case is appealed to
- 25 the state supreme court by counsel appointed by the judge, the
- 26 allowable fee for services on appeal shall not * * * be less than
- 27 Three Thousand Dollars (\$3,000.00) per case. In addition, the
- 28 judge shall allow reimbursement of actual expenses. The attorney
- 29 or attorneys so appointed shall itemize the time spent in
- 30 defending said indigents together with an itemized statement of
- 31 expenses of such defense, and shall present same to the
- 32 appropriate judge. The fees and expenses as allowed by the
- 33 appropriate judge shall be paid by the county treasurer out of the
- 34 general fund of the county in which the prosecution was commenced.
- 35 **SECTION 2.** Section 25-32-5, Mississippi Code of 1972, is
- 36 brought forward as follows:
- 37 25-32-5. Compensation for the public defender shall be fixed
- 38 by the board of supervisors or boards of supervisors, if two (2)
- 39 or more counties are acting jointly; provided, however, the
- 40 compensation for a public defender, who shall be full-time,
- 41 representing an entire circuit court district shall not be less
- 42 than the compensation of the district attorney, the compensation
- 43 for a public defender representing one (1) county shall not be
- 44 less than the compensation of the county prosecuting attorney and
- 45 the compensation for a public defender representing two (2) or

46	more counties, but less than the entire circuit court district,
47	shall not be less than the aggregate of the compensation for
48	county prosecuting attorneys of the counties served, but in no
49	event to exceed the compensation of the district attorney. No
50	full-time public defender or full-time assistant public defenders
51	shall engage nor be associated with any person in the private
52	practice of law. Part-time public defenders or part-time assistant
53	public defenders may engage in the private practice of the law as
54	long as such practice does not relate to the prosecution of
55	criminal matters.
56	SECTION 3. Section 25-3-35, Mississippi Code of 1972, is
57	brought forward as follows:
58	25-3-35. (1) The annual salaries of the following judges
59	are fixed as follows:

62	Presiding Justices of the Supreme Court, each 169,500.00

66	Presiding Justices of the Supreme Court, each 176,737.00
67	Associate Justices of the Supreme Court, each 173,800.00
68	There are imposed upon the Supreme Court justices the extra
69	duties of taking all necessary action to promote judicial
70	education in schools, intervention courts, electronic filing and

- 71 case management systems as developed by the Administrative Office
- 72 of Courts, or such other additional duties as may be assigned by
- 73 the Chief Justice of the Supreme Court. For such extra services
- 74 each justice, from and after January 1, 2023, shall receive a sum
- 75 sufficient to aggregate, per annum, the salaries set forth in this
- 76 subsection (1).
- 77 The fixed salaries in this subsection (1) shall be paid from
- 78 the State General Fund and from the Judicial System Operation Fund
- 79 created under Section 9-21-45. No less than: One Hundred Fifteen
- 80 Thousand Three Hundred Ninety Dollars (\$115,390.00) of the Chief
- 81 Justice's salary in this subsection (1), One Hundred Thirteen
- 82 Thousand One Hundred Ninety Dollars (\$113,190.00) of the salary of
- 83 a presiding justice in this subsection (1), and One Hundred Twelve
- 84 Thousand Five Hundred Thirty Dollars (\$112,530.00) of the salary
- 85 of an associate justice in this subsection (1) shall be paid from
- 86 general fund monies; in addition, the Legislature shall
- 87 appropriate annually from the Judicial System Operation Fund a sum
- 88 sufficient to increase the salary of the Chief Justice, a
- 89 presiding justice and an associate justice to the levels set forth
- 90 in this subsection (1).
- 91 The fixed salaries as specified in this subsection (1) shall
- 92 be the exclusive and total compensation which can be reported to
- 93 the Public Employees' Retirement System for retirement purposes;
- 94 however, any judge in office on December 31, 2003, may continue to

95	report his expense allowance as part of his compensation for
96	retirement purposes.
97	(2) The annual salaries of the judges of the Court of
98	Appeals of Mississippi are fixed as follows:
99	Through December 31, 2022:
100	Chief Judge of the Court of Appeals\$161,500.00
101	Associate Judges of the Court of Appeals, each 158,500.00
102	From and after January 1, 2023:
103	Chief Judge of the Court of Appeals\$169,349.00
104	Associate Judges of the Court of Appeals, each 168,467.00
105	From and after January 1, 2023, each judge shall receive a
106	sum sufficient to aggregate, per annum, the salaries set forth in
107	this subsection (2).
108	The fixed salaries in this subsection (2) shall be paid from
109	the State General Fund and from the Judicial System Operation Fund
110	created under Section 9-21-45. No less than One Hundred Eight
111	Thousand One Hundred Thirty Dollars (\$108,130.00) of the Chief
112	Judge's salary in this subsection (2) shall be paid from general
113	fund monies; in addition, the Legislature shall appropriate
114	annually from the Judicial System Operation Fund a sum sufficient
115	to increase the Chief Judge's salary to the level set forth in
116	this subsection (2). No less than One Hundred Five Thousand Fifty
117	Dollars (\$105,050.00) of the salary of an associate judge in this
118	subsection (2) shall be paid from general fund monies; in
119	addition, the Legislature shall appropriate annually from the

120	Judicial System Operation Fund a sum sufficient to increase the
121	salary of an associate judge to the level set forth in this
122	subsection (2).
123	The fixed salaries as specified in this subsection (2) shall
124	be the exclusive and total compensation which can be reported to
125	the Public Employees' Retirement System for retirement purposes;
126	however, any judge in office on December 31, 2003, may continue to
127	report his expense allowance as part of his compensation for
128	retirement purposes.
129	(3) The annual salaries of the chancery and circuit court
130	judges are fixed as follows:

137	In addition to their present official duties, the circuit and
138	chancery judges shall take necessary action to promote judicial
139	education in schools, intervention courts, electronic filing and
140	case management systems as developed by the Administrative Office
141	of Courts, or such other additional duties as may be assigned by
142	the Chief Justice of the Supreme Court. For such extra services
143	each judge, from and after January 1, 2023, shall receive a sum

- The fixed salaries in this subsection (3) shall be paid from

- 149 Thousand One Hundred Seventy Dollars (\$104,170.00) of the salary
- 150 of a chancery or circuit judge in this subsection (3) shall be
- 151 paid from general fund monies; in addition, the Legislature shall
- 152 appropriate annually from the Judicial System Operation Fund a sum
- 153 sufficient to increase the salary of a chancery or circuit judge

- 166 Department of Finance and Administration.

- 175 (7) The annual salary of the full-time legal assistants
- 176 shall be not less than Fifteen Thousand Dollars (\$15,000.00) nor
- 177 more than eighty percent (80%) of the salary of the district
- 178 attorney for legal assistants who have been licensed to practice
- 179 law for five (5) years or less; eighty-five percent (85%) of the
- 180 salary of the district attorney for legal assistants who have been
- 181 licensed to practice law for at least five (5) years but less than
- 182 fifteen (15) years; and ninety percent (90%) of the salary of the
- 183 district attorney for legal assistants who have been licensed to
- 184 practice law for at least fifteen (15) years or more.
- 185 **SECTION 4.** This act shall take effect and be in force from
- 186 and after July 1, 2023.
