## HOUSE BILL NO. 368

- 1 AN ACT TO AMEND SECTION 45-35-17, MISSISSIPPI CODE OF 1972, 2 TO CLARIFY THE AUTHORITY OF THE COMMISSIONER OF PUBLIC SAFETY TO 3 CREATE RULES AND REGULATIONS TO PROVIDE AN ALTERNATIVE STATE
- IDENTIFICATION CARD TO HOMELESS PERSONS; TO AMEND SECTIONS
- 5 45-35-17, 45-35-7 AND 45-35-5, MISSISSIPPI CODE OF 1972, TO
- 6 CONFORM TO THE PRECEDING SECTION; FOR RELATED PURPOSES.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 SECTION 1. Section 45-35-17, Mississippi Code of 1972, is
- amended as follows: 9
- 10 45-35-17. (1) Subject to available appropriations, the
- Commissioner of Public Safety shall establish an alternative state 11
- 12 identification card that does not conflict with the requirements
- 13 of the federal Real ID Act of 2005, except that this card shall
- 14 not require proof of domicile for persons who do not have a
- 15 domicile to list. The Commissioner of Public Safety shall create
- rules and regulations that allow persons who are homeless to 16
- obtain an alternative state identification card. 17
- 18 (2) For purposes of this section, the term "homeless" means
- 19 lacks a fixed, regular and adequate residence, or lives

- 20 periodically in a public or private shelter or location that
- 21 provides temporary living arrangements.
- SECTION 2. Section 45-35-7, Mississippi Code of 1972, is
- 23 amended as follows:
- 24 45-35-7. (1) (a) Except as provided in paragraph (b) of
- 25 this subsection (1) or as otherwise provided by law for homeless
- 26 persons, each applicant for an original or renewal identification
- 27 card issued pursuant to this chapter who is entitled to issuance
- 28 of such a card shall be issued a four-year card or an eight-year
- 29 card, at the option of the applicant. Each card shall expire at
- 30 midnight on the cardholder's birthday and may be renewed any time
- 31 within six (6) months before the expiration date of the card upon
- 32 application and payment of the required fee.
- 33 (b) Any applicant who is blind, as defined in Section
- 34 43-6-1, upon payment of the fee prescribed in Section 63-1-43,
- 35 shall be issued an original or renewal identification card which
- 36 shall remain valid for a period of eight (8) years, shall expire
- 37 at midnight on the cardholder's birthday, and may be renewed any
- 38 time within six (6) months before the expiration date of the card
- 39 upon application and payment of the required fee.
- 40 (2) (a) Any applicant who is not a United States citizen,
- 41 upon payment of the fee prescribed in Section 63-1-43, shall be
- 42 issued an original or renewal identification card which shall
- 43 expire four (4) years from date of issuance or on the expiration
- 44 date of the applicant's authorized stay in the United States,

- 45 whichever is the lesser period of time, and may be renewed, if the
- 46 person is otherwise qualified to renew the license, within thirty
- 47 (30) days of expiration.
- 48 (b) An applicant for an original or renewal
- 49 identification card under paragraph (a), except a person who is
- 50 homeless as defined in Section 45-35-17, must present valid
- 51 documentary evidence documenting that the applicant:
- 52 (i) Is a citizen or national of the United States;
- (ii) Is an alien lawfully admitted for permanent
- or temporary residence in the United States;
- 55 (iii) Has conditional permanent residence status
- 56 in the United States;
- 57 (iv) Has an approved application for asylum in the
- 58 United States or has entered into the United States in refugee
- 59 status;
- (v) Has a valid, unexpired nonimmigrant visa or
- 61 nonimmigrant visa status for entry into or lawful presence in the
- 62 United States;
- (vi) Has a pending application for asylum in the
- 64 United States;
- (vii) Has a pending or approved application for
- 66 temporary protected status in the United States;
- 67 (viii) Has approved deferred-action status;
- 68 (ix) Has pending an application for adjustment of
- 69 status to that of an alien lawfully admitted for permanent

- 70 residence in the United States or conditional permanent resident
- 71 status in the United States; or
- 72 (x) Has a valid employment authorization card
- 73 issued by the United States Department of Homeland Security.
- 74 (3) The fee for the issuance of an original or renewal
- 75 identification card shall be as prescribed in Section 63-1-43.
- 76 (4) Any person who, for medical reasons, surrenders his
- 77 unexpired driver's license, and any person whose unexpired
- 78 driver's license is suspended for medical reasons by the
- 79 Commissioner of Public Safety under Section 63-1-53(2)(e), upon
- 80 request shall be issued an identification card without payment of
- 81 a fee. The identification card shall be valid for a period of
- 82 four (4) years from its date of issue. Subsequent renewals shall
- 83 be subject to the fees prescribed in Section 63-1-43.
- 84 (5) The department shall maintain a record of all
- 85 identification cards issued.
- 86 (6) (a) Any male who is at least eighteen (18) years of age
- 87 but less than twenty-six (26) years of age and who applies for an
- 88 identification card or a renewal of an identification card under
- 89 this chapter shall be registered in compliance with the
- 90 requirements of Section 3 of the Military Selective Service Act,
- 91 50 USCS Appx 451 et seq., as amended.
- 92 (b) The department shall forward in an electronic
- 93 format the necessary personal information of the applicant to the
- 94 Selective Service System. The applicant's submission of the

- 95 application shall serve as an indication that the applicant either
- 96 has already registered with the Selective Service System or that
- 97 he is authorizing the department to forward to the Selective
- 98 Service System the necessary information for registration. The
- 99 commissioner shall notify the applicant on, or as a part of, the
- 100 application that his submission of the application will serve as
- 101 his consent to registration with the Selective Service System, if
- 102 so required. The commissioner also shall notify any male
- 103 applicant under the age of eighteen (18) that he will be
- 104 registered upon turning age eighteen (18) as required by federal
- 105 law.
- SECTION 3. Section 45-35-5, Mississippi Code of 1972, is
- 107 amended as follows:
- 108 45-35-5. Except as otherwise regulated by the authority of
- 109 Section 45-35-17 for homeless persons, data for the issuance of an
- 110 identification card shall include a birth certificate or other
- 111 document to establish the age and identity of the applicant, the
- 112 social security number of the applicant, and such other
- 113 identifying data as is required on an application for issuance of
- 114 a driver's license.
- 115 **SECTION 4.** This act shall take effect and be in force from
- 116 and after July 1, 2023.
