## HOUSE BILL NO. 536

AN ACT TO AMEND SECTION 1 AND SECTION 2, CHAPTER 493, LAWS OF 2016, TO AUTHORIZE THE BOARD OF TRUSTEES OF STATE INSTITUTIONS OF HIGHER LEARNING, ACTING ON BEHALF OF MISSISSIPPI STATE UNIVERSITY OF AGRICULTURE AND APPLIED SCIENCES, TO EXTEND THE ORIGINAL LEASE 5 TERMS FOR THE DEVELOPMENT OF HOUSING AND RETAIL SPACE FOR THE BENEFIT OF THE UNIVERSITY, BY GRANTING A SECOND OPTION TO RENEW 7 FOR AN ADDITIONAL TEN YEARS AND ONE ADDITIONAL OPTION FOR A RENEWAL PERIOD NOT TO EXCEED FIVE YEARS, INCREASING THE ORIGINAL 8 LEASE TERMS FROM A TOTAL OF 50 YEARS TO A NEW LEASE TERM TOTALING 9 65 YEARS; AND FOR RELATED PURPOSES. 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 12 SECTION 1. Section 1, Chapter 493, Laws of 2016, is amended 13 as follows: Section 1. (1) The Board of Trustees of State Institutions 14 15 of Higher Learning, acting on behalf of Mississippi State University of Agriculture and Applied Sciences, is authorized to 16 17 enter into a long-term lease of all or any portion of certain real property under its control and possession. The property described 18 in this section shall be leased for a period not to exceed a term 19 20 of forty (40) years \* \* \* with two (2) additional options 21 for \* \* \* renewal periods not to exceed ten (10) years and one (1)

additional option for a renewal period not to exceed five (5)

The approved lease and any amendments to the lease shall not be cancelled by successor boards based on the binding successor doctrine.
